

The inevitability of quantum medicine

Almost all processes on Earth depend on solar activity. The new quantum theory of cancer draws attention to the fact that practically any human disease cannot but take into account the influence of the information field of the Cosmos on a person. 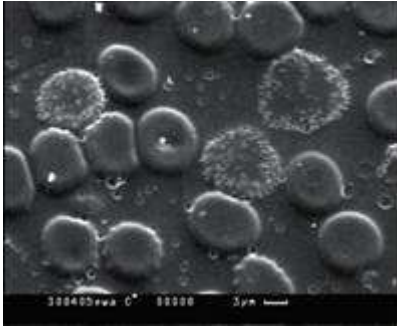
