

## Human blood plasma - matter that perceives the information field

Having completed the second book about the influence of the information field of the Cosmos on human health, we continue to consider human health in accordance with these new data.

All the accumulated knowledge about nature indicates that biological activity on Earth arose due to solar radiation. Man could not help but appreciate the role of the Sun in his daily life.

However, the sun can disrupt the functioning of the body. human directly by radio waves. We have discovered and shown the presence of microscopic antennas in human blood plasma. They are the sources of "interference" leading to the rapid development of microflora and fauna in human blood plasma. But what makes human blood plasma so sensitive to changes in the magnetic activity of the Sun?

Many people know that plasma is the liquid component of blood and is characterized as the fourth state of matter. It includes molecules, positively and negatively charged ions and a small amount of free electrons. Free electrons are in constant motion. And all this movement and the connection between them is carried out with the help of electromagnetic forces. And the blood plasma itself has a certain electromagnetic elasticity.

The differences between plasma matter and ordinary matter are especially manifested in magnetic field. On the normal matter, the magnetic field does not exert any influence. At all plasma is another matter. Each charged particle interacts with magnetic field. Therefore her movements in the presence of a magnetic field changes.

The increased magnetic activity on the Sun is a pulse of electric current. Microscopic antennas on excited molecules of hydroxyl - OH in human blood form a kind of "response", which is then received by a pulse of electric current during "cosmic induction", i.e. during strong magnetic storms, when the blood plasma begins to feel the increased disturbances of the Sun.

Studies by astrophysicists have shown that the violent emission of radio waves

comes from areas of the solar corona above large sunspots. Radio emission during flares is especially powerful: it becomes millions and even tens of millions of times stronger than usual. Thus, this radiation is closely related to the active activity of the Sun and signals about the processes in its atmosphere. Radio emission does not remain constant.

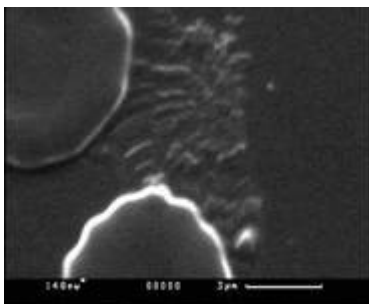
Hydroxyl molecules - OH, present in human blood plasma

The stability of the emission frequency of masers is ensured by the fact that it is created by molecules of the same type, that is, by hydroxyl molecules - OH. As scientists have established, the creators of gas masers in Space are not mysterious intelligent inhabitants of other worlds, but Nature itself. In 1966, the famous Russian scientist I.S. Shklovsky showed that unusual radiation is generated by hydroxyl molecules in an excited state. The nature of the physical processes occurring in this case was assumed to be the same as in gas masers created already under terrestrial conditions.

Human blood plasma allows us to "catch" this informational field of the Cosmos and use it as the most perfect tool for researching human health. The study of human blood plasma has shown that for the transmission of information from the Cosmos, nature has used the most perfect source of information transmission - maser electromagnetic radiation, radiation of the highest quality. The coherence and monochromatic properties of this electromagnetic radiation are used by nature to create a holographic method for recording information from matter that is constantly in motion and has the properties of a plasma.

The information field of the Cosmos determined the entire course of prebiological evolution on Earth and was reflected in the life of any of its creatures. There is also an opportunity for a person to perceive the cause of diseases in a new way and develop new approaches to treatment.

"Cosmic induction" forms a vortex zone in the matter of human blood plasma. The properties of maser radiation make it more and more organized, and an interference pattern is formed. A special type of vibration is formed - standing waves.

In human blood plasma, this interaction of waves leads to

the formation of small vortices first, which then combine according to the laws that lead to the formation of the most favorable energy structure - an interference pattern. That is, the structure survives, the individual components of which interact most effectively with each other. The disordered structure has become ordered.

Thus,

the structure of blood plasma matter, starting with small vortices and ending under the interference pattern, is organized by cosmic induction. These amazing transformations occur through the point of no return. It can be said that in a certain area of blood plasma matter such changes have occurred under the influence of cosmic induction, which no longer allow the blood plasma matter to recover to its previous state. A certain part of blood plasma matter falls out of a single quantum state and will never be restored. It will be replaced by matter with different properties, with a new quantum state. This kind of evolution of matter occurs constantly in nature, it also occurs in human blood plasma. The main one is the holographic method for studying human blood plasma, prompted by Nature itself, which makes it possible to see the mechanism of the disease.

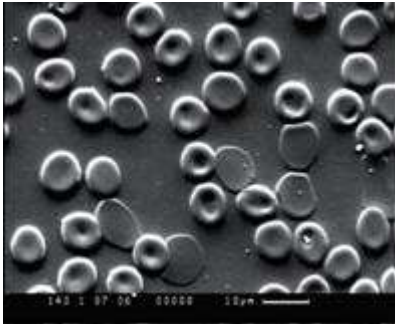
Evgenia Veniaminovna Alekseeva and Olga Ivanovna Eliseeva (Methodological Center Eliseeva OI) were the first to discover a natural holographic method for recording information in human blood plasma and applied it in their research.

In order to obtain a high-quality image of any object, it is necessary to reproduce the wave field scattered by it as accurately as possible. The more detail it is reproduced, the greater the guarantee that the image of the object will not differ in any way from the original. It is volumetric holograms that make it possible to obtain a volumetric image of an object of the highest resolution (quality).

But in holography it is not enough just to record the wave field scattered from the object; it must also be restored. It turns out that the image is not formed immediately, but in two stages. The first stage consists in the fact that the waves scattered from the object (blood plasma matter) should be "frozen" and stored in a safe place, and then called up again, that is, as if "defrosting", recreating the image of the object (matter of blood plasma), that is, one that no longer exists at a given time. "Frozen" waves in holography are a kind of negative in photography. It is the interference pattern.

So, the complex pattern of the wavefront, which contains all the information about the diseased matter of the blood plasma, must be recorded. That is, "freeze" with the help of a motionless picture of standing waves or an interference pattern formed during recording, and then, when it is necessary to see this sick matter again, "unfreeze the wave", restore the image of the diseased matter of blood plasma, that is, matter with a new quantum state ...

To restore the image of an object (blood plasma matter), a coherent radiation source is used. Indeed, we have a negative - this is a picture of standing waves that does not decay for a long time, there is a coherent source - maser radiation. This allows you to "print" as many copies of the diseased matter as you like. These copies will be included in the blood plasma matter, and be characterized as matter with a new quantum state (see Fig. 2).
