

Comparative characteristics of electroacupuncture according to R. Voll and ART
in hardware-software complexes "Medissa", "Alpha-2", "IMEDIS-
FOLL

I have been doing electropunctural diagnostics according to R. Voll since 1995. Started working at the hardware and software complex (AIC) "Medissa" (Simferopol). Four years ago she mastered and applied in her work the APK "Alpha-2" (Kiev). Two years ago I completed training at the IMEDIS Center (Moscow) and to the present time I work at the IMEDIS-VOLL agro-industrial complex (version 3.1).

Since in my work I use three hardware and software complexes from different manufacturers, I would like to share my accumulated experience and note the advantages of the listed methods and equipment.

It is important to note that APK "Medissa" and "Alpha-2" allow examining a patient only by the method of R. Voll, and the use of APK "IMEDIS-VOLL" makes it possible to use both the method of R. Voll and vegetative resonance test.

Examination of a patient begins with measuring the electrical parameters of BAP (biologically active points), and already here the advantages of one method or another are visible. When diagnosing according to R. Voll, difficulties arise in taking indicators in BAP in case of damage to the skin, in the absence of limbs, in severe degenerative processes (cancer, multiple sclerosis, the consequences of a stroke - paresis, paralysis), etc. In these cases, there are low indicators on BAP, which does not make it possible to examine the patient in detail and accurately. When using the vegetative resonance test (ART) of the APK "IMEDIS-VALL", all of the above problems disappear.

In our diagnostic and treatment center, doctors of various specialties work mainly according to the method of R. Voll at the Alfa-2 agro-industrial complex. In their practice, they are faced with the above listed problems, and in such cases, patients are sent for examination for ART.

In practice, each doctor uses his own specific algorithm for examining the patient. Using the HSC "IMEDIS-FALL" by the ART method, it is possible to determine the presence or absence of geopathogenic load (GN), electro-magnetic load (EMN), their degree. APK "Medissa" and "Alpha2" do not provide such an opportunity. The role of GBV in the occurrence of various diseases is very great. It is almost impossible to cure a patient with GBV, if not eliminate it.

The next advantage of ART is an indication of the presence or absence of radioactive load (RN), its degree, and in the presence of RN we can determine which radionuclides are in the body, and which organ or system they generate. When examining by the method of R. Voll on APK "Medissa" and "Alpha-2", there is no such indication. The APC data only allow one to determine the presence of a particular radionuclide by sequential testing, which takes more time.

One of the stages of ART is the determination of biological indices (BI), photon indices (PI), adaptation reserves (RA), which make it possible to judge about

integrative indicators of the body's vital functions. ART also makes it possible to determine the optimal step of therapy, which is determined in order not to disrupt the reserves of adaptation, not to cause an exacerbation. Folly diagnostics does not provide a definition of these indices.

The ART program includes indications of the presence of a viral, bacterial, mycotic burden, and in case of a positive result, we, in this case, look for it, which reduces the doctor's work time. In addition, using electrostructural therapy, it is possible to select the frequencies of this burden, and using devices for magnetic therapy "loop" or "inductor" determine the site of the lesion of this organ and conduct treatment. When diagnosing according to R. Voll, it is necessary to sort out all the etiological MRC (micro-resonance complex) of viruses, bacteria, fungi included in the hardware complex. Using VRT, as well as electrostructural diagnostics with frequencies, we can more accurately determine the presence of one or another burden, since there are potentiated frequencies in the IMEDIS-VOLL AIC.

Practical example

At the reception there was a patient with a history of chlamydia. When examined according to R. Voll on APK "Alpha-2", the test for chlamydia was negative. When performing ART, chlamydia was determined in the D60 potency, which indicated the transferred chlamydia.

In APK "IMEDIS-FALL" there is an index of the definition of the affected organ, with which you can determine:

- primary affected organ;
- the most affected organ;
- chronic inflammatory process;
- acute inflammatory process.

When diagnosing according to R. Voll, it is determined:

- inflammatory process;
- degenerative process;
- a neoplastic process, however, it is primarily affected and the most the affected organ cannot be determined with the same indicators.

When a disease occurs, certain conditions appear in the body that contribute to the disease. One of the conditions is a violation of the acid-base balance, the presence of an anabolic or catabolic process, lymphatic burden, lack of minerals and trace elements, vitamins, enzymes, hormones. APK "IMEDIS-FALL" allows you to determine these violations. In APK "Medissa" and "Alpha-2" there are no indications of these problems.

The state of the immune system is of great importance in the onset and development of the disease. With ART, working at the APK "IMEDIS-VOLL", it is possible to determine:

- the degree of depletion of the immune system;
- the presence of a chronic degenerative process;
- early stage and obvious malignant process;
- the formation of macro-micro tumors.

R. Voll's method does not determine the degree of damage to the immune system.

I would especially like to note the advantages of AIC "IMEDIS-VOLL" in the diagnosis of oncological diseases. Cancer diseases have a multifactorial genesis, therefore, for successful therapy, it is crucial to identify as many potential causes as possible and eliminate them. I will give only a few parameters that can be used in ART in the diagnosis of malignant tumors. This is:

- the presence of more than three BI;
- high PI values;
- presence of GBV;
- testing of onconazole;
- determination of the polarity of Yin-Yang (more often Yin);
- violation of acid-base balance (often acidic environment).

During the examination according to R. Voll, the diagnosis of oncological diseases is mainly carried out on the basis of removed low rates (degenerative changes) in certain BAPs of onco-, affected meridians, as well as testing of nosodes. Besides, onconosode in APK "IMEDIS-FALL" are potentiated, which makes it possible to judge the severity of the disease.

APK "IMEDIS-FALL" allows you to carry out segmental diagnostics that can be used for mass screening of the population (for example, during medical examinations), since it takes a minimum of time. Agroindustrial complex "Medissa" and "Alpha-2" do not have this opportunity.

AIC allows not only examining a patient, but also treating, and there are also certain advantages of AIC "IMEDIS-VOLL". This is:

- potentiated homeopathic remedies;
- a large group of devices from different companies (Heel, OHOM, Imedis, Rayex, etc.);
- the possibility of carrying out endogenous BRT and exogenous EPT, an induction treatment program for brain rhythms.

There are more homeopathic medicines in the program of APK "Medissa" than in APK "Alpha-2", and in the latest versions of APK "Medissa" it is possible to carry out BRT by acting on certain BAPs. In AIC "Alpha-2" there is no such possibility.

In APK "Medissa" and "IMEDIS-FALL" the selector is periodically updated and the program is expanded, which is not in the APK "Alpha-2".

The use of the repertory AIC "IMEDIS-VOLL" also reduces the doctor's work time, which is not in the APK "Medissa" and "Alpha-2".

During the examination by ART, the patient receives more information about the general state of his health (GN, EMN, RN, BI, FI, the state of the immune system, etc.). Diagnostics according to R. Voll gives a more complete picture of the state of an organ or system, for example, by BAP from the stomach meridian, we can judge the function of the stomach (determine acidity, secretion of gastric juice).

I made a brief analysis of the comparative characteristics electroacupuncture diagnostics according to R. Voll and ART of APK "Medissa", "Alpha2" and "IMEDIS-VOLL", and as a doctor who has been engaged in folli diagnostics for 9 years, now I give the advantages of diagnostics and treatment at APK "IMEDIS-VALL" ...

Summary

1. Based on the above, we can conclude that in the agro-industrial complex "IMEDIS-VOLL" can be used both the R. Voll method and ART.
 2. Using APK "IMEDIS-FALL", there are practically no problems when working with patients who have low electrical parameters on the BAP, or one of the limbs is missing.
 3. When working on ART, you can get more extensive information about general health.
 4. Less time is spent on the examination algorithm for ART.
 5. ART makes it possible to determine the degree and depth of pathological process in the body.
 6. APK "IMEDIS-FALL" has a more extensive treatment program.
