

## Psychosomatic diseases and the capabilities of the "IMEDIS" system

By and large, all diseases are psychosomatic. The only question is the degree of influence of the psyche. The psyche (soul and spirit) and the soma are inextricably linked. In the morphogenetic field of a person (namely, with him we are dealing with treatment with bioresonance methods), mental and somatic states are complexly intertwined. It is impossible to try to cure a sick organism, limiting ourselves only to correcting somatic disorders. Even such purely somatic problems as fractures and dislocations are healed faster and more correctly if the patient has the appropriate attitude.

The question of the hierarchy of these relationships is also nontrivial. It is known that in the treatment of depressive and manic conditions, certain physical activities should be used that stimulate the endocrine system; on the other hand, it is impossible to cure rheumatoid arthritis without identifying and eliminating the mental blockages that led to the disease.

We are increasingly treated by critically ill patients for whom treatment by methods of official medicine has ended with an unsatisfactory result or even impossible. The experience of working with such patients led us to the idea of the need, first of all, to understand the mental stress that led to the disease. At the same time, we quickly realized how multidimensional and complex this task is. First of all, we started to use the capabilities of APK "IMEDIS":

1. The use of high potency homeopathy (especially to eliminate mental negative influences of the immediate environment of the patient).
2. Induction programs that solve a number of problems, such as mental and somatic nature.
3. Roy Martin's preparations - Biooscillators and Flowerplex.
4. Sprout essences and Bach Flowers.
5. LM potencies and Rubimed preparations.
6. Chronosemantic therapy using mantic BAP.
7. Color and light, visualization.
8. The use of prehypnotic states in the mode of alpha, theta and delta rhythms through bioresonance induction programs.
9. Consolidation of new behavioral algorithms with new induction programs.

The only method that we use in addition to the capabilities of IMEDIS for removing deep mental blockages is the EMDR (Eye Movement Desensitization and Reprocessing) method, but here we also use the capabilities of IMEDIS and conduct this therapy against the background of induction programs in the BRT mode ...

At the same time, we began to apply complex treatment with a simultaneous effect on the mental and somatic state of the patient. Interesting results were not long in coming. We realized that a true cure is possible only in such a complex way. At the same time, there is a noticeable increase in the patient's self-awareness, leading even to a change in lifestyle. Especially

noticeable results are shown in the treatment of cancer, rheumatism, rheumatoid arthritis, Crohn's disease, multiple sclerosis and a number of chronic diseases.

Moreover, taking into account the patient's mental state leads to a general improvement in the body. This method is especially promising for the treatment of a number of childhood diseases - from allergies to autism.

The report on several specific examples is shown the use of these complex techniques, which led to the recovery of patients. The healing facts have been confirmed through clinical diagnostics.
