

The use of APK "IMEDIS-EXPERT" for homeosynmatric and  
pharmacopuncture methods of treatment

Recently, homeosiniatry and pharmacopuncture are of increasing interest - areas of practical medicine that combine the Tibetan method of reflexology with the method of drug administration.

(homeopathic and allopathic) in acupuncture points. This method of therapy for various diseases is of undoubted interest, since it allows you to obtain a quick and reliable therapeutic effect with a minimum risk of side effects due to a decrease in the dose of administered drugs.

The use of such an effective method poses two tasks for the doctor:

1. The choice of acupuncture points individually for each patient, according to specific problem.
2. The choice of optimal medicines, which will be especially effective when injected into these acupuncture points, in a particular patient.

1. To solve the first problem, you need to view the energy the patient's condition at a given time, i.e. find out which meridians are in short supply and which are in excess. A deficient meridian is a blocked meridian, i.e. as much as possible struck. A meridian in excess is a meridian with energy left on it, which lingered at certain points of the meridian during the formation of a vicious circle of energy flow, in the process of solving a problem (block) by the body. The next step in the diagnosis is to identify a point blocked along the meridian. This action is carried out using the frequency base of the program "IMEDISEXPERT", where there are frequencies of points of all classical meridians. Having selected the blocked points along the affected meridians, we have the vicious circle that the body has formed at the present moment in time to solve this momentary problem. However, in some cases, a patient comes to us with a request to help solve a specific problem of concern, in which case we select a certain marker and view the state of the meridional system relative to it. Very often, when specifying a problem, we have our own vicious circle, other points. Thus, we do not just gradually "cleanse" the body, removing layer by layer, but, as it were, pull the problem to the surface, not taking into account the work of the body itself to solve this problem, which sometimes can cause a negative reaction from the body in the form of a complication phenomenon process at the very beginning of treatment. Having found out which points are blocked, it is advisable to view them through certain markers in order to resolve the issue of the possibility of puncturing. Such markers include Cu. met, Ferrum. met, Argentum nit.

2. The selection of optimal medicines is carried out, first of all, according to the nosological principle. More developed for every problem

amount medicinal drugs how allopathic, So and homeopathic, from which you can try to choose the only drug specifically for a given patient that will quickly solve the problem when injected into the tested points of the body. That is, the given medicine should coincide in frequency characteristics with the intended punctured point. To do this, we again use the frequency base in the program, where we select a drug that is suitable in frequency to the frequency of a given point.

After finding the points and suitable medicines, it is necessary to pay attention to which meridians - centrifugal or centripetal, are the selected points, which meridians are in short supply and which are in excess. It is necessary to analyze this data in connection with the technique of puncturing dots. To enhance the flow of energy along the meridian, the point is punctured along the course of the meridian at an angle of 45 ° to 90 °, and if it is necessary to suspend the flow of energy, then the puncture is performed against the course of the meridian, also at an acute angle. The depth of the injection corresponds to the location of the acupuncture point, the puncture is performed more often with insulin needles or needles for mesotherapy, but if the injection depth is more than 2 cm, ordinary 2- or 3-gram syringes are recommended. The beginning of drug administration is determined by the appearance of "certain" sensations in the patient, as with conventional acupuncture. The administration of the medicine is completed when a feeling of pressure and pain appears at the acupuncture point. Usually, no more than 1 ml of the substance is injected at each point. The number of punctured points does not exceed 4-6 for each session.

Sessions at the beginning of treatment were carried out daily, after the onset of improvement 2-3 times a week. The course of therapy averaged 3-5 weeks. During this time, the patient received 8-12 procedures. Each session was individually selected for acupuncture points and medications, which usually takes from 10 to 15 minutes of a doctor's appointment. But we had a clear idea of the course of the process, did not have any side effects of treatment. After a course of therapy, a rapid stabilization of the patients' well-being was observed.

The use of complex selection of both acupuncture points and medicines in the treatment regimens of this method is highly advisable, since it allows a pronounced clinical effect to be obtained in a shorter time. This technique can be recommended for the relief of acute pain syndrome, as well as for the treatment of chronic pathologies.
