

The first results of chronosemantic therapy

From 24.05 to 9.05.2005, in Rostov-on-Don, an educational and methodological seminar was held by the teacher of the Center for Intelligent Medical Systems "IMEDIS" Mkhitarian K.N. ", Which brought together many doctors of the Southern Federal District, involved in BRT and ART and, to one degree or another, using astrology and chirolgy in their medical practice. Example No. 1. Patient K., 47 years old. Diagnosis: hemangioma of the right kidney. No complaints. On a routine dispensary examination with an ultrasound of the right kidney from On March 10, 2004, in the middle segment, two oval-shaped hyperechoic formations with a size of 10.0 were found 8.8 mm vs 10.6 9.7mm shade-free. On June 6, 2004, Chronosemantic therapy was started along the line of Life (Venus) with a target marker - the patient's urine, potentiated according to Mkhitarian's method. Reception of the adaptant was 2 globules per 10 days and the meridian preparation - 1 globule per day. Chronosemantic cleaning of the line was carried out once a month, work with the line, as with a point, - once a week. At control examinations on ultrasound of the right kidney from 18.08.2004, the size of hemangiomas was 8.0 7.7 mm vs 7.7 5.7 mm, respectively; dated October 25, 2004 - 4.1 2.8mm vs 3.2 2.0 mm; from 17.01.2005 - hyperechoic formations in the middle segment of the right kidney are not determined.

Example No. 2. Patient Ch., 35 years old. I went to the mammologist on 04/19/2004 due to the discovery of a slightly painful lump in the right mammary gland. History - wedge resection of the left ovary in connection with Stein-Leventhal syndrome in 1997, resection of the right ovary in connection with purulent fecal peritonitis due to perforation of the appendix in 2002. No children. Mammography of the right breast dated 04.22.2004 - in the upper lateral quadrant, a round shadow with relatively even contours of 1.9 in size is determined 1.5 cm. Surrounding fabrics are not changed. Ultrasound from 04/23/2004: in the upper lateral quadrant is defined by a rounded shape

hypoechoic formation, size 1.9 1.5 cm. Diagnosis: fibrocystic mastopathy of the right breast. June 9, 2005 was started

Chronosemantic therapy with the recording of negative engrams from the Life line and points of the "Dragon" with a target marker - the patient's blood potentiated according to Mkhitarian's method. The adaptant was taken 3 globules per week, the meridian preparation - 2 globules per day. The HST sessions were carried out once every 2 weeks, work with the lines of Life (Venus) and the Head (Mars) (this line was selected by testing it is functional), as with a point, once a week. Against the background of treatment, a clear positive dynamics was determined: with mammography from 08/30/2004, the size of the formation decreased by more than half, and amounted to 0.9 0.7 cm. Unfortunately, in September 2004, the treatment was completed due to the patient's moving to another city for permanent residence.

Example No. 3. Patient B., 48 years old. She complained of intermittent contact bleeding from the vagina. When examined by a gynecologist on 10/11/2004, a polyp with a size of 0.6 was found on the cervix in the region of the cervical canal 0.3 cm. Smears from the cervical canal and urethra are negative for bacterial flora. A session of chronosemantic therapy along the line of life was carried out with a target marker - the patient's blood potentiated according to the method of K.N. Mkhitarian, followed by taking the adaptant 1 globule per week and douching the cervix with a solution (1 globule per 0.5 liter of boiled water) daily. On repeated examination by the gynecologist, the polyp was not found.

CCT in all patients was performed on the dominant hand, the doses of drugs were determined using mental testing, for environmental tests, information was taken from the end points of the main lines. The main line for work in all patients was the line of Venus, because the genitals and kidneys are projected onto it. All patients were examined by a therapist and neuropathologist every 10 days, blood tests were taken every two months and specialized instrumental examinations were performed.

Taking into account the fact that the effect of therapeutic treatment of neoplastic diseases is minimal, and the use of CST made it possible to achieve a result, we come to the conclusion that the value of chronosemantic treatment using mantic BAPs of chiroglyphic lines is very high. Why, even in the biblical books, the importance of these lines was noted: "... The Lord puts a seal on the hand of every person so that people know His work" (Book of Job, ch. 37, verse 7), "... Longevity is in the right hand her, and in her left with riches and glory "(Proverbs of Solomon, ch. 3, verse 6); "... Here I have inscribed you on my hands; your walls are always before Me "(Isaiah, ch. 49, verse 16). So maybe these patterns - a horary horoscope on a dominant hand and a rolling one on a recessive one - are proof of HIS existence - the seventh proof of Kant, according to M.A. Bulgakov? Who knows!
