

Vegetative resonance test in the correction of established clinical diagnoses

The ART technique opens up wide opportunities for clarifying and correcting the diagnoses with which patients apply to us. Naturally, clarification of the diagnosis is followed by a correction of treatment, and the results are sometimes turn out to be amazing.

Our Center, along with diagnostics of the energy balance, attaches great importance to clarifying the infectious etiology of the disease.

Therefore, it is very important to abstract from the ready-made diagnosis with which the patient came and pay due attention to the search for certain infectious agents.

I would like to illustrate the above with a few examples.

1. Patient M., 37 years old. I contacted the Center with complaints of a skin rash, with predominant localization on the inner and outer surfaces of the shoulder and forearm. The appearance of the rash resembled psoriatic. The same diagnosis was made to the patient more than 7 years ago. Received treatment in the form of topical application of hormonal ointments. No clear improvement was observed.

When examining the patient, attention was drawn to the symmetry of the rash, as well as its location along the meridians - pericardium and endocrine.

When tested, none of the potencies of the psoriasis nosode gave a "response." However, the fungus *Trichophyton rubrum* and the nosode "Trichophytosis" in potencies D30 and D100 were clearly tested.

Upon further study of the anamnesis, it turned out that at the age of 7-8 years, the patient was treated for a long time for a certain skin fungal disease that arose from contact with a sick cat.

We carried out treatment with frequency, bioresonance and drainage drugs, aimed at deep elimination (destruction) of the fungus, detoxification of the body and increasing the level of its immunity.

During the first month of treatment, the spots began to fade noticeably, and from the second month the elements of the rash began to disappear, peeling off with scales of various diameters, under which healthy skin with areas of hyperpigmentation remained. Follow-up for 2 years - the patient is healthy.

2. Patient K., 56 years old. I contacted the Center with complaints of pain in the elbows and interphalangeal joints with their periodic swelling and deformation.

About 5 years ago, she was diagnosed with gout.

Specific treatment and diet did not bring any obvious relief. Blood tests for various rheumatic tests were consistently negative.

The diagnosis by the ART method clearly reveals streptococcal joint damage without the development of autoimmune processes.

Increases in uric acid levels have not been tested.

Treatment aimed at eliminating streptococcus and draining the joints for the first time in several days gave an exacerbation, expressed in an increase

temperature, increased pain and swelling of the joints, which forced the patient to resort to taking non-steroidal anti-inflammatory drugs. By the end of the first week, the state of health returned to normal and stabilized, and the initial symptoms began to noticeably regress.

Observation for 3 months and repeated examination with correction of treatment revealed a significant improvement in well-being and all parameters for ART.

Thus, once again I would like to emphasize and recall the importance of diagnosing the cause of diseases.

My experience with the use of methods of vegetative resonance test and bioresonance therapy is 1 year.
