

Algorithm of work in the "IMEDIS-TEST" system

IN classifications diseases reflected theory medicine, corresponding to the most common ideas of different periods of development. At the present stage, it should be highlighted:

1) Morphological classification - according to the predominance of the diseased organ or systems at the macro and micro levels.

2) Etiological (causes of diseases - worms, fungi, bacteria, viruses, toxins, stress, trauma, etc.).

3) Pathophysiological - methods of response, predisposition, diathesis.

We are more impressed by the consideration of all three classifications with the priority of the theory of miasms by S. Hahnemann.

The latent existence of miasm in the human body arises at the mental level for several generations and is reflected in the state of the genome, which scans and regulates the system and sets the program of life. An incorrectly chosen way of life, exposure to exo- and endotoxins lead to a disruption of adaptive mechanisms, the awakening of miasm. At the same time, due to the blockade of many chromosome loci, the genetic apparatus is unable to scan and normalize regulatory mechanisms. There is a distortion of the system at the morphological, biochemical, energy levels, a violation of the immune system and the development of pathogenic flora.

To destroy the miasm requires work on the spiritual, mental, energetic and physical levels.

First of all, when examining a patient, we are interested in his general condition. How to measure what S. Hahnemann called vital forces, how to get an integral informational image of the patient's state?

In the vegetative resonance test, the most common indicator is group health. At each of the levels, when tested according to the "IMEDIS-TEST +" method, four groups of problems are reflected in severity: 1 - problems only at the physical level, 2 - frequent acute conditions, 3 - joining physical mental and emotional problems, and the level of health increases with the neutralization of psychological problems, 4 - deep mental disorders; a sharply aggravated state about the accession of acute processes.

Comparison of indicators of group health level at each of the four levels, as well as filtering through Fe met. D60 allows you to reliably select the optimal level at which you should work at a given moment. Both the volume of therapy and the degree of sensitivity of the patient (the potency of the selected drug) depend on this.

The next stage of diagnosis is an definition common biological indices and general adaptation reserves (at the moment, optimal and constitutional), as well as the state of the body systems: immune, endocrine, psycho-emotional, ANS, STN, bactericidal activity, slagging of lymph, the ratio of anabolic and catabolic processes and acid-base balance, the state of the body according to

morphological scales at the intercellular and cellular levels.

The state is determined chakras, meridians, key meridian, organs, in a suboptimal state, the most affected organ, nosodes and key nosode, blockade of the mesenchyme, DNA, chromosome, having a load, the ratio of PSORA / SYCOSIS / LUESIN.

This diagnostic algorithm takes into account the morphological picture, the pathophysiological way of reaction, the etiological factor in the broad sense of the word (the cause of the causes according to S. Hahnemann), i.e. the informational image of the patient is determined at a given time interval.

The degree of "pollution" of the organism depends on the state of the genetic apparatus, vitality, spiritual and psycho-emotional level of the patient at this stage, therefore, the desire to

miasmatic approach to the treatment of chronic diseases.

It is necessary to clearly imagine the ratio of miasms in the patient at a given time.

The deepest is PSORA,

Corresponds to blue. Psoriasis pollution is a legacy of leprosy and its chronic suppression, a deficiency at the level of all processes: lack of metabolic processes, dystrophy, lack of sleep, courage, opportunities, etc.

SYKOSIS is the result of insufficient excretion and accumulation of metabolic products in the body. Excess in everything (complete, boastful, selfish. Excess complaints, discharge, growths. Always in a hurry, active and active. Corresponds to the color yellow.

LUESIN - perversion and destruction in everything at the morphological, functional and spiritual levels. Death wish, inappropriate behavior, rude violent behavior, ulceration. Corresponds to the color red.

After the production of the target marker, a color preparation, a homeopathic preparation, an information preparation, a key point in the required potencies are selected; with the patient, his mental problems and the ways of their realization are discussed.

The image is simulated according to key problems by introducing the selected drugs into the measurement circuit.
