

## Energy Information Medicine in the Treatment of Certain Neurological diseases

Approaching the solution of one or another health problem, we proceed from the position that the body is a single whole. In this context, all our work is aimed at restoring the disturbed balance. Any therapy should be physiological. Energy-informational medicine meets these requirements.

We have treated patients who are difficult in terms of therapy according to allopathic schemes. At the same time, the generally accepted approaches have not been canceled. Knowledge and methodology that have existed for many years in energy-informational medicine, which have justified themselves in practice, plus the experience of a neurologist, knowledge of homeopathy, Chzhen-chiu, made it possible to approach the restoration of health in slightly different positions.

The results obtained allow such an approach to be considered justified and give grounds for these techniques to gain the right to be recognized and widely used in the treatment of complex neurological diseases, in particular, such as: passive sclerosis, epilepsy, Parkinson's disease, Parkinson's disease, nervous tics, migraines, climacteric neuroses (with persistent headaches, sleep disturbances, fluctuations in blood pressure and other manifestations), etc.

Good results were obtained in all cases. It should be noted that the earlier the application of our method is started, the better the result (before the formation of contractures, pronounced atrophies, ankylosis, synkinesias, etc.). This applies to all diseases with organic pathology.

In particular, to multiple sclerosis - one of the most common diseases nervous system. The cause of its occurrence, as well as the pathogenesis, has not yet been finally clarified. The most likely infectious-allergic theory, according to which the acute period causes a neurotropic virus, and the entire subsequent course of the disease (especially the mechanism of relapse of the disease) is due to the allergic component, autoimmune processes (breakdown of myelin, leading to demyelination, etc.). The disease occurs at a young age and has a chronic progressive course. Long-term remissions are characteristic. Typical for this disease "sclerotic plaques" are scattered in different parts of the central nervous system, more often - the spinal cord, brain stem, optic nerves (picture of retrobulbar neuritis). Depending on the localization, the picture is different. The classical form is characterized by three features - nystagmus, intentional tremor and chanted speech. By the name of the author who first described it - "Charcot triad" (15%). The cerebrospinal form is more common (60-70%), in which there are various combinations of cerebral and spinal symptoms - spastic lower paraparesis, absence of abdominal reflexes, pelvic disorders, and others. This is, in short, what you need to pay attention to before describing the algorithm.

A total of 4 people were treated. Cerebrospinal form, the duration of the disease is about 1 year, the neurological picture corresponds to that described

higher. In all patients, a pronounced positive dynamics was obtained literally right there - the gait improved, the stiffness in the legs disappeared, the tone and sensitivity were restored, and a little later the function of the pelvic organs. The speech became the same - without chanting elements, the intentional tremor disappeared.

"I just fly,... lightness in my legs, throughout my body,... strength has grown," - these are the words of patients at the second or third visit. Treatment was started at the onset of the disease, after the necessary examinations were carried out on an outpatient and inpatient basis, including MRI and others.

At our visit, the diagnosis of multiple sclerosis also did not raise doubts during the examination by the Neurologist and during testing. We received an answer to the question "WHAT?" And specified the specific nosological form. The algorithm did not differ significantly from the one we study in the courses; it is fully described in the Materials of the X, XI Conferences. We always adhere to the principle from GENERAL TO PRIVATE. Our other principle REGARDING ACHIEVED RESULT. progressive diseases existing neurological INDIVIDUAL approach. This applies especially to the complex nervous system. We "track symptomatology ", it is necessary strictly

initially eliminate discovered load - geopathogenic, electromagnetic, radiation. Already these first steps give positive changes in the patients' well-being. If we find False polarity, Hotbeds, Fields of interference, we prepare preparations. We widely use in further work induction programs P - 5, 8, 10, 15, 22; programs "E" - different, according to indications; organopreparations of various structures and sections of the brain and spinal cord, for the creation of PBS, for bioresonance therapy (as well as diagnostics). We work with the immune and endocrine systems, first eliminating their exhaustion. If necessary - with bacteria, viruses and what prevents the body from being healthy. The general BR-drug, which harmonizes the activity of all organs and systems, is at the same time an excellent drainage agent, we ALWAYS prescribe to everyone.

It should be emphasized that when working with the equipment of the Center "IMEDIS" we adhere to the principle - "DO NOT GO FORWARD" diagnoses previously made somewhere. At the same time, do not distance yourself from the existing and accepted in medicine - ultrasound, general biochemical analyzes of blood and urine, Ro studies, NMR, etc. We remember the basic law of doctors - "DO NOT HARM". All analyzes are done at the beginning and during the work with the patient, when the same studies are needed to confirm the NORM.

At the first visit, we inform the patient about the method, emphasize its safety, briefly introduce the basics of homeopathy, Chzhen-chiu. We point out that in the body, in addition to the visible - the physical body, there are energy channels, etc. Then we proceed to the anamnesis. In short, anamnesis vitae et morbi. Complaints are described in detail by the patient himself, ranking according to the degree of significance for himself. At the same time, we ask you not to list the diagnoses in their sequential presentation, but approximately as in homeopathy: what? where? and modalities. Why is it better, worse? At the same time, we do not divide a person "into separate parts": for the treatment of eyes - an ophthalmologist), ear-nose-throat - an otolaryngologist, a thyroid gland - an endocrinologist,

heart - cardiologist, lungs - pulmonologist.

A doctor of any specialty in energy-informational medicine "finds himself". We treat a specific patient using the principle "FROM HIM AND FOR HIM".

At the same time, we restore ALL organs and systems. A person is freed from a problem that has bothered him for many years. The diagnosis we made does not always coincide with the one with which the patient came. The positive dynamics is confirmation of the correctness of our approach and our treatment.

Patients with Parkinsonism. In this case, we mean the differences from Parkinson's disease and manifestations as SYNDROME in various diseases. We have described this in detail in the Materials of the XI International Conference "Theoretical and Clinical Aspects of the Application of Bioresonance and Multiresonance Therapy" in the article "Prospects and real possibilities of bio- and multiresonant therapy for Parkinson's disease and parkinsonism." Of course, diagnostics existing in the IMEDIS selector help.

At the first appointment (in the presence of Parkinsonian syndrome) we decide the question - WHAT ?, then - WHERE?

This is necessary, otherwise we can get a negative result from our work. Outwardly, the equally pronounced Parkinsonian syndrome requires a different approach in each of the options set out below:

1. Parkinson's disease (idiopathic parkinsonism) - 85%;
2. Secondary parkinsonism;
3. Parkinsonism within neurodegenerative diseases (atypical parkinsonism);
4. Pseudoparkinsonism or something else.

As you know, Parkinsonian syndrome is characterized by: general stiffness, posture - bending forward a little, shuffling gait in small steps, shallow trembling in the fingers (often in the legs), monotonous speech, mask-like "emotionless" face, later - intellectual disturbances, functions pelvic organs and others.

It should be noted that we more often met and is more promising for work Secondary Parkinsonism, from which it is necessary to single out:

- a) vascular (the genetic factor is of great importance, and not only the vascular process itself. The Selector has markers for most problems);
- b) medicinal (barbiturates, long-term use of neuroleptics according to psychiatric schemes, Cinnarizine, Stugeron, Dopegit, Reserpine-containing drugs);
- c) toxic (with alcohol intoxication, against the background of drug addicts, "carbon monoxide", etc.).

Parkinson's disease requires increased attention and constant monitoring of the patient, correction in treatment. The pathogenesis, modern views on the problem, the algorithm and the positive results obtained are described in detail in the above article in the Materials of the XI International Conference "Theoretical and Clinical Aspects of the Application of Bioresonance and Multiresonance Therapy". The complexity of managing these patients pays off

results. They are encouraging and require continued collaboration among neurologists who are proficient in our techniques. The accumulation and systematization of the obtained data will be relevant, especially since numerous International Conferences "Theoretical and Clinical Aspects of the Application of Bioresonance and Multiresonance Therapy" put this problem - Parkinson's Disease - in one of the first places in the world.

In the treatment of Secondary Parkinsonism (vascular, medicinal, toxic), the results are obtained relatively quickly. At the same time, we work using the algorithm described above, taking into account individual characteristics. In case of medicinal and toxic substances, we "remove the problem" from the body, using the 3 inverted container. In all cases, we start working with the existing loads - GPN, EMN, radioactive.

In the future, we connect the OP of the cerebral and subcortical structures "guilty" of the syndrome that has arisen - Substantiation nigra, Striatum and others (described in detail in the article above).

Another group that responds well to energy information therapy, according to our observations, are nervous tics. The algorithm of therapy, a detailed description of this pathology and differential diagnosis are described by us in the Materials of the X International Conference "Theoretical and clinical aspects of the use of bioresonance and multiresonance therapy." There are a great many manifestations of nervous tics. The causes are different. When working with such a pathology, we first divide patients into two groups, depending on what underlies the disease:

- 1) functional disorder of the nervous system (25 people);
- 2) organic disease of the nervous system (10 people).

In cases when we are dealing with 1 group, we carry out treatment according to the existing schemes for working with neuroses, which we have repeatedly written about in Materials of Conferences. Algorithm We use everything that is aimed at systems. Preparing BPS-preparations interested meridians. We often use Bach Flowers and Guna preparations. Determining the dose, frequency of admission The treatment is continued for about 1 month.

However, the positive effect is visible after 1-2 days. We use induction programs "Children's", "Cerebral" and others. It's a different matter if tics are based on organic pathology. In this case, diagnostics using the ART method allows you to clarify the diagnosis, being at the same time a differential diagnostic method (in a short time and without additional material costs). In organic nature, we determine WHAT and WHERE is affected. According to the result, we carry out the correction of the detected. These can be various parts of the brain or subcortical structures, rheumatism, or something else (diagnostics are available in the Selector). Treatment is always individual for a specific person, taking into account his characteristics, we work according to the principle "FROM HIM AND FOR HIM" and "RELATIVELY ACHIEVED". We prescribe a general BR-drug to all patients, we give it always and to everyone,

In our practice, there were several patients with a diagnosis of epilepsy, but it was concomitant. The problems that forced us to contact us were different and everyone had different ones. The general diagnosis was -epilepsy. For many years, everyone took anticonvulsant therapy, were monitored by a neuropsychiatrist. The seizures were with a frequency of 1–2 in 2–3 months - general, “developed” seizures (with loss of consciousness and other manifestations characteristic of epilepsy) and “worn out”, of the “petit mal” type.

The diagnosis was not in doubt. As a result of our work, "attacks" became less frequent, and then stopped altogether. The algorithm for managing such patients is similar to that described above: they also worked with the elimination of the detected loads, carried out psycho-emotional correction, and so on, according to the scheme known to us. The peculiarity was that the anticonvulsants were not canceled, but after determining the effectiveness, they were replaced with analogues along the interested meridians. The observation period was 2 years. Is it early to draw conclusions? Need to continue monitoring? Fact is fact.

The main thing is that the problem with which each patient addressed "is gone", which is confirmed by the data of the conducted examinations. And at the same time, the "attacks" that had existed for many years have stopped. (Subsequently, anticonvulsant therapy was canceled for all patients in polyclinics).

A special group among all functional diseases of the nervous system is occupied by the so-called climacteric neuroses. In general, many studies and articles have been devoted to the group of neuroses and the problem of disorders of the nervous system. No wonder there is a widespread opinion that "all diseases are from the nerves." If the nervous system is "upset", even Biological Indexes change (as opposed to Photonic ones). In our time, with its colossal overloads - physical and emotional (against the background of general environmental pollution, increased levels of radiation, electromagnetic loads, etc.), the growth and variety of manifestations of neuroses is not surprising. The nervous system is especially vulnerable during periods of restructuring of the body, with menopause. Moreover, menopausal manifestations are also found in men, but in women - more often and more pronounced. Neurologists and psychiatrists know how difficult it is to work with functional disorders of the nervous system - with neuroses. Significant changes were made by energy-informational medicine, the equipment of the IMEDIS Center. We carry out diagnostics and treatment at the same time. The effect is simply colossal. A separate large article can be devoted to this topic. In short, patients simply “flourish”, numerous complaints disappear, sleep is restored, efficiency increases, various vegetative manifestations disappear (hot flashes, surges in blood pressure, sweating, etc.).

I would especially like to emphasize what happens visible to all REJUVENATION (the structure of the skin improves, problems disappear - hair, eyes, etc.). This is described in detail in the article "Using the equipment of the IMEDIS Center in solving complex problems of cosmetology" in the Materials of the XI International Conference "Theoretical and Clinical Aspects of the Application of Bioresonance and Multiresonance Therapy". It can be said for sure that with the advent of equipment in the work of neurologists and psychiatrists

Center "IMEDIS" disappears the problem of treatment of neuroses.

The algorithm is described in detail in numerous articles, especially recent conferences. We work with geopathogenic, electromagnetic and radiation loads, removing them from the body, restore the functioning of the immune and endocrine systems (we eliminate HPN, EMN and Ro at the beginning of any of our work). Often there is a combination of neurosis and some other pathology. We are working with this problem, which exists. We always prescribe a generic BR drug.

Good results have been obtained in patients diagnosed with migraine. As you know, this is a large group with diverse manifestations and complex pathogenesis. Common to all - headache attacks, usually one-sided. Here are just a list of some types of migraines: associated, basilar, fascicle, migraine neuralgia (histamine cephalalgia), cluster headache - cluster headache, menstrual migraine, chronic paroxysmal hemicrania. This is not a complete list of the existing variety of migraines. The complexity of the treatment of such a pathology makes us look for new approaches, new methods. We get good results when using Zhen-chiu. Homeosiniatry helps such patients a lot (the introduction of a homeopathized ampoule preparation of the "Heel" company into the BAP). However, even more significant positive results are obtained with energy-informational therapy. The algorithm is common for everyone, but in the course of work we connect the OP of structures interested in the development of pathology, we work on the restoration of the immune, endocrine, and nervous systems. We widely use induction programs - Cerebral, Endocrine, Children's, Relaxation and others.

We use fixed frequency programs "E" in our work. The therapy carried out according to this scheme gives an undoubted effect. The results obtained inspire some optimism, since neurologists know how difficult it is to work with a pathology such as migraine. Further required continuation of work in this direction.

Conclusions:

1. Energy information restoration of health, allows therapy is an effective in solve complex diagnostic issues and treatment.
2. With the right approach, energy-informational therapy is promising in terms of restoring health in complex neurological diseases.
3. It is highly desirable to use energy-informational therapy on the initial stages of the disease, which will shorten its duration, improve the quality of life of people.
