About psoriasis and alcohol V.L. Boltunova (Warsaw, Poland)

In addition to the almost monographic article by I.V. Fedorovskaya and O.I. Eliseeva about psoriasis [1] I would like to add my observations about the treatment of patients with psoriasis. In two cases, we were unable to obtain a sustained remission. While the patients were under our round-the-clock supervision, the improvement was significant, but after a few days of staying at home, the disease returned. After talking with relatives, it turned out that these patients had "latent allergic reactions - food (most often to the patient's favorite foods)" [2]. In our case, it was an alcohol allergy. Here it was necessary to treat not alcohol dependence, but alcohol allergy. And alcohol dependence could appear later.

In addition, these patients felt comfortable with their illness, because received disability benefits and were relieved of all household chores.

The patients were recorded: for a man - on crumbs, for a woman - on a pendant: "samosobotazh" + antiallergen for alcohol (the preparation of the company "GUNA" E Plex 19) = antialcohol (a group of drugs from our own "repertory"). Both the grits and the suspension were tested on the MINI-EXPERT-DT apparatus. The answer was "yes" - they are needed.

On subsequent visits, it turned out that the pendant was "strangling" and the woman took it off, while the man's grits "crumbled". They had to be treated like alcoholics - anonymously, i.e. there had to be someone interested, loving, but there weren't any.

A few words about alcoholics. Of course, this is a disease, but not from choice. Disease of people with a vulnerable psyche. If he didn't drink, he would go blind or hang himself, get a heart attack or stroke, or get cancer. According to A.N. Mathison, referring to Luule Viilma [3], alcoholics live with the attitude "they don't like me".

We take alcoholics to cure if there is someone who is loving and patient next to them. It is necessary not only to free a person from alcohol addiction, but also to teach him to live in this terrible world without the previous social protection, to teach him the ability to stand up for oneself with the effective and interested participation of one of the patient's relatives. Naturally, you have to deal with the psyche of this assistant.

For treatment, we, of course, widely use Systemic Spiritual Adaptants, drugs "psychosocial stress" from different companies, and we certainly carry out detoxification and regeneration of the body according to the methods described in the software and in the materials of conferences.
