Consciousness of a doctor - as a basic factor in the organization of medical diagnostic process

Methods energy information medicine - homeopathy, homotoxicology, EAF, ART and others - currently exist as phenomenological phenomena, i.e. none of them has a coherent scientific theory. However, many years, and in the case of homeopathy - two centuries of experience in their use shows their effectiveness and efficiency.

There are many approaches, theories, concepts with attempts to substantiate the mechanism of their action. Practical doctors, analyzing their daily experience, discussing the results of the analysis with colleagues, create exactly the foundation on which a coherent theory of energy-informational interactions in biological systems will be created.

The purpose of this message: to voice the phenomena that many doctors face, but which are difficult to recognize, and even more so to bring their observations to the judgment of colleagues. It is about the influence on the results of diagnostics and treatment of the basic attitude of the operator. Recognition of this phenomenon can become the foundation on which various currents existing in our heterogeneous electropuncture community could develop organically, mutually complementing each other.

At the stage of mastering the vegetative resonance test, everyone faced the phenomenon: if by mistake a completely wrong diagnostic was taken into the test, but the doctor did not notice it, the test result will be as if no error had occurred. If an important link in pathology is localized here, then a good effect of therapy in the form of weakening or disappearance of complaints, clinical manifestations of the disease,

But if the diagnosis is carried out by a homeopathic doctor, for whom the disease is, first of all, a disruption in the functioning of the "vital force" in the body, manifested through certain symptoms from the physical body, through the peculiarities of emotional reactions, through a change in the mental

activity and peculiar behavior, then, firstly, the diagnostic data on the same equipment will differ from the data of the first doctor, and, secondly, the assessment of the treatment results will be different. An optimistic report like "... blood pressure has decreased, pains have disappeared, episodes of acute respiratory viral infections have stopped, although depression still persists, a periodic need for sleeping pills, but we are working with this" - a homeopathic doctor will be regarded as a case of unsuccessful treatment, requiring an immediate review and change of treatment as contrary to Hering's law.

A reflexologist will always receive a much more accurate picture in all methods of meridian diagnostics.

It is absolutely useless to find out in this case who is right. Truth is never linear and unambiguous.

It is much more important to know and understand that we get the worst results when we study a new direction for ourselves. Internally, we have already distanced ourselves from the known, but not always satisfying our needs knowledge (this is the incentive for learning new), and new knowledge has not yet become a solid basis. It is worse when it is difficult for a doctor to believe in the reality of energy, information, meridians, chakras, but he has to work, and he sits down at the device with inner protest, with the confidence that serious diseases cannot be cured by such methods and, as a result, there is no result. The attitude of the patient is equally important. Our experience shows that the best results are possible in two cases:

- 1. The doctor and the patient are open and friendly towards each other, everyone understands the extent of their responsibility in solving the problem and fulfills their obligations this is an ideal and not at all rare option.
- 2. The doctor is convinced that the patient should be executive, disciplined, and the doctor knows and decides everything else.

The similarity of these two dissimilar options is that the treatment process has a unidirectional energy component. What tactics to use should be decided by each doctor, but just not rush about, wanting to work as more experienced colleagues do. Any new idea should fit seamlessly into your individual work style. It is also not worth adjusting to please the patient. Patients only think they are looking for the "best doctor", in fact they are finding "their own doctor." And if suddenly a doctor has changed as a person as a result of life collisions or as a result of work on himself, or he has changed as a specialist as a result of comprehending new knowledge, some of the patients will leave him and this is normal, no need to reproach yourself for this.

The creator of the theory of functional systems academician Pyotr Kuzmich Anokhin argued that "... in every functional system there is an apparatus for evaluating information - the so-called acceptor of the result of an action, which is at the same time an apparatus for predicting the result. That is, having analyzed the incoming information, on the basis of the available experience, he immediately forms information models of the required result. " And in the research of Corresponding Member of the Russian Academy of Medical Sciences, Doctor of Medical Sciences E. Umrikhin, it is shown that the processes of human subconscious activity are also built in accordance with the general principles of organization functional systems.

CONCLUSION: the doctor, even before the start of the session, creates the background that will

determine the accuracy of diagnosis and the effectiveness of treatment.
