

## Some observations when working at APK "IMEDIS-EXPERT"

Medicine has divided a person into parts, or better to say - into "carcasses": one "carcass" is treated by pulmonologists, another - by cardiologists, then dermatologists, gynecologists, ophthalmologists, ENT doctors, etc.

Teeth, dental diseases - dentistry has completely branched off from general medicine, but sensitive teeth, caries, periodontitis are a consequence of diseased organs: liver, kidneys, pancreas, gynecology, etc. The teeth are destroyed from the inside due to diseased organs.

Sick spine - osteochondrosis, radiculitis, etc. The cause of their pathology is also found in the abdominal organs.

Our patients are not interested in our ignorance at all, they "give" treatment now. So they run from one specialist to another in search of a doctor with unconventional thinking and treatment.

The cause of all diseases in a person is one, less often - two, and they must be treated. At all medical conferences, the body is said to be a self-regulating system. And, nevertheless, they continue to prescribe a huge number of medicines (allopathic, homeopathic, nosodes, complexones, etc.), sharply suppressing self-healing, self-regulation. The defenses cannot withstand a huge amount of medicine. Hormones and antibiotics are especially harmful. Hormones powerfully block organs. In these conditions, self-healing is out of the question.

I work on a hardware-software complex (AIC) of the firm "IMEDIS". Practice has shown that this apparatus is somehow capable of setting in motion organs and systems; they begin to feel, "understand" each other, help each other. Inside, everything is closely interconnected, if an organ is ill, the entire body is involved in the treatment process, i.e. the treatment is carried out "by the whole world". But since acute pathology develops against the background of existing chronic diseases with blocked organs; a quick therapeutic effect cannot be expected. Many patients are now beginning to realize that there are some difficulties with the treatment process. One patient says: "My daughter and I go to the doctors, we have already tortured them, but the treatment is not going on. Sorry for the doctors. "

The Voll method and bioresonance therapy are classics. But everyone works to the best of their knowledge and abilities. I take measurements according to Dr. Voll's method. In the first 2-3 sessions, information inversion with low BAP values is required. The inverse drug has an amazing ability to push out toxins, chemicals, etc. from every cell of the body. It is a good drainage agent and no others are needed. In patients, immediately after the 1st session, toxic products of various origins begin to enter the blood from the tissues. For better elimination of toxins, it is imperative to drink 1-2 liters of liquid daily, for adults - slightly salted water is better: at the tip of a sharp knife 1 cm long, 4-5 crystals of table salt per 250.0 ml of boiled water, drink the liquid until 16-17 hours to sleep at night. In this case, the patient feels normal. If the liquid is not consumed, the toxins are carried by the bloodstream.

one place to another, the person shows signs of intoxication. With further treatment, I no longer use inversion. Also, I do not use flat electrodes in my work, I use a variety of magnetic inductors manufactured by IMEDIS.

Several years ago I decided to check the state of the biologically active points after the completion of the treatment session. An unexpected situation opened up - all the indicators turned out to be extremely low, although I conducted the session so thoroughly and for a long time. But taking 1 grain of a bioresonance drug immediately brought all indicators to a high level. A new awareness soon came. During drug testing, we select those drugs that increase all indicators. "Look," we say to the patient, "what a good drug, how high and quickly it raises indicators". We are happy and make the patient believe it. But in reality, it turns out that during drug testing, the indicators increase only on the periphery of the BAP of the hands and feet, and inside, in the organs, as there were problems, they remain unchanged. Means, the medicines we have selected do not work inside, they do not solve the problems. For me, this is a new phenomenon, a secret of nature. Only now did Dr. Voll understand why he subsequently switched to electrotherapy. Using positive or negative impulses, he relieved stress or compensated for the energy deficit in sick systems. The result was quick. But he worked on every BAP of the meridian (including corporal ones). His professionalism was high.

Or maybe the body does not react internally to our medicines just because they are not suitable for it? It means that there are other breakdowns inside, which we do not even know about, and therefore we do not carry out treatment.

Our body is a highly developed biosystem that knows all its diseases, knows how to get itself out of the problem. But we - physicians - interfere rudely, prescribing a large number of medications (allopathy, naturopathy, etc.), suppressing the natural ability to heal ourselves. A different solution is needed, a different approach. For example, the temperature of 39-40-41 degrees is suppressed by doctors, although this is a good defensive reaction. Microbes, viruses, toxins, once inside, cause aches, headaches, muscle pains, cramps in children. If the body cannot rid itself of the infection, it raises the temperature to 39-41 degrees in order to burn them. But we do not see the microcosm, we see the temperature and are fighting with it.

We suppress a runny nose, diarrhea. Skin manifestations (they are of a protective nature) are also suppressed. We bury it, cover it up, plug everything that the body tries to throw out.

The body is like a trap - everything that gets inside, settles forever: microbes, viruses, toxins, chemistry, hormones, antibiotics, etc. Unable to withstand such pressure, in the end, the body "folds its wings", ceases to fight not only with the doctor, but also with its diseases. And in order to survive, he begins to adapt to the disease, begins to peacefully coexist with it. Over time, some kind of compensation develops. And the body does not want to violate this compensation even during treatment. For example, with age, the body begins to dump toxins, chemistry into adipose tissue. Each fat cell is like

thermos where the body stores this poison. In liposuction, when the fat cell membrane is melted, toxins are instantly absorbed into the bloodstream, spreading throughout the body. Their action is like snake venom. Hence the serious consequences, up to clinical death.

### Chronic diseases

Chronically diseased organs are blocked, pain in them disappears, treatment "does not break through" to them, the disease progresses, gradually destroying not only the organ, but the entire system. The energy deficit is replenished by the "pumping" of energy from other systems, where pathology also begins to develop over time, but already of a secondary nature with the corresponding symptomatology - a "cry" for help. And in medicine it is customary that screams should be treated.

Example: acute rhinorrhea. After hypothermia or infection during an epidemic, viruses or microbes that enter the nasal cavity begin to multiply. The body reacts quickly - the enemy has penetrated. The first reaction is that the vessels become porous, a large amount of serous fluid seeps through them in order to wash away, in the literal sense, uninvited guests. Water exchange is controlled by the kidneys. And if the kidneys are involved in this process, then the disease has got them. Hence the conclusion that acute respiratory infections are a disease of the kidney colds. Kidneys ache, and the nose "screams".

### About kidneys

We are underestimating the purpose of the kidneys. We believe that the kidneys are an organ that regulates water-salt metabolism, and secondly, an organ that forms and excretes urine. The changes that are revealed during the examination of the kidneys correspond to already gross violations in this system. The preclinical stages of kidney damage are invisible at first glance. But this is not the case. Kidney disease is multifaceted. These are all kinds of allergies, anemia, gastrointestinal tract diseases, lung diseases, skin problems, poor appetite in children, high blood pressure, etc.

The kidneys are primarily a vascular organ, and it does not matter where the vessels are located: in the kidneys, in the heart, in the nose, in the walls of the gastrointestinal tract, etc.

The first manifestations of kidney pathology are the sweating of serous fluid into the organ, into the system. In the nose - rhinorrhea, in the organs - gastritis, bronchitis, etc., on the skin - diathesis. Sweating in tissues - swelling (eyelids, lungs, extremities, etc.).

Thus, all colds are sick kidneys: pulmonary diseases, including bronchial asthma, skin pathology, diseases of the gastrointestinal tract, hypertension, anemia - all this is a consequence of sick kidneys. The kidneys control the skeletal system, which means that bone fractures are a consequence of diseased kidneys. The condition of the large intestine and the small intestine associated with it is kidney problems, so all digestive problems, enzymopathies are a kidney problem. Sexual and reproductive functions are linked by the kidneys. All hereditary diseases are transmitted by the kidneys. The vitality, the energy given to us by inheritance, is contained in the kidneys, in other words, the kidneys give us life expectancy, it follows that the kidneys stop the heart.

But urolithiasis is a consequence, because stones are born in

blood, in the vessels, but salts crystallize in the calyx-pelvis system. My guess is that there are other kidney functions that we don't know about yet.

#### About hypertension

Once a patient came to the 2nd session. An angry dialogue took place: Patient (P): "But my blood pressure has not decreased."

Doctor (B): "How old is your hypertension?" P: "30 years old."

Q: "How many years have you been treating hypertension?" P: "30 years old."

Q: "Why have you never turned to your GP with a request

explain to you that more than 30 years have been treated, and the pressure does not decrease. "

P: "I didn't think about it."

When comparing, interesting patterns sometimes emerge. The first manifestations of kidney disease are vascular porosity when fluid is released from the vessels into the environment. The second stage of kidney disease is the flow of fluid from the surrounding tissues into the vessels, from which it can no longer leave on its own. Arthritic pressure builds up. The walls of blood vessels are weaker and less resistant to the pressure of the incoming fluid. To keep the vessels in good shape (prevent them from expanding), the activity of the renin-angiotensin-aldosterone system increases, primarily due to the hypersecretion of renin. Blood pressure rises even more. At this stage, medicine intervenes in the process. Antihypertensive drugs partially paralyze the walls of the vessels, the capacity of the vessels increases and fluid from the surrounding tissues immediately begins to flow there. For some reason, the kidneys at this stage cannot excrete fluid in the required amount. The volume of circulating blood (BCC) increases, it is more correct to say - the volume of circulating fluid in the bloodstream increases. And so this process is repeated up to a certain limit. Chemistry (antihypertensive drugs) suppresses the body and wins.

Now time is working against the patient, GB is progressing sharply, its ending is known: heart attack; stroke; cardiovascular insufficiency; nephrogenic pulmonary edema; anasarka; Ante finem and more.

An interesting phenomenon was observed in the process of carrying out bioresonance therapy: a periodic increase and decrease in indicators on BAP. Then I realized. The body is 85% water. And where the seas are oceans, there are ebb and flow. I found them in the body. I noticed that blocked organs do not take part in wave-like changes in indicators. But, if at least one organ does not participate in the general treatment, recovery will not come. Wavelike changes are detected only when measured by the Voll method.

In some cases, during treatment, patients have a feeling of numbness in the hands, less often in the feet. Realization also did not come immediately.

Blocked organs are numb. When leaving the block, numbness is thrown outward, to the periphery in the hands, less often in the feet. In this case, the patient himself must massage the four opposing fingers of the same hand with his thumb, as if he wants to salt something. Everything passes quickly - the numbness information is erased.

If the entire state of health from birth to the present moment is recorded on film, then with bioresonance and homeopathic treatment, the film is scrolled in the opposite direction, and those diseases that were incompletely treated appear. The doctor's task is to recognize this situation and help the patient in a timely manner.
