

A new example of restoration and correction of the psycho-spiritual equilibrium

In this work, we will continue to acquaint our esteemed colleagues with the most striking examples from our practice of restoring and correcting mental and spiritual balance in middle-aged patients.

The case presented below is also interesting because in the situation under consideration, biopathogenic objects (BPOs) were identified, the material about which was also presented in the collection of abstracts of the last year's Conference [1].

And it should be noted that almost for the first time in our practice, we saw the patient's willingness to independently purchase a therapeutic device from the firm "IMEDIS" to increase the effectiveness of treatment, which only confirms the confidence in the effectiveness and efficiency of the developed technique.

Patient V., 47 years old. I turned to a fairly common question of how to properly influence a teenage son at a transitional age, however, upon a deeper examination of the situation, it turned out that for a fairly long period of time after a divorce from the child's father, our patient constantly found herself in very delicate and unpleasant situations associated with by the behavior of her ex-husband, who criticized and condemned her in the presence of her son and with other relatives, and even with strangers, and also, having a set of house keys, appeared without an agreement and only when he wanted, and instead of providing real help and participation in the upbringing process, demonstratively "rummaged" on the refrigerator and played on the computer.

In fact, a teenage son, constantly observing the incorrect behavior of a man in the family and a negative example of the mother-father relationship, began to form an absolutely incorrect value system. The child was capricious and opposed to the mother. Against the general background of the atmosphere in the family, his son's academic performance was falling, there were no good comrades and interests besides school, which could soon lead him into bad company.

As is already accepted in our practice, in such situations we use the capabilities of our devices, in this case it is "MINIEKSPERT-DT", and work with induction programs and the necessary frequencies.

We were especially pleased that the boy treated the treatment process not only with understanding, but even with curiosity, and did not refuse to accept energy information drugs ("Peas") in periods between direct sessions of frequency therapy.

Positive results in the behavior of his son appeared practically immediately, and this very much interested his own father, who began to appear much more often in his first family and nevertheless drew attention to his own the child as a person, showing an interest in his progress.

At the same time, the new wife of our patient's ex-husband, worried that the man began to devote more time to his son, organized several events aimed at distancing him from the first family.

This allowed us to conclude that this woman is either

direct BPO (biopathogenic object), or one of the segments in the corresponding chain of BPO (such chains are studied by us separately, and here it is necessary to take into account that the processes of such interaction are extended in time).

We proposed a number of means that would protect our patient from the influence of this object, and for this we examined V.'s apartment according to the author's technique of "interior therapy®" [2].

The developed program of protection included, among other things, energy-informational preparations made on the device "IMEDIS-BRTA".

Considering that we have been using this technique for a long time and regularly, the results were not long in coming. The situation continued to develop positively, and our patient was able to better and better control her.

The ex-husband gradually self-disciplined and changed his attitude towards V., and the son was the first to notice this and drew the mother's attention.

Against the background of the husband's respectful attitude, changes appeared in the behavior of his son, who, noting his father's reaction, himself became more attentive and sensitive in relation to V., as well as more obligatory in relation to school.

All these changes allowed V. to reevaluate the situation, change her attitude towards herself, and, in parallel with the treatment, which was, among other things, the amplitude-frequency harmonization of the personality, V. took up her own image, which only improved her social position, causing endless surprise on the part of the ex-husband and his relatives, increased attention among colleagues and other men, as well as delight from the son, who finally saw that his mother was not only a fiddler who is trying to keep track of his progress between work and household chores, but she is a successful, surprisingly beautiful woman who commands respect from many, and, importantly, from her father.

Six months after the first meeting with us, V. already independently understands how to behave in relation to the child and her ex-husband, the stress factor that has followed her for many years gradually passes and a huge amount of energy is released, which is spent on normal, everyday moments, on elementary the joy of life!

From time to time, we carry out a correction of the treatment program, since our patient, in the process of self-development, makes an appropriate self-assessment of her actions, which gives her bright hopes, and it is at this moment that it is imperative to make an individual correction of the treatment.
