

Treatment of diseases taking into account the electromagnetic load

No one will argue that human health is one of the greatest values. To realize oneself in any area, a person must first of all be healthy.

We live in the age of electronics and scientific and technological progress, taking advantage of all its achievements. In the last decade, a large computers, cell phones, etc. have become widespread. Residential areas of cities are surrounded by an extensive network of repeater antennas for satellite, television and radio communications. Household appliances are also capable of emitting a wide range of electromagnetic waves.

The background that exists around us, created by all sorts of radiation, can not but affect our health (the state of vital organs and systems). This applies to all of us.

Many businesses and companies network their employees' computers so that they can exchange information, use e-mail and the Internet. To do this, computers are connected to the network using a cable that runs under the floor. Each conductor has its own electromagnetic field, and it turns out that all people in the office are surrounded by this field, emanating from a variety of sources, ranging from the wiring of telephone cables, computers to air conditioners.

Unlike Western, "pharmacological" medicine, traditional Chinese medicine considers human health as a harmony with the world around him and with himself. Violation of this harmony leads to disease and the goal of treatment is to restore the lost balance. In the system of the Five Elements, electricity and electrical appliances are considered as the energy of Fire. In traditional Chinese medicine, it is believed that an excess of this type of energy leads to heart disease (since the heart meridian corresponds to Fire) and irritation of the nervous system. Electromagnetic loads (EM) on the body are constant, when they are constantly tested, and temporary, which arise and begin to be tested when approaching the source (for example, the patient takes a cell phone in his hand). At the end of the 1940s, attention was drawn to the possibility of an adverse effect of EN on the human body. it was found that the clinical manifestations of EN exposure are most often characterized by asthenic and autonomic reactions. The immune system is such a regulatory defense mechanism. The body is able to neutralize the negative impact due to the existing mechanisms of self-regulation and self-defense. But if there is a malfunction in the immune system, the human body becomes vulnerable to the action of a pathological factor. Thus, EN causes not only immune weakening, but also the development of somatic pathology in target organs.

The presence of EN is a trigger mechanism, as a result of which a vicious circle arises in the body - immune weakening, endocrine failure, disruption of the functioning of vital organs. In this case, target organs can be hereditarily determined, i.e. genetically weaker. For example, if a family has hereditary diseases of the cardiovascular system, then it will suffer first.

When diagnosing, it is imperative to identify the effects of EN and further treatment should be carried out taking into account its presence.

When treating patients in our center, in parallel with the removal of EN, homeopathic support of the meridian of the heart, as well as the immune and nervous systems is carried out.
