Application of ART and BRT methods in cardiology A.V. Makarevich ("Center for Resonant Medicine" Infomed ", Minsk, Belarus)

It's no secret that diseases of the circulatory system (CVD) annually claim tens of millions of lives around the world, and continue to lead in the structure of adult mortality, despite the fact that all new dosage forms, the latest methods and techniques of surgical interference.

With more than 14 years of experience in emergency cardiology, I had to deal with thousands of results of such treatment. It is always possible to predict the end of such a "treatment" with 100% certainty. As they say,- tell me how you are being treated, and I will tell you what will happen to you. And world statistics fully confirm this.

Whether a modern person is satisfied with such results is easy to guess. The methods used today for the diagnosis of cardiovascular diseases (CVD) are often unsafe for the patient (for example

coronary angiography can be fatal) are often expensive and not always informative. About treatment, we can say that its essence boils down to one thingruthless exploitation of the adaptation reserves of the diseased heart and other organs of the patient with the help of drugs. After depletion of the patient's adaptation reserves, he is usually offered surgical treatment. This is the way, unfortunately, of millions of people with coronary heart disease (IHD) in many countries of the world.

My 4-year experience of working with APK "IMEDIS-EXPERT" shows that often such a fate can be avoided because, firstly, modern cardiologists "sin" overdiagnosis of coronary artery disease, often using this diagnosis as a "popular" then there is sufficient clinical justification; secondly, inflammatory diseases of the myocardium (myocarditis, endo- and pericarditis) are underestimated (underdiagnosis); thirdly, standard treatment regimens are prescribed, leading, as mentioned above, to "standard" results, without taking into account the individual characteristics of the organism.

Let me explain the above with specific examples.

1. In August 2007, patient A., 54 years old, came to me with an established diagnosed with ischemic heart disease, with about 2 years of illness, with 2nd degree A circulatory failure, with "typical" pain in the heart, in a depressed psychoemotional state, put on a queue for CABG (aorto-coronary bypass surgery). According to the forecasts of "experts", he has no more than 3 years left to live. Omitting the questions of deontology in this situation, I will say that as a result of testing by the ART method on the APK "IMEDIS-EXPERT", there were revealed signs of chronic myocarditis, the absence of signs of atherosclerosis in the coronary vessels. This means that the blood circulation in the heart of this patient was normal, and the problems arose apparently due to coronary spasm due to the inflammatory process in the myocardium. That is, there were no physical reasons for the operation, which was confirmed by further treatment. Along the way, chronic bronchitis, pancreatitis, revealed electromagnetic burdens (including myocardium 3 tbsp.), and mental stress of 4 degrees.

Was carried out "removal" of the electromagnetic load with a frequency of 6.2 Hz, the normalization of the patient's psychosomatic state (drugs Bach Flowers, firm "GUNA", IPM programs for sleep, overcoming their fear), BRT, RFT - according to the identified pathogens. The mineral balance has been restored with the help of dietary supplements. Recommendations are given not to sleep at the power outlet. After 3 months, a MIRACLE happened! At the next appointment, to my question: "When was the last time you called an ambulance?"

Similar examples can be cited further. I will only say that this article would not have appeared if these were isolated cases. Unfortunately, my medical practice shows that the diagnosis and treatment of cardiological diseases in the post-Soviet space "suffer", which is reflected at the official level in the Russian Journal of Cardiology No. 2 for 2005 expert assessments on the problem), where it is said that the mortality rates from BSK in the countries of the post-Soviet space in 2-3 times higher than in economically developed countries, detailed statistics are given, possible reasons are named.

From the above, it can be concluded that the use of APK "IMEDIS-EXPERT" in cardiological practice allows:
