

II Russian Homeopathic Congress

In accordance with the decision of the I Russian Homeopathic Congress (Novosibirsk, 1999) and the Plan of Scientific and Practical Measures of the Ministry of Health of Russia, from June 20 to 22, 2003, the II Russian Homeopathic Congress was held in St. Petersburg.

By organizers Congress came forward Ministry health care
Russian Federation, Federal Scientific Clinical Experimental Center for Traditional Methods of Diagnostics and Treatment of the Ministry of Health of Russia, Russian Homeopathic Society, Russian Homeopathic Association, St. Petersburg Homeopathic Association.

By order of the Ministry of Health of Russia No. 604-u dated 05/15/2003, the organizing committee of the Congress was formed, which included:

Mishchenko, President of the Russian Homeopathic Society; SP Pesonina, President of the St. Petersburg Public Organization "Homeopathic Association"; executive secretary - Vasina N.M., chief physician of the polyclinic of CJSC "Intermed".

Among the members of the organizing committee are prominent Russian scientists, healthcare organizers, directors of homeopathic centers, manufacturers of homeopathic medicines, and practitioners.

Within the framework of the Congress, the exhibition "Homeopathy - 2003" was held, organized by the Exhibition Agency "RIMIEXPO". Active participation in the exposition of the exhibition was taken by: CJSC Holding "EDAS", 000 "Alkoy", CJSC "Arnebia", 000 "Gomeopharma", NPK CJSC "Medstan", 000 "Ollo", 000 "Talion-A", 000 "NPO" Energy information technologies - Eurasia "(all Moscow)," Homeopathic Association ", 000" Homeopathic Pharmacy ", JSC" Aeromed "(all of St. Petersburg), 000" Lit-Reagent "(Tyumen), 000 Krasnodar regional center of homeopathy and others.

The General sponsor of the Congress was JSC Holding "EDAS", recognized in 2002 by the Chamber of Commerce and Industry of the Russian Federation as the best homeopathic company of the year, and in 2003 awarded the Great Silver Medal named after P. Ehrlich of the European Academy of Natural Sciences for his contribution to the development of practical health care,

At the opening of the Congress, the greeting of the Minister of Health of the Russian Federation Yu.L. Shevchenko. It was stated in the greeting that "the years of mutual hostility, confrontation

The participants of the Congress received very warmly the welcoming speech of one of the largest modern homeopaths - T.D. Popova (Ukraine).

The following main issues were brought up for consideration at the Congress:

- the place of homeopathy in the health care system;
- homeopathy in clinical practice;
- homeopathy in pediatrics;
- scientific foundations of the homeopathic method of treatment and homeopathic pharmacy;
- educational activities in the field of homeopathy;
- topical issues of homeopathic pharmacy;
- development, standardization, preclinical and clinical studies of homeopathic medicines;
- raw materials and production base of homeopathic preparations;
- homeopathy and electropuncture diagnostics;
- homotoxicology and anthroposophic medicine;
- homeopathy in veterinary medicine.

At the first plenary session (at the request of delegates, all sessions were plenary), the keynote speaker "Homeopathy in Russia: State and Prospects" was made by the chief specialist on traditional medicine of the Ministry of Health of Russia, co-chairman of the Expert Council on Homeopathy under the Ministry of Health of Russia A.A. Karpeev. The report presented an analysis of organizational, scientific, educational directions in the development of domestic homeopathy over the past decade. The main result of the work done is that homeopathy is officially recognized, its development is dynamic and consistent, skepticism among doctors and scientists is confidently overcome, the authority of Russian homeopathy in the international arena is growing. The great role in the development of homeopathy of domestic manufacturers of homeopathic medicines was noted, which in a short time managed not only to stand on a par with foreign manufacturers, but also to outstrip them in certain positions. A large section of the report was devoted to the analysis of the reasons hindering the development of homeopathy, and the challenges facing all the forces involved in its forward movement towards evidence-based medicine.

Academician of the Russian Academy of Medical Sciences V.G. Zilov ("Homeopathy and Science"), T.L. Kiseleva ("On the implementation of the Branch program for the development of traditional medicine and homeopathy in the country for the period 2001-2005."). In the report of S.P. Pesonina presented the experience of educational activities in the field of homeopathy, emphasized the role of the scientific and worldview substantiation of the training of doctors in homeopathy. The audience was greatly interested in the reports of Doctor of Medical Sciences N.M. Titieva "Pharmacoeconomic aspects of homeopathic therapy" and Doctor of Pharmaceutical Sciences O.A. Korvyakova "The official status of homeopathy in different countries of the world."

Interesting aspects of scientific research in homeopathy were highlighted in the reports of famous Russian scientists V.A. Vorobieva, V.I. Zhuravleva, L.N. Kuznetsova.

Prominent Russian homeopath L.E. Lurie summarized her experience in a report on a new approach to the selection of the most similar homeopathic medicine.

A total of 54 reports were presented on various homeopathic sections treatment methods and homeopathic pharmacy.

On the final day of the Congress, after a lively discussion, a resolution was adopted, which is published in this issue of the journal.

RESOLUTION

II RUSSIAN HOMEOPATHIC CONGRESS

The II (III) Russian Homeopathic Congress notes that in the period since the previous Congress, homeopathy in our country has received further dynamic and purposeful development. The implementation of a number of organizational measures, the deepening of scientific research, the improvement of the training system in the field of the homeopathic method of treatment and homeopathic pharmacy, the expansion of the volume and forms of participation of homeopathic physicians in the activities of the general medical network allowed to significantly increase the authority of homeopathy, to a certain extent to overcome mistrust of it on the part of academic medicine, to more fully meet the needs of the population in the provision of homeopathic medical care.

The past period was marked by a significant increase in the production of domestic homeopathic medicines, especially complex medicines, and the entry of Russian manufacturers into leading positions in the homeopathic market.

At the same time, the Congress states that the successes of Russian homeopathy would be more significant if the state and public organizations responsible for the development of homeopathy more actively and consistently participated in the implementation of the decisions of the I (II) Russian Homeopathic Congress.

The activity and influence on the state of affairs of the Expert (Coordination) Council on Homeopathy at the Ministry of Health of Russia has decreased. The Homeopathy Works Council was self-liquidated. In the work of the majority of public homeopathic associations, homeopathic organizations, there is a certain lethargy, closure on internal problems, withdrawal from the solution of common tasks for the development of homeopathy in the country.

CONGRESS RESOLVES:

1. Recognize the work of state, public and other medical organizations for the development of the homeopathic method of treatment in the country and homeopathic pharmacy are generally satisfactory.

2. The Expert Council on Homeopathy at the Ministry of Health of the Russian Federation to complete in this year, work on the draft order of the Ministry of Health of Russia "On measures for the further development of homeopathy in the country" taking into account the proposals made by the delegates of the Congress.

3. The Expert Council on Homeopathy at the Ministry of Health of Russia to finalize and to submit to the Ministry of Health of Russia for submission to the State Duma proposals on amendments and additions to the Federal Law "On Medicines", taking as a basis the proposals of the Congress delegates aimed at creating a legislative basis for the further development of homeopathy and preventing the leaching of inexpensive homeopathic medicines from the pharmaceutical market,

4. The Expert Council on Homeopathy under the Ministry of Health of Russia as a body in which almost all state, public and other homeopathic organizations are represented, by the end of this year, initiate the creation of the International Union of Homeopaths with the participation of public homeopathic organizations and homeopathic doctors from the CIS and neighboring countries.

5. Recommend FNCECTMDL of the Ministry of Health of the Russian Federation, public and other to homeopathic organizations by the end of this year to become the founders of the Homeopathy Development Fund.

6. To establish the Day of Russian Homeopathy. Instruct the Expert Council on homeopathy for The Ministry of Health of the Russian Federation to determine the optimal date for the annual Day of Russian Homeopathy. State, public and other homeopathic organizations to coincide with this event holding scientific conferences, exhibitions and other events. To consider the main goal of the Day of Russian Homeopathy to be all-round propaganda of its achievements among the medical community and the population.

7. Consider it expedient to amend the numbering of Russian homeopathic congresses by removing the serial number in brackets. In this regard, to name the last Congress as the II Russian Homeopathic Congress.

8. Conduct the next III Russian Homeopathic Congress in 2007 in Krasnodar Territory.
