

Scientific foundations and practical perspectives of homeopathy
and electropunctural diagnostics

Identification of causal factors and pathological consequences of their impact on various levels of the body's functioning is the main task of diagnostics. Treatment should help to eliminate the causative factors that led to the disease from the body and normalize the physiological processes disturbed as a result of their influence at all levels.

It is known that bacteria, viruses, parasitic and other microorganisms are the causative agents of acute diseases. Depending on the severity of the pathological process and the natural capabilities of a particular organism, toxins and decay products of pathogens of an acute illness may remain in the cells or on the cell membranes of damaged organs and systems.

The undoubted practical results of electroacupuncture diagnostics and homeopathic treatment, on the one hand, and the lack of convincing scientific foundations, on the other hand, are the reason for the controversial attitude towards such areas of medicine.

For more than seven years, in close collaboration with specialists, the author has devoted to the study and analysis of modern scientific facts in the field of quantum wave physics, quantum chemistry, protein physics and other branches of natural science. Experiments using the method of electropuncture diagnostics and drug testing also helped to find answers to many questions. The results of the experiments were demonstrated to the leading specialists of the Research Institute "Polyus" (Moscow), the Research Institute of Robotics and Technical Cybernetics (St. Petersburg). While acknowledging the facts, specialists in theoretical and applied physics admit that they are unable to explain these phenomena, nevertheless, they did not note contradictions in the considerations expressed by the author.

The topic touched upon is difficult to comprehend, and therefore it is necessary, first of all, to introduce universality in the terminology, which is used in discussions and in scientific articles devoted to the theoretical foundations of such methods. The established fact is the existence of a nuclear field, an electric field, a magnetic field, an electromagnetic field and a gravitational field. All these fields and their quanta (electron, proton, photon, etc.) have wave properties, and waves have both energy and information characteristics.

Additionally, there is no need to introduce such concepts as "energy field", "information field", "information waves", etc. Since all fields have a torsion component, the concept of "torsion field" loses its scientific relevance, although the study of this component is of undoubted interest. The meaning of such concepts as "lepton field", "subtle energy", etc. is not visible either.

As is known, an electromagnetic field arises around a moving charged particle. In nature, including atoms and molecules, there are no stationary charged particles, therefore it is more correct to use the term "electromagnetic interaction of elementary particles" instead of the term "electrostatic interaction". The known properties of waves - to be modulated - the ability to fix and transmit energy-informational (frequency-amplitude) characteristics, as well as the specificity of the results of their interactions (constructive or destructive interference), depending on their characteristics, underlie energy-informational methods of diagnosis and treatment. The only question is how exactly the energy and information parameters of the wave characteristics of the used field correspond to the set goal.

Having built a logical series of scientific facts from different areas of natural science [2; 3; 5; ten; 11], the results of the analysis of experimental data, carried out jointly with specialists and independently, I put forward a hypothesis in which an attempt is made to answer the basic questions of homeopathy. It is assumed that it is precisely the energy-informational characteristics of electromagnetic, acoustic and other waves, specific for the molecules of plants, minerals and other objects used as raw materials, that correspond to the concept of "life force". The coincidence of the wave (information) characteristics of the photon with the absorption spectrum of the atom makes the energy (force) of the photon a "life force" for the atom of the corresponding chemical element. For an atom of another chemical element, the energy of this photon will be only force, but not "vital",

The potentiation process leads to the rupture of intermolecular and intramolecular bonds, while new bonds arise with the molecules of the substance used as a drug base. Bonds (covalent, ionic, hydrogen, etc.) are known to be electromagnetic interactions between oppositely charged particles and / or parts of molecules [11]. When some bonds are broken, both acoustic and electromagnetic waves arise, and possibly other radiation with specific energy-informational characteristics, which modulate the bonds arising at the same time with the molecules of substances used as a basis. Wave characteristics of electromagnetic interaction, as a result of which intramolecular and intermolecular bonds arise,

There is a molecular electrostatic potential (MEP) around the molecules [2]. This potential is a field and also has wave characteristics specific to each molecule. MESP is caused by delocalized electrons that are in constant motion. The interaction of molecules has the character of wave interactions, that is, the phenomena of constructive or destructive interference are possible, which can lead to their structural and functional changes when the frequency characteristics coincide (if the force turns out to be "vital"). It's obvious that

the mechanism of action of homeopathic medicines consists in constructive interference (resonance) or destructive interference arising from the similarity of the wave characteristics of the MEP of homeopathic medicines and the wave characteristics of biomolecules or disease-causing molecules. Constructive or destructive interference can lead to a specific response - to the disintegration of disease-causing molecules and / or to the activation of molecules that help restore homeostasis, as well as take part in the immune response, etc.

So, the factors of specific properties transmitted in the process of dynamization are the wave characteristics of MEP and chemical bonds. The carriers of these energy-informational characteristics can be electromagnetic, acoustic and other waves arising from the rupture of bonds, as well as charged particles (electrons and protons), photons and ions. The "vital force" is fixed in the connections arising in the process of potentiation in the form of modulations of their wave characteristics. The result of the therapeutic action is due to constructive or destructive interference, which is possible only if the wave characteristics (frequency, phase, etc.) of intramolecular bonds and / or MEP of interacting molecules are similar.

Practice has shown that the law of similarity is of great importance not only in treatment, but also in diagnosis. The study of the dynamics of electrical conductivity (EP) in biologically active points (BAP) with testing of etiological nosodes makes it possible to identify causal factors that led to various chronic diseases; by testing pathomorphological nosodes, it is possible to establish the nature of the pathological process. The method is of great help in clarifying the mutual compatibility with the simultaneous appointment of several homeopathic medicines, as well as the compatibility of combination therapy with chemotherapeutic agents [1; 12].

In the development of complex homeopathic medicines and food supplements to optimize combined therapy with allopathic basic drugs, the author's modification of the method for studying the dynamics of EP indicators in BAP with drug testing is used (R. Voll's method).

It is known that the indicators of EP BAP have a physiological corridor (norm). In pathologies, these indicators deviate from the norm to varying degrees [1; 4; 6; 7; eight]. Literature data, the results of their own research and the practical work of many specialists demonstrate that therapeutic agents, during contact with which the EP BAP indicators improve in the subjects, have a positive therapeutic effect on these patients. In cases where the EP indices do not change upon contact with the test drug, there is no therapeutic effect, and if the EP BAP indices worsened, then side effects are often noted. Similar results were obtained in our studies when comparing the test results and the effectiveness of allopathic remedies in 78% of cases, homeopathic remedies and nosodes - in 93% of the subjects.

During the simultaneous testing of several homeopathic preparations, the dynamics of the BAP electrical conductivity reveals mutual compatibility or incompatibility. The compatibility of a complex of homeopathic medicines and allopathic medicines that are used in the basic therapy scheme has been studied

also by testing. If incompatibility was revealed, then the component creating the energy-informational conflict was excluded from the complex preparation, that is, the composition of the complex preparation was optimized in relation to the basic therapy. When developing food supplements for combined therapy, their compatibility with basic therapy and a homeopathic complex preparation is being investigated.

The method of energy-informational diagnostics with drug testing also allows at the development stage to optimize the composition of a complex homeopathic preparation, biologically active food additives and combined therapy of a specific nosology. The method can be useful in clinical trials of pharmacological drugs and a valuable tool in the research and standardization of homeopathic medicines, nosodes, energy-informational remedies and dietary supplements.

The strategic direction of the EDAS Holding is the integration of homeopathy with academic methods of treatment. An important aspect in the combined use of homeopathic and allopathic medicines is their mutual compatibility. The only method for identifying the mutual compatibility of both different homeopathic medicines with each other and homeopathic medicines with allopathic medicines is electropuncture diagnostics with joint testing of various therapeutic agents.

Clinical trials of medicinal products are demanding and costly. A preliminary study of the mutual compatibility of various components of the treatment process can serve as a guarantee of positive results.

Thus, a study was carried out on a group of patients diagnosed with hypertension, taking drugs Enap, Kapoten and Atenalol.

The measurements of the initial parameters of the EP in the BAP of the vascular meridian and the meridian of the heart were carried out. Then, one of the basic drugs was tested in conjunction with various complex drugs EDAS (alternately) with hypertension in the indications. After the identification of drugs that improve the initial parameters of EP, studies of compatibility with dietary supplements and bioenergetics were carried out.

Similar studies were carried out with each basic drug separately and in different combinations. The test results showed the following.

1. For combined therapy with the basic drug "Kapoten" can be used one of the complex homeopathic preparations: "EDAS 106", "EDAS 906", "EDAS 135", "EDAS 136", "EDAS 956" together with "Kaskorutol EDAS".

2. For combined therapy with the basic drug "Enap" one of the complex drugs can be used; EDAS 106, EDAS 906, EDAS 136, EDAS 116 and + Kaskorutol EDAS.

3. For combined therapy with the basic drug "Atenalol" can be used one of the preparations: "EDAS 106", "EDAS 906", "EDAS 136", "EDAS 135", "EDAS 956" and + "Kaskorutol EDAS".

The results of clinical trials conducted on the basis of the sanatorium

"Otradnoe" in the Kaliningrad region, showed a significant increase in the effectiveness of treatment with the combined use of basic drugs with complex homeopathic drugs "EDAS" and dietary supplements "Kaskorutol EDAS".

Joint testing of the drug "EDAS-137" with allopathic drugs showed a decrease in its effectiveness. This drug is optimal in the form of monotherapy after relieving exacerbation of hypertension and for the prevention of crises.

Thus, diagnostic and treatment methods based on the use of the specificity of the result of wave interactions of molecules in cases of similarity of energy-informational parameters of their MEP and / or intramolecular bonds have both practical and scientific research prospects, especially for the optimal integration of various methods of healing.
