

Modern trends in the development of energy information therapy

Introduction

Currently, the health care system is experiencing a rapid growth of various methods of treatment - allopathic, homeopathic, EM, resonance field, herbal medicine, physiotherapy, traditional folk medicine and healing [1, 2].

The question arises of how to properly use this huge arsenal of knowledge, means and methods for a doctor to help patients. Specificity of the rhythm of life

and work in modern cities-megalopolises not only dictates its own requirements for the lifestyle and nutrition of people, but also leads to the need to actively use various kinds of physiotherapeutic devices and procedures, nutritional supplements and fortifying agents (immunomodulators, lactobacillins, kurunga, yogurt) to resist aggressive action of the urban environment. An important role in this problem is played by energy-informational therapy (EIT), which has recently become widespread in the Russian Federation and abroad [3].

But, as experts rightly point out, a careful methodically correct approach to EIT is needed so that it does not become a "Pandora's box", revealing which we get a whole range of complex problems of a medical and humanitarian nature.

[4, 5]. It should be remembered that "The human body is a perfect harmonious whole, created by nature, each system of which is in constant dependence on other systems, and when one of them is damaged, the whole organism responds" [6].

Energy Information Therapy at the Quantum Level

The widespread development and spread of EIT is associated with many factors: first, it helps the body to resist the aggressive action of the surrounding urban environment using one of the most effective methods of self-defense - the activation of the protective immune forces of the body itself; secondly, it has greatly expanded the arsenal of therapeutic and prophylactic drugs and remedies against a wide range of diseases by creating their electronic copies and various nosodes; thirdly, she discovered new mechanisms of action of therapeutic agents and methods of their introduction into the body of a sick person; fourth, and it is very important to note, she contributed to the introduction of centuries-old traditional methods of treatment, such as zhen-chiu therapy, homeopathy,

This is based on the provisions that the human body at the elementary level is provided with various physicochemical reactions and various kinds of atomic bonds and electron-proton ensembles. Consequently, when considering deep-seated mechanisms energy-informational preparations, the attending physician must clearly understand

transformations occurring with the drugs and means of influence on the body and take into account their physicochemical and biochemical properties and the specificity of the therapeutic action. New methods and methods of treatment require the doctor to understand how these directed actions of therapeutic agents occur in a complex and harmonious human body. EIT is associated with the primary, quantum level of organization of the human body and the specific interaction of tissue, cellular and subcellular structures.

Conceptual Foundations of Energy Information Therapy

An important task has always been and remains in medicine - to help a sick person cope with his disease in the shortest possible time. This problem was solved by doctors from different countries of the world many centuries ago and has not lost its relevance at the present time, despite the huge arsenal of medicines and a method of treatment. Studying

and conducting EIT, one should not reject the centuries-old experience of previous generations of doctors, considering it archaic and completely outdated. Their experience is based on deep knowledge and insight and should be an unshakable foundation for modern doctors, just as the usual change of day and night or seasons occurs.

Exactly like this strictly individual the approach to the patient is reflected in the work of Akaeva T.V., Gotovsky M.Yu., Mkhitaryan K.N., which states: "The procedure for formal standardization of the methods of the therapy used also cannot be transferred to experiments comparing energy-informational methods ...

because, as a rule, does not lead to the choice of the same drugs for patients

with the same nosology or at the same stage of therapy ... This is due to the fact that energy-informational and pharmacological methods use different in relation to each other nosology scales, disease severity criteria and prognostic criteria "[29. S. 33-34; italics by authors. HELL.]. Allopathic medicine does not take into account the individual differences of people, but follows, as the main criterion, only the presence or absence of the patient's tolerance of the given medicine. No one would deny the critical role of antibiotic use in acute conditions or in the event of pandemics. Allopathic remedies are very important for relieving not only individual symptoms (migraine headaches, colds, etc.). But also with massive infections of various origins. But the use of antibiotics in general conditions of human health disorders is not justified, since it introduces a sharp imbalance in the coordinated work of functionally important organs and systems of the human body. It is important to emphasize that this feature is well understood and emphasized by pharmacologists themselves: "... But it is not always taken into account that most drugs have a diverse range of effects on the functional systems of the body, the clinical manifestations of which are characterized by side effects of drugs" [30]. Pathogenetic side effects are subdivided into the following subgroups: concomitant undesirable pharmacological, toxic, allergic effects and

drug addiction. Pharmacologists note the following: "The widespread use of antibiotics over a 30-year period has made it possible to identify the variety of their side effects and develop measures to combat it "and emphasize the following:" Multiple steadiness microorganisms ... Prevention and treatment of allergic reactions during antibiotic therapy "[31; highlighted by me. HELL.].

Many centuries of experience have been accumulated, enabling the doctor to correctly navigate in the ocean of complex physicochemical and biochemical - biophysical systems and their connections in the human body. In practice, this is revealed when people are divided according to typological and constitutional-functional characteristics (miasms), the number of which varies from 5 (homeopathy) to 7 or more (eastern methods of diagnosis and treatment). Before starting treatment, the doctor should determine constitutional features and nature of the underlying disease in the patient, meaning by this typological features of a person - his so-called miasm. It should be recalled a brief description of this concept, introduced by the founder of homeopathy S. Hahnemann: "the term miasm in its homeopathic understanding means infection and type response" [fifteen. Matison A.]. The following miasms are distinguished in homeopathy: psora, sycosis, syphilis, tuberculin, carcinosine. As the well-known expert on BRT, Ph.D. N. Kempe, "Miasm is a combined concept ... Miasms are a natural consequence of life ... it is a natural necessary component of human existence ... it is deep a complex all-encompassing phenomenon ... this is the payment of humanity for evolution ... Miasmatic treatment has a great future, although a lot of work will have to be done in the development of appropriate methods "[16. P. 93].

This phenomenon should be given special attention, since it is the primary basis of any etiological treatment for the following reasons: firstly, it is the basis for dividing people into types their individual characteristics in terms of metabolism and the nature of responses to the disease and, secondly, forms the basis of their psychophysical characteristics, fundamentally important for the correct subsequent treatment of a sick person. Classification of sick people by types (types) of miasms is the most important factor in the treatment of any disease, since it includes hereditary the burden of the body and the influence of the environment on a person. Applied kinesiologists point out this directly: "Constitution - as a set of relatively stable morphological and functional (including mental) properties of a person, due to heredity, as well as long-term and (or) intense environmental influences "[17, 18]. In this regard, it should be noted the wide distribution of various kinds of food biologically active additives (BAA), which help the body to raise the activity of the immune system, ensure the elimination of toxins and thereby reduce the aggressive influence of the urban environment [25].

Researchers rightly note the important role of the nervous system in creating a constitutional type and its responses to therapeutic effects. It is appropriate here to quote the words spoken in the work of the psychologist Yu.A. Storozhenko " Dissimilarity of typological properties indicates differences not in degree

perfection of the nervous system, and the originality of its capabilities" [nineteen]. As the well-known physician - one of the founders of homeopathy G. Köhler noted in his time: "The constitution is an innate and acquired mental, mental and somatic organization of a person.

It is determined by the structure of the body, mental and emotional makeup and the way of responding to internal and external stress "[22. P. 166]. He emphasized the fundamental importance of this provision: "Constitutional predisposition, constitutional readiness and virulence the pathogen are in interaction "and added:" Chronic miasms are a reality that has been proven "(p. 170. Ibid.). If we consider the types of constitutional characteristics of people, such as temperament, determining the reactivity of a person (choleric, melancholic, phlegmatic, sanguine), then the words of G. Köhler, spoken by him at the time, become clear: "Biographical history, real status, well-being and constitutional signs together provide the material that is necessary for the choice of drugs for a chronic disease "and explained what was said:" It is necessary to take into account the role diathesis - laid down in constitution readiness for certain diseases "[22. P. 165; highlighted by me. HELL.].

Experts in the field of oriental medicine note: "... determination of the constitutional type of a person is the main principle of diagnosing people

and the supranosological principle of prevention and treatment "[21]. This work gives a figurative description of constitutional types ("mucus", "heat", "wind", etc.) and their classification. We pay so much attention to the basics of constructing and classifying constitutional types of a person in different medical treatment systems and methods of exposure for the simple reason that, with all their novelty in the methods and techniques for conducting EIT, it is necessary to take into account the indicated individual features of the human body. EIT is a special type of resonance-field treatment, in which, in addition to various kinds of EM methods of diagnosis and treatment, EM resonance-modulated frequencies are given, recorded on homeopathic crumbs from different levels of organization of living matter.

This allows you to influence at the deepest levels of the structure of the human living system - its organs, tissues, cells and organelles, and thus selectively affect certain functions of the body. The motto of EIT specialists should be: "Treat not the symptoms, but the manifested disease behind them!" And here it is appropriate to recall the words of G. Köhler: "There is no single way of knowing all cases of a disease for all homeopaths. The study of the disease and the search for a drug should be individual in each case ". And then he explains what was said: "Our task in homeopathy is always to make a suit to order. " There are plenty of ready-made dresses everywhere. The third commandment of homeopathy is strict individualization each case "[22. P.51 - author's italics; highlighted by me. HELL.].

A clear example of the validity of these words can be the scientific and practical work of A. Mathison on EIT of elderly people, seriously ill, in whom "... very little vitality remains, and biological indices and adaptation reserves are at the limit [5. P. 96]. In his work, Dr.

A. Mathison shows the difficulties in such patients arising from the prescription of medications according to the miasmatic likeness: "Practice shows that almost any person has combination various miasms in varying degrees of their manifestation, which significantly complicates the selection of a dynamized drug capable of curing a patient" [5. P. 95; my italics A.D.]. It is also very important here that his remark regarding the specifics of the treatment of this age group of patients: "... the less often the intake of the correctly selected drug, the better its therapeutic effect" and continues: "... the resonance scale of connective tissue developed by Dr. M Shraibman (when determining it at the third level of ART +). In this case, Dr. A. Mathison considers it correct to choose the right drug according to the classical homeopathic scheme or to use the selection of an element in the electromagnetic therapy mode. At the same time, he emphasizes: "It is important to remember that a drug found in this way

must be completely homeopathic to neutralize all previously tested levels "(p. 97). to all miasms of the patient and pathological indicators of all

But time makes all its changes and amendments, and this applies equally to the evolution of the concept of a constitutional type. When analyzing the constitutional type, one can see a certain progress and its development from the standpoint of modern science [15–17]. Mkhitarian K.N. and Storozhenko Y.A. introduce the concept of constitutional delusion test (CDT) on the basis of their method, which makes it possible to determine the constitutional homeopathic preparation of an individual [20]. Further development of this direction can be seen in the work of M.Yu. Gotovsky and A.V. Samokhin about the use of hardware and software of classical homeopathic practice [23], I.A. Bobrova and E.Yu. Pechnikova on the use of diagnostics by the ART method to assess specific mechanisms of homeostasis disturbance and its relationship with the mechanisms of genetic regulation [24].type of response the patient and his relationship with the outside world. " [24. P. 154; emphasis mine A.D.]

As can be seen from the above, classical homeopathy with its canons, principles and rules not only did not give way to allopathic medicine in the fight against modern types of diseases, but received new support due to the development of new methods of diagnosis and treatment in EIT. But time makes all its changes and amendments, and this applies equally to the evolution of the concept of a constitutional type. When analyzing the constitutional type, one can see a certain progress and its development from the standpoint of modern science [15–17].

Alternative methods and approaches in EIT

In recent works on EIT, studies have been highlighted on the important role of individual systems that play an important role in the functioning of the body: the immune system [25, 27], the lymphoid tissue of the small intestine [26], and the psychoneuromunnoendocrine system [28]. It should be noted that EIT is based on three fundamental healing systems- zhen-tsyu therapy

(including acupuncture points, meridians, qi-energy, yin-yang types), homeopathy according to S. Hahnemann (miasms, constitutional types, potencies, affinity of drugs and types of diseases) and methods ART and BRT with a complete substantiation of the most important concepts based on modern science [9–14]. As E.G. and T.S. Avanesov: "... the use of both endogenous and exogenous bioresonance therapy in the process of treating patients (both children and adults) is characterized by the following features: physiological therapeutic action, harmlessness, painlessness, absence of side effects, and most importantly - always a purely individual approach to the patient [12; highlighted by the authors. HELL.]

From what has been said, it is clear that EIT opens up wide horizons in the therapeutic and diagnostic practice of modern medicine, but, on its part, requires from specialists full and deep knowledge of these three areas of knowledge. Doctors and specialists from various fields of science, technology and medicine come to this area of knowledge, who have not previously studied homeopathy, reflexology, automation and radio electronics, programming, and therefore EIT should be in the hands of specialists who have mastered the laws, postulates and rules of these so different sciences and time-tested knowledge and modern medical practice.
