

Experience with the use of the full resonance scale of connective tissue
and scales State in practical work using the capabilities of ART

In recent years, many of our colleagues in their reports began to note that the state of our physical body is influenced by the so-called subtle physical fields. And if the physical body is relatively healthy, and there are violations in the fine-field structure, then a person has complaints that cannot be diagnosed by methods of academic medicine. Possibilities vegetative resonance test allows you to determine the effect of these fields on the functional state of our body.

The algorithm proposed by me for a step-by-step improvement in the quality of health (physical, emotional, spiritual), which has developed over the past few years, has been tracked in dynamics on a large number of patients, and takes into account this component of our being.

Some of the stages were consistently reflected in the materials of the conferences for 2005, 2007, 2008. In this post I want to give a generalized picture of the whole algorithm.

There are three of our components: body - soul - spirit. I believe that you need to start working with the physical body. "In a healthy body healthy mind!"

Work on physical body consists of several steps:

Step 1 - preparation for miasm therapy, usually in two steps. At the first admission, we stop the destructive process on cell membranes

(1 diagnostic level of ART +), at the second appointment we work at the level of the cytoplasm of cells (2 diagnostic level of ART +).

Step 2 - therapy of miasms, i.e. work at 3-4 diagnostic levels of ART +.

Step 3 - deep mycoses therapy, very often, immediately after therapy, drainage is selected for the mental body.

With these steps of therapy, it is possible to help the patient to correct all the problems acquired in this life, i.e. harmonize the lower 4 subtle bodies - physical, etheric, astral and mental. These three steps of therapy take about a year of work, then the process of restoring the physical body continues for several more months - a complete replacement of all structures of the body. But you can already start working on a psycho-emotional level.

Work on mental level (problems of the Soul) also goes into several stages:

Step 4 - working with karmic space (usually goes in two steps). With this step, we harmonize the disturbances in the 5th subtle body - karmic or causal.

Step 5 - working with the atmic level, installing a magnetic center (usually in two steps). With this step, we harmonize the disturbances in the 6th and 7th subtle bodies - buddhic and atmic.

Step 6 - working with the Constitutional Delusion Test, i.e. determination of the main life lesson.

These steps of therapy also last for about a year. There is a deep correction of the emotional component of our being, a person evaluates the surrounding events more objectively, ceases to be nervous over trifles.

The next stage is to work on spiritual level. It also goes in a few steps:

Step 7 - taking a person to an endless field, i.e. a person becomes a full-fledged part of a single energy organism. It works through the Vipera D400 pointer.

Step 8 - removal of sensitivity to all negative influences from the outside. Additional control criterion at this stage Chernobyl precipitation D200.

Step 9 - alignment of the force fields of the doctor and the patient. An additional control criterion at this stage is Chrommet. D800.

Step 10 - identification of foci and their layering (according to LB Makhonkina). This is a work through the index Head foci.

11th step - harmonization of human polarity. This is work through the Yin-Yang state pointers.

Step 12 - removal of a very strong degree of vegetative burden. This is work through the pointer Talamus \$ 5.

These steps of therapy take about one and a half years. They are related to our destiny. A person comes to deep inner peace, finds his place in this life. Begins to understand the laws of the universe, its significance not only in society, but also on the scale of the Universe. Comes to

a state of unconditional love and God's commandments.

Next, I would like to dwell on the possibilities of ART when working with this algorithm. There is an expression: trust, but verify! Therefore, I believe that it is impossible to work blindly in such a delicate matter as the Soul and Spirit. The control criteria that, in my opinion, best reflect the complete overall picture are the Full Resonance Scale of Connective Tissue and the Diagnostic Scale "Condition".

In 2007 M.M. Schraibman proposed a complete resonance scale for connective tissue (TSS). When comparing the stages of therapy with this scale in practical work on a large number of patients, complete coincidence was noted and the sequence of recovery processes was tracked. This scale allows us to clearly control the work on our two components - Body and Soul. This coincidence was noted in the report "Experience with the use of the full resonance scale of connective tissue" in 2008.

At a practical seminar after the conference in 2008, M.M. Shraibman proposed the Diagnostic Scale "State" (SC), represented by complex resonant-frequency drugs that record the general state of the body at the physiological, psychological and spiritual levels. When comparing the stages of therapy with this scale in practical work on a large number of patients, complete coincidence was also noted and the sequence of recovery processes was tracked. AL allows you to clearly control the work on all three of our components - Body - Soul - Spirit. The implementation of all steps of therapy according to the proposed algorithm allows a person to be brought from the SHS I-1 index to the SHS VII-4 index. The result obtained is stable for a long time. I continue to keep under the supervision of patients, who have achieved this result. I will present the results obtained at subsequent conferences.

Below are the statistical data on the number of patients treated according to the proposed algorithm.

In total, during this period, a four-level diagnosis of 1117 people was carried out.

By age, the groups were distributed as follows.

The first 7 places in descending order are occupied by the dominant miasms of poliomyelitis viruses (22.7%), rubella (12.9%), cytomegalovirus (12.7%), hepatitis (8.8%), fungoid fungus (5.6%), chickenpox (3.1%), tuberculosis (3.1%). That is 68.9% of the total.

In 229 cases, which amounted to 20.5% of the total number of examined, at the fourth level, only psycho-vegetative loads were tested, which could be eliminated with drugs from the Bach Flowers group, Systemic Spiritual Adaptants, Medpharma (psychosocial load group), drugs from the Guna company ("Floweplex").

In 215 people, which accounted for 19.2% of the total number of those tested, at the fourth level, miasm and psycho-vegetative loads were determined, which were removed by Viper 2000 in combination with preparations from Bach Flowers, psychosocial loads "Medpharma", "Guna" ("Floweplex") etc. Moreover, the psychological drug served in this case as a drainage.

Over the past year, there has been a noticeable increase in the number of patients in whom only psycho-vegetative loads were determined at the fourth diagnostic level. Solving these problems with drugs from the Bach Flowers, Systemic Spiritual Adaptants, Medpharma, and Guna groups, we managed to remove the auto-aggressive program in the DNA (see Table 4).

Of the 158 people tested over the past year, 135 people went through just this option. This amounted to 85.4% only over the past year.

Analyzing the diagnostic picture, there is a clear predominance of hereditary burden (96.8%).

For level 4 therapy, I used the following drugs: Spec. Viper 2000 - 870 cases (77.9%); FM chords - 17 cases (1.5%);

Nosode - 1 case (0.1%); Bach flowers - 62 cases (5.5%); Systemic Spiritual Adapters - 17 cases (1.5%); Psychosocloading Medpharma - 60 cases (5.4%); Guna's Flowerplex - 41 cases (3.7%); Other drugs - 49 cases (4.4%).

After removing the miasms, I conduct therapy for deep mycoses.

A few figures on the results of antifungal therapy. In total, 740 people passed this stage. Resonance frequency therapy was performed in 659 sessions. At 81 sessions, it was possible to remove the fungal infection by selecting a ready-made preparation from the selector.

General statistics on the proposed algorithm

The therapy of miasms of 1117 people was prepared and carried out: 740 of them were treated with deep mycoses; 630 of them received therapy for the karmic space; 598 of them worked at the atomic level; of them, work was carried out to install a magnetic center 558 people; 497 of them carried out work on KDT; 414 of them worked through Vipera D400; of them, work was carried out to align the force fields of 320 people; 228 of them worked through the index head foci; of them YIN-YANG harmonization 222 people; of them work was carried out through the Talamus \$ 5. 75 people
