The results of the training of medical specialists, using methods of electropunctural diagnostics and bioresonance therapy

in the Armed Forces of the Russian Federation: to the 10th anniversary of the method of electropunctural vegetative resonance test V.B. Ivanov, V.V. Kulikov, V.M. Pospelov

(State Institute for Advanced Training of Doctors of the Ministry of Defense of the Russian Federation, Moscow, Russia)

The recruitment of the Armed Forces of the Russian Federation with a healthy contingent is still a serious problem, which is due to the deterioration of the mental and somatic state of health of adolescents. Such socially significant diseases as drug addiction, substance abuse and associated HIV infection, viral hepatitis, etc., are widespread among people of military age.

In 1999-2001, at the Center for Intelligent Medical Systems "IMEDIS" together with the Central Exhibition Complex of the Ministry of Defense of the Russian Federation, MMA im. THEM. Sechenov, developed and in 2002 introduced into practice the "Method for identifying persons who use drugs" on the basis of ART.

In 2002, within the framework of the Federal Target Program "Comprehensive Measures to Combat Drug Abuse and Illicit Trafficking", a decision was made to centrally procure from the federal budget and equip all assembly points of military commissariats of the RF subjects and a number of military medical institutions with this equipment. Since 2003, this decision has been implemented. On the basis of the State Institute for Advanced Training of Doctors of the Ministry of Defense of the Russian Federation (GIUV of the Ministry of Defense of the Russian Federation), a planned training of specialists from military commissariats and military medical institutions was organized on the cycle "Vegetative resonance test: identifying persons who use drugs. The basics of bioresonance therapy". To date, 453 medical specialists have been trained under this program.

From January 2003 to November 2010, the GIUV of the Ministry of Defense of the Russian Federation conducted training: to work on the "Mini-Expert-DT" equipment with an electronic drug selector: 85 medical specialists from military commissariats of the constituent entities of the Russian Federation, 77 - from military medical institutions, 7 - from military medical training institutions (total - 169 doctors); for work on the hardware and software complex (AIC) "IMEDIS-EXPERT": 201 medical specialists from military medical institutions, 5 - from the medical service of military educational institutions, 5 - from military medical schools, 23 - from military commissariats (total - 284 doctors).

In addition, in order to identify persons who use drugs, about 40 specialists from the Federal Penitentiary Service of the Russian Federation and the Ministry of Internal Affairs of the Russian Federation were trained.

The system of thematic improvement of medical specialists for work at the AIC "IMEDIS-EXPERT" created at the State Institute of Internal Affairs of the Ministry of Defense of the Russian Federation fully provided their initial training in the amount required for the needs of the Ministry of Defense of the Russian Federation.

By 2011, the number of specialist doctors trained to work on equipment for electropunctural diagnostics and bioresonance therapy at the Ministry of Defense of the Russian Federation exceeded 450 people, which will require mandatory

continuous annual training (taking into account the frequency of 1 time in 5 years) at least 90 listeners for 1-1.5 months on thematic cycles improvements "Vegetative resonance test. Bioresonance therapy".

The experience of practical use in the medical service of the Armed Forces of the Russian Federation of the new medical technology "The method of identifying persons who use drugs, based on ART" IMEDIS-TEST "has shown its high information content, reliability, cost-effectiveness and promising application as a screening technique.

The positive results of the application of the method in the troops and military commissariats were reflected in the requirements of the order of the Minister of Defense of the Russian Federation No. 105 of March 6, 2008 "On improving the work of military command and control bodies to counter the illegal consumption of narcotic drugs and psychotropic substances and their illegal circulation in the Armed Forces of the Russian Federation" about compulsory examination by the method of vegetative resonance test of citizens conscripted to for military service, entering the military comrade service under the contract, for training in military educational institutions, Candida showed satisfactory professional psychological selection, unsatisfactory neuropsychic stability.

Practice of use methodology on the ground shows that the potential equipment capabilities of the IMEDIS Center is far from being exhausted identification of drug users. The characteristics of the AIC "IMEDIS-EXPERT" allow using the complex to solve a wide range of

diagnostic and therapeutic tasks. So, for example, there is an opportunity to use this equipment for screening detection and treatment of other extremely relevant in military groups, including those related to drug use, hepatitis A, B, C, D viruses; more than 10 varieties of the causative agent of tuberculosis; influenza viruses, Coxsackie, chickenpox, measles, mumps, adenoviruses; diplococcus pneumoniae, pathogens

diphtheria, meningococcal infections, mycoplasma, chlamydia, shigella, salmonella, enterococci, etc.

Most effective with diagnostic and therapeutic purposes of the agro-industrial complex "IMEDIS-EXPERT" are used in 3 CVKG them. A.A. Vishnevsky, military hospitals, military educational institutions and military commissariats, deployed in the cities of Voronezh, Smolensk, Birobidzhan, Saratov, Volgograd, Novocherkassk, Ivanovo, Yuzhno-Sakhalinsk. And such doctors as: Azbarov A.A., Popova T.A., Kuzmich A.V., Vasilenko A.A., Ivanov D.Yu., Kudryavtsev V.G., Khomenko E.D., Kravtsov A N., Ivushina S.M., Mikhno N.A., Khlamova E.N. exemplify creative application of methods electropuncture diagnostics and bioresonance therapy in the performance of their functional duties.

However, due to the optimization of the structure of the military medical service, the relocation and dismissal of a number of trained medical specialists, the equipment available in military commissariats, military educational institutions and military medical institutions is not always used for its intended purpose. There is still serious work to be done to resume the training of these specialists.
