

The use of bioresonance therapy  
in the treatment of gynecological and endocrine diseases (a case from  
practice)

Patient S., 40 years old, in May 2010 turned to the medical diagnostic center "Medicine of the Future" with complaints of uterine bleeding, pain in the lower abdomen, weakness and severe skin irritation on the back of the hands, a decrease in hemoglobin to 79 in the general blood test ...

From the anamnesis: in the fall of 2009, irritation began on the hands (a small red rash), after contacting a local polyclinic, a dermatological dispensary, a private dermatologist, various diagnoses (eczema, allergies) were made and symptomatic treatment was prescribed (suprastin, flucinar, celestoderm , fukortsin, herbal medicine).

All attempts to suppress the symptoms of the disease with the help of chemical hormonal and antibacterial drugs led to suppression of immunity and a significant deterioration in the condition. New diseases have appeared that did not exist before.

In December 2009, a small rash on her hands turned into ulcers, and if the patient stopped using ointments, her hands turned into "bloody meat", she had to constantly walk in bandages, and could not put her hands into the water.

In January 2010, after acute attacks of pain in the stomach and lumbar region, the patient underwent examination at the diagnostic center of the Regional Clinical Hospital, revealed: gastric ulcer in the acute stage, deformity of the duodenum, gastritis, 2 myomatous nodes of the uterus (4 x 6 cm ), multiple polyps.

In April 2010, hysteroscopy was performed to remove uterine polyps. The gynecologist suggested removing the fibroids in September 2010. After removing the polyps, the patient was prescribed the hormonal drug Jess. With the beginning of the hormone intake, the state of health sharply deteriorated: dizziness, nausea, and rashes on the hands appeared. The attending gynecologist recommended to continue taking hormones. After a month of taking the drug, "Jess" began, uterine bleeding began, the patient was hospitalized. Within 8 days of intensive inpatient treatment, it was not possible to stop uterine bleeding completely.

The examination was carried out by the ART method on the hardware-software complex of the company "IMEDIS". The most affected organs were identified - pituitary gland, thyroid gland, right adrenal gland, ovaries, uterus. Various causative agents of diseases were identified for various organs: Pseudomonas aeruginosa, gonococci, green streptococcus.

A decision was made to restore immunity and functions neuroendocrine system, endocrine system, gastrointestinal tract, liver and urogenital organs. The first 12 sessions of bioresonance therapy to restore immunity and organ functions were carried out without the use of resonance therapy to destroy pathogens.

After 7 days of treatment with bioresonance therapy, the bleeding completely stopped, the patient stopped taking all previously prescribed

medications, dry skin of the hands decreased, cracks disappeared. Further treatment was carried out once a week. In July, the menstrual cycle recovered, the skin of the hands cleared.

After 12 sessions of bioresonance therapy, resonance-frequency therapy was started to destroy the foci of localization of pathogens. There were 15 sessions of frequency resonance therapy.

In September 2010, an operation was performed to remove the fibroids, an ultrasound scan is performed once a month, and there is no growth of fibroids.

As a result of treatment, the following improvements can be noted:

1. Uterine bleeding is absent, recovered and completely the menstrual cycle has returned to normal.
2. There are no pains in the lower abdomen.
3. Weakness and chronic fatigue syndrome no longer occurred.
4. Pain in the stomach area no longer bothered.
5. The condition of the skin on the hands is completely normalized.

According to the results of control testing, the functions and immunity of the following organs were restored: ovaries, skin, bladder mucosa, urethra, pituitary gland, gastric mucosa.

Currently, the patient continues treatment to restore the functions and immunity of the thyroid gland, right adrenal gland and uterus. The main goal of treatment is preparation for pregnancy.

As a result of the treatment of this patient by the method of bioresonance therapy on the hardware-software complex "IMEDIS", it was possible to restore the functions and immunity of the neuroendocrine and genitourinary systems, significantly improve the functional state of the organs of the endocrine system, gastrointestinal tract, liver, skin and other organs.

As a result of the treatment, it was possible to detoxify most of the organs affected during symptomatic treatment with chemical medications. As a result of detoxification, chronic fatigue syndrome and weakness disappeared, and the skin condition returned to normal. There are conditions for starting preparation for pregnancy.

The patient is very happy with the treatment results and has a firm intention to do everything possible to give birth to healthy and full-fledged offspring.

In treating this patient, our center has applied all the experience gained over the previous ten years. The treatment was carried out exclusively on the equipment of the IMEDIS Center.

No chemical medications were used in the patient's treatment. Moreover, the key to successful treatment was the correct approach to eliminating the consequences of toxic lesions caused by the use of chemical medications.

We believe that for successful treatment with bioresonance therapy, it is necessary to completely exclude the use of chemical medications for symptomatic treatment. Otherwise, the effect of the use of bioresonance therapy can be completely nullified by chemical toxins.
