

Features of the structure and function of the energy-information system man

The methods of electro-acupuncture diagnostics and bioresonance therapy are built and developed on the theoretical basis of ideas about the existence of biologically active points, meridians, chakras, on the basis of ideas about the energy (or subtle fields) that circulates in the human body and determines the state of his health. The knowledge of the meridian system is taken from Chinese acupuncture, the concept of chakras is an integral part of the Indian tradition. In other words, our today's theoretical basis consists of fragments of a large and multifaceted knowledge about the structure and laws of functioning of the human energy system, set forth in many sources of Eastern philosophical thought. Today we know about the degree of effectiveness of medicine, when knowledge about the anatomy and physiology of the human body was fragmentary and fragmentary. A study of the philosophical foundations of the Chinese and Indian teachings on the energy system shows that they consider the purpose of life and the direction of human development from different positions. The whole nature of the ancient Aryans was aimed at helping a person to realize himself not only as an earthly being, but also as a cosmic being, that is, to go beyond this mortal body and see the unity of the entire universe. Therefore, their entire teaching is built on the idea of a "triumvirate" of vital energies: Brahman, Vishnu, Shiva; mind, mind, ego; prana, tejas, ojas; vata, pita, kapha, etc. The same spiritual concept underlies the Christian doctrine of the Trinity, i.e. there is the Father, there is the Mother, and the Child appears - the third. From the moment the third appears, the whole picture of the world begins to unfold. The union of polar forces gives rise to a new quality, a new type of energy, there is a process of qualitatively new development, evolution. The Chinese in the "Tao Te Ching", in the "I Ching" also contain the concept of the Trinity of the universe. But they did not set themselves the goal of human evolutionary development. They wanted to live here and now, enjoy only this body with all its features as long as possible. It was enough for them to see the world in the Yin-Yang duality.

From the point of view of Vedic knowledge, the body contains a centralized energy system that controls and coordinates the body's activities and the processes of its energy-informational interaction with the outside world. This system is formed from the energy channels "nadis" through which energy circulates, and chakras - condensations of energy in the form of energy vortices, through which interaction with the outside world and the inner world is carried out. The nadi system consists of 350 thousand channels. Translated from Sanskrit, "above" means movement, so the circulatory, lymphatic, and nervous systems (by the way, described millennia before the Europeans) were referred to the nadi system. Acupuncture meridians belong to one of the 14 major nadi systems - paravaha nadi, in which pranic energy circulates. But the most important channels are Sushumna, Ida and Pingala.

systems. "Ida" and "Pingala" are ascending and descending currents going to the left and right of the spine, at the physiological level they create the energy-informational basis for the functioning of the autonomic nervous system. Their triune interweaving creates a system of chakras, which, at the level of physiological functions, provides an energy-informational basis for the coordinated interaction of the nerve plexuses and endocrine glands. The forces of the polar interaction of Yin energy in Ida and Yang energy in Pingala are transformed and acquire new qualitative characteristics, intersecting with a balanced flow of energy in Sushumna. This is how the variety of characteristics and functions of different chakras is born. A similar system is symbolically described by the ancient Greeks in the form of a caduceus ("staff of the messenger"), which also says that a person is a living caduceus.

If the source of the dynamic processes of movement and interaction of the energies of "Ida" and "Pingala" is the quality of these energies: energies of the same name are repelled, oppositely charged - are attracted, then the source of energy movement in "Sushumna" does not have such an understandable physical nature. Vedic texts, explaining this issue, speak of such a concept as "Sutratma" - "thread of life", "silver thread", a stream that unites all our lives, the energetic result of the diverse experience of our Soul and its plans for this life. If you translate literally "sutra" - a sacred message, "atma" - Soul. That is, it is a flow of energy that emanates from the Soul to the body, as its manifestation in the physical world. It contains the main information about the program that the Soul implements through this body in this life. Each person has his own program. Regardless of cultural and religious views, we must state that life is surprisingly generous to some people and cruel, unfair to others. Without understanding the difference in life goals and objectives, and, consequently, in the demands that life makes us, it is impossible to effectively interact with this world in all its diversity. "Sutratma" has a complex structure and a harmonious system of "feedback" with the human body and energies. All the energies of our deeds, words, emotions, thoughts and intentions create an ascending spiritual-energy flow from the body to the Soul, which is called "Antahkarana". In her writings, Alice Bailey writes about the "science of Antahkarana" - this is "a creative effort to build a bridge in consciousness between the lower analytical, knowledge-accumulating mind, soul and higher mind, the aspect of the divine" I ", the spiritual person. It is a scientific process that can be studied and practiced as a meditation technique coupled with an effort to apply spiritual principles in daily life under all circumstances. " The more the quality of the energy of the ascending flow of "Antahkarana" corresponds to the quality of the energy of "Sutratma", the more harmonious and successful a person's life is, the better his physical, emotional and spiritual health. The more the dissonance of the energies of "Antahkarana" and "Sutratma", the more severe the corrective mechanism (illness, injury, difficult life circumstances, etc.) is included in a person's life. This is a real manifestation of the idea that the hand of God is always with goodness and love extended to a person, but he must make an effort to accept

The resulting vector, formed from the interaction of the streams of "Sutratma" and "Antahkarana", we called the "channel of life". The energy content and dynamics of movement in the entire system of energy channels "nadi" depend on the full value of its functioning, and the peculiarities of the course of biochemical processes, the formation of tissue and organ structures, depend on them.

Passing sunlight, in a certain sequence, through five platonic solids made of quartz piezocrystals in combination with sound vibrations, we received a diagnosticum, which, as practice has shown, makes it possible to reveal the desynchronosis of energies in the "channel of life". Similar experiments with sound, color and light passing through various crystals made it possible to create diagnostics for "Sushumna", "Ida" and "Pingala", as well as drugs that make it possible to restore damage to the main nadis and fill the deficit of harmonious energies in the "channel of life" ... With the help of the diagnostic capabilities of ART, one can see the presence of a failure between the intentions of the Soul and the actual life activity of a person. Having picked up a drug that contributes to the creation of harmony and balance in the "channel of life", one can reveal the main idea of the failure that a person makes. By restoring the energy failure in the "channel of life" and explaining the main idea of this failure, we create conditions for the possibility of further manifestation of a person's free choice in accordance with his ability to accept and realize such information. For example, we find out that there is damage to the "channel of life", and the drug "Love for oneself" restores it. We introduce it into the circuit and carry out bioresonance therapy. At the same time, we explain to a person that the basis of his energy deficit is the wrong attitude towards himself. Having blocked the movement of the energy of love within his system, a person cannot receive it from other sources: neither from children, nor from parents, nor from a partner, nor from the world. A person does not love himself only because some qualities that are significant for him do not correspond to his own or someone else's expectations. He renounces his unique individuality, does not accept the reality that is, spends his energy on becoming someone else. But Nature, Soul created you like that, this world needs you just like that. Working on his weaknesses, self-improvement, a person does not betray himself, but guided by love for himself, he does better what he has. If a person does not love himself, he creates in himself the processes of self-destruction. It is very important to talk about this during a treatment session, then the energy, even of a fragmentary understanding, will be recorded on the BR-drug and will contribute to a deeper understanding when taking it. Work on the restoration of the "channel of life" is very often so tangible by the patient and important for the body that the need for other therapeutic actions appears only at the next session. We have a lot of patients who already feel well when an energy failure has occurred and openly say that the restoration of the "channel of life" is the main thing for which they come to us. The restoration of this fundamental energy flow often drastically changes the body's response to classical drug treatment and shortens the recovery time.

It is equally important to have a harmoniously functioning "channel of life" for the doctor.

All cases of absurd medical errors and blunders occur precisely when the doctor himself has a state of energy deficit due to violations of the basic requirements of his own Soul. An indirect indicator of this disorder is the fact that a person (be it a doctor or a patient) during testing does not hold the load with Epiphysis D26 - Epiphysis D400 / 800/2000 amplification drugs. Yuri Valentinovich Gotovsky always emphasized that a doctor-patient device is a single energy system. The founder of the ART method, Dr. H. Investigation and restoration of violations in the "channel of life", first at the doctor, and then at the patient, is the most important basis for correct diagnosis and treatment. A disease, being an integral part of life, can be a manifestation, a signal of serious deviations in a person's lifestyle or way of thinking from his life program. Then the doctor's efforts aimed at eliminating the symptoms of the disease can become the basis for the aggravation of the pathological process or transfer the energy correction to the event level.

Modern medicine today is faced with a peculiar contradiction: huge advances have been made in the study of individual biophysical and biochemical processes at the level of cells and subcellular structures, but, at the same time, there is no rational understanding of the phenomena of amazing harmony, consistency, reliability of biological systems in maintaining homeostasis and the manifestation of an amazing biological phenomenon called LIFE. But science today more and more finds a natural-scientific explanation for religious and ancient philosophical truths. To make a contribution to this good cause is the task of all physicians and researchers of the energy-informational direction in medicine.
