

## Experience with miasms

It is well known that miasms are innate toxic information passed down to us in a relay race from our closest and most distant ancestors. It is located in the DNA, in the chromosomes. It determines the quality of our entire life.

- from the moment of birth until death. If the DNA index points to minimal disturbances, then life will proceed happily. But if there are maximum violations in the DNA, then a person will be constantly haunted by a variety of intractable diseases.

Thus, a completely logical conclusion arises. In order to make the patient harmonious and healthy for the rest of his life, it is necessary to remove all existing miasms from him. That's how it is! But it is impossible to do this during the first visit, especially for an elderly patient, because, firstly, he does not have enough internal energy for this process, and, secondly, he may have the most unpredictable complications. Therefore, in order to start eliminating miasms, a preparatory period is necessary. It consists in the elimination of all external burdens: geopathogenic, electromagnetic, radioactive, external influences and, of course, mental stress. In addition, it is necessary to work with all types of infections (viral, bacterial, fungal) that are tested at the 1st, 2nd and 3rd diagnostic levels.

And finally, a patient comes to you who, during the previous sessions, removed all the tested problems at all 3 levels. The Ferrum D60 is used to test the 4th level - the DNA level. In this case, the optimal index is equal to 100 on the scale of M.M. Shraibman (many thanks to him for her!). The pathological index at this level, for example, is 46. Here I select the line "miasma" from the CDT. In the right window there is a resonance scale. In this case, the 46th index will be the filter. Through it I test all 4 miasms in turn in all potencies. Testing comes with the optimal number of ampoules of Epiphysis D26 included. All 4 miasms are tested. The next step is to select the "dominant miasm" indicator from the Schimmel's "miasms" section and use it to test all 4 miasms. The psoriasis miasm is triggered. The key problem at the 4th level is through Zn. met D24 also appears to be psoriasis. Consequently, it is he who must be removed first. But before you get rid of it, you can look at which meridians and organs it has a pathological effect, i.e. identify target organs. As a rule, they are exactly the organs with which you had to deal at the first 3 levels.

So the dominant miasm is defined. Through all its potencies in the list of homeopathic remedies I am looking for one that will not lower the measuring level. Homeopathy is also tested in all potencies. I write down the selected homeopathic preparation in the highest potency for 2-3 globules of sugar crumbs. Then I will adapt it to KMH. I check whether it will remove the desired miasm and give the optimal index, its effectiveness in high potency and, finally, determine its dose. It turns out, for example, 10-12 globules once. The patient takes this dose, after which the miasm is no longer tested.

In the next sessions, it is necessary to remove successively the remaining dominant miasms. It is dangerous to remove all 4 miasms in one session!

After the elimination of all 4 major miasms, the toxic load of DNA becomes minimal or even ceases to be tested.

But sometimes, after all these manipulations, the toxic load Intox III begins to be tested again at the 4th level. This means that in addition to the main 4 miasms, there is another one in the DNA. In these cases, all Schimmel miasms should be tested. And if none of them work, then go through all the external factors that we tested earlier. The found miasm can be removed with Vipera B or "Rheumatic inflammation" from Schimmel's FM complexes.
