

Informational homeopathic therapy is the
compensation of information in time

As a result of several years of work with patients and tests on myself, I have formed an understanding that the potency of any informational or homeopathic remedy corresponds to the time. The higher the potency resonating drug, the deeper the corresponding time in the patient's life history. The potency scale of any drug can be regarded as the time scale of this drug in the life history of the patient and his ancestors, i.e. the resonant potency range of any drug corresponds to a specific time period in the patient's past when that drug was relevant. It is even possible to determine the calendar years of each resonant potency-time period.

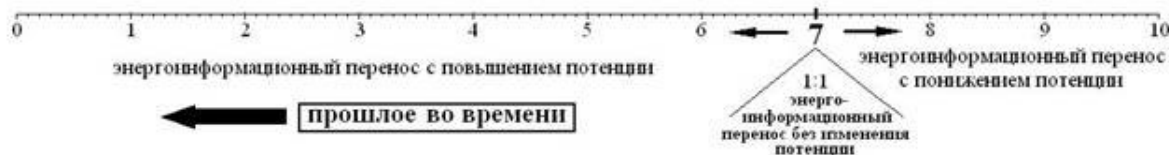
Not all drugs are homeopathic in the classical sense, there are groups of informational drugs that were not created by homeopathic dilutions and do not have classical potencies (D3, D6, D12, D30, D60, etc.). These are groups of drugs: Bach Flowers, Systemic Spiritual Adaptants (SDA), information drugs of frequencies (40 Hz, 60 Hz, etc.), colors (red, orange, green, etc.), electron-magnetic copies of the physical body patient, etc. Despite the different origins of information drugs, using the Transfer apparatus, any information placed in a direct or inverse container of the Transfer apparatus can be potentiated. Therefore, we will consider the scale of potencies not as a scale of classical homeopathic dilutions (D3, D6, D12),

Different groups of drugs have different time scales. For example, drugs from the Bach Flowers group, in comparison with all other drugs, have the most "dense" time scale and with an increase in potency to 0 there will be a correspondence to the past about 200 years. With an increase in potency to the mark 0 for drugs from the group of Systemic Spiritual Adaptants (SDA), there will be a correspondence with the past about 100 years. With an increase in the potency of the electron-magnetic copies of the physical body of a person to 0, there will be a correspondence with the past about 50 years (Fig. 2).

Let's pay attention to the fact that the patient's state in the present time for all groups of drugs is measured when the potency is lowered to the 10 mark, and not at the 7. The potency scale in the region of 9-10 corresponds to the most recent past. On this scale, it is possible to measure the patient's condition for various drugs literally by the day up to the present moment (mark 10). By measuring the state of short-term acute stress or physical trauma on a daily basis, it is possible to observe the gradual movement of any range of the drug into the past. The correspondence of the potency scale of various groups of drugs to recent times is shown in Fig. 3. There are no exact data on the potency scale for the near future for the electron-magnetic copies of the physical body; this scale roughly corresponds to the scale of drugs from the SDA series. The indication of the corresponding time range is approximate,

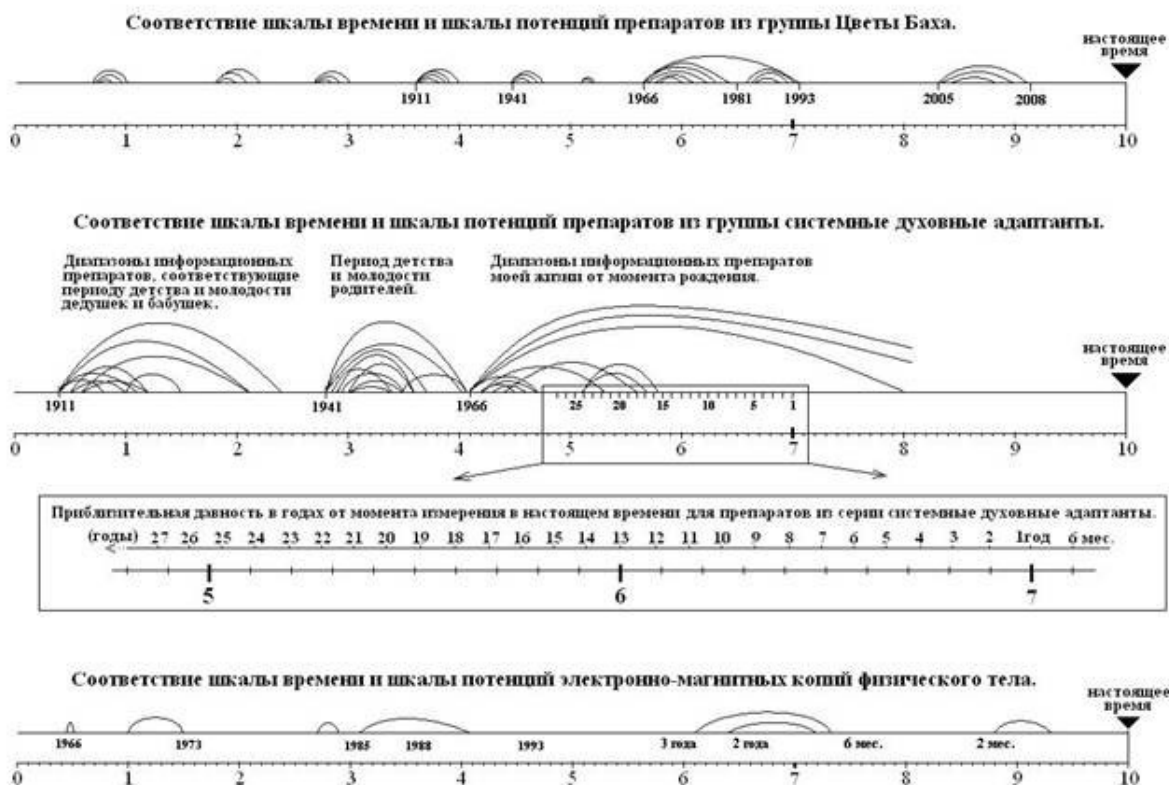
In my work, the Bach Flowers (CB) preparations and 17 SDA preparations were studied in the most detail. These drugs in the depth of time are often tested not "pointwise", but in certain intervals. Such ranges reflect deviations in the patient's mental and emotional state in a specific period of his life. Most often, the most problematic and stressful is the childhood of a person, especially for SDA. The adult period of independence, heyday and fullness of strength is usually

less problematic. With the onset of old age, there is a decline in vitality, fatigue, exhaustion, stress accumulates, and many drugs begin to be tested again. There are more CB drugs, and they reflect differently the state of mind in childhood and adulthood.

At the moment of a person's birth, the total psychoemotional state of his parents is measured deeper in time. Usually in the prime of life before childbirth, most SDA drugs are not tested. Therefore, immediately after the moment of birth, a relatively "clean" period is usually observed. With a deepening in time to the period of childhood, the parents again begin testing the ranges of drugs reflecting mental and emotional disorders. During the periods of childhood of parents and the moments of their birth, the total state of the older generation of grandparents is tested. In the same way, as in the case of parents, the most powerful mental and emotional problems are concentrated in the period of childhood. It turns out that SDA preparations are concentrated in the form of a peculiar chain of condensations, which usually correspond to the periods of childhood of generations of ancestors.



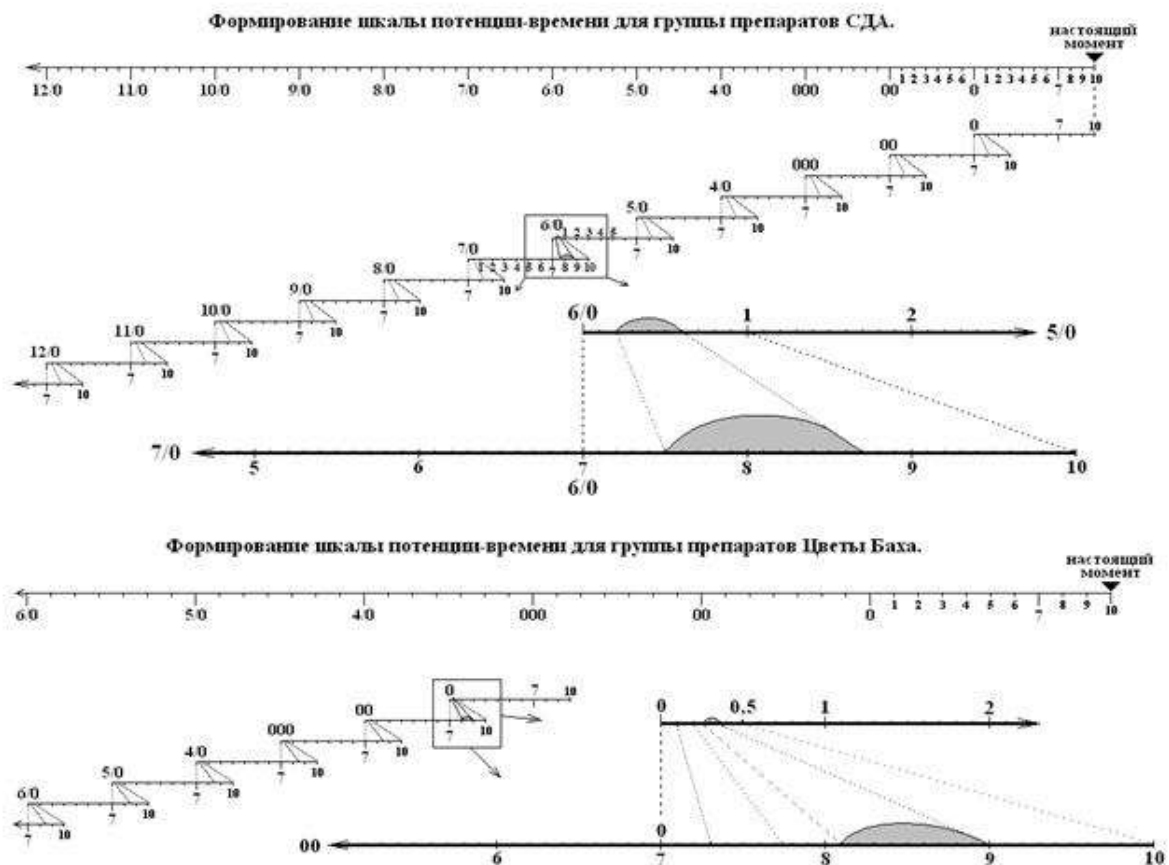

The number of human ancestors is progressively increasing (2, 4, 8, 16, 32, etc.), and when you go deeper into the past, a kind of "blurring" of the chain of negative ranges should occur as a result of their summation and overlapping in different periods of time. But, despite this, with a deepening in time for CB and SDA drugs, it is still possible to measure a peculiar chain of drug thickening, corresponding to negative impressions and emotions in the life of this person's ancestors. This negative chain usually corresponds to the childhood periods of each generation along the most problematic ancestral lines. There are also special generations with clearly distinguished impressions and sensations in adulthood. I have been able to measure such a clearly visible chain of drug thickening to the depth of several centuries.

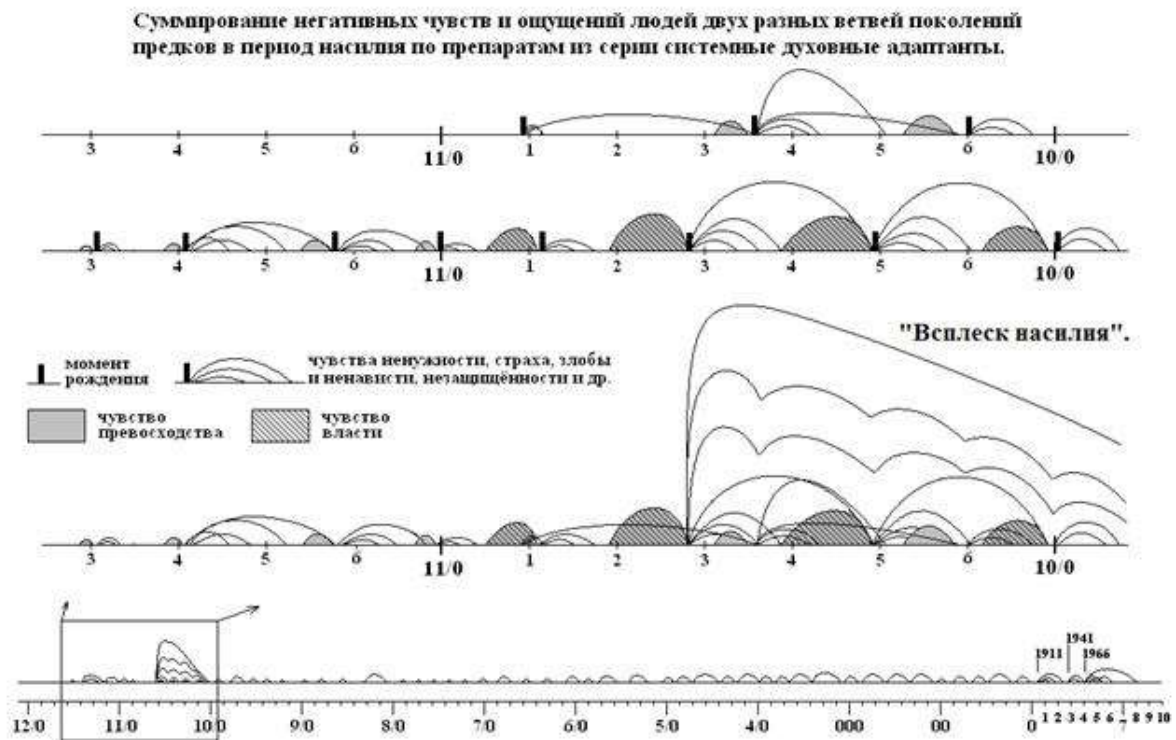
Separately, it is necessary to talk about how you can carry out further measurements in the depth of time, going beyond 0. To measure the state in the deeper past, you can create an increase in the potency of any initial drug by creating intermediate increased potencies. This is done as follows: an informational copy of the original preparation is created with maximum potentiation at the 0 mark, thus an intermediate preparation "first zero" or 1/0 is obtained, which is stored in a separate cassette. If this 1/0 preparation is copied again with maximum potentiation at the 0 mark, then an intermediate preparation of an even higher potency 2/0 is obtained, which is also stored in the cassette. If 2/0 is also copied with maximum potentiation at the 0 mark, then the intermediate preparation is 3/0, and so on.

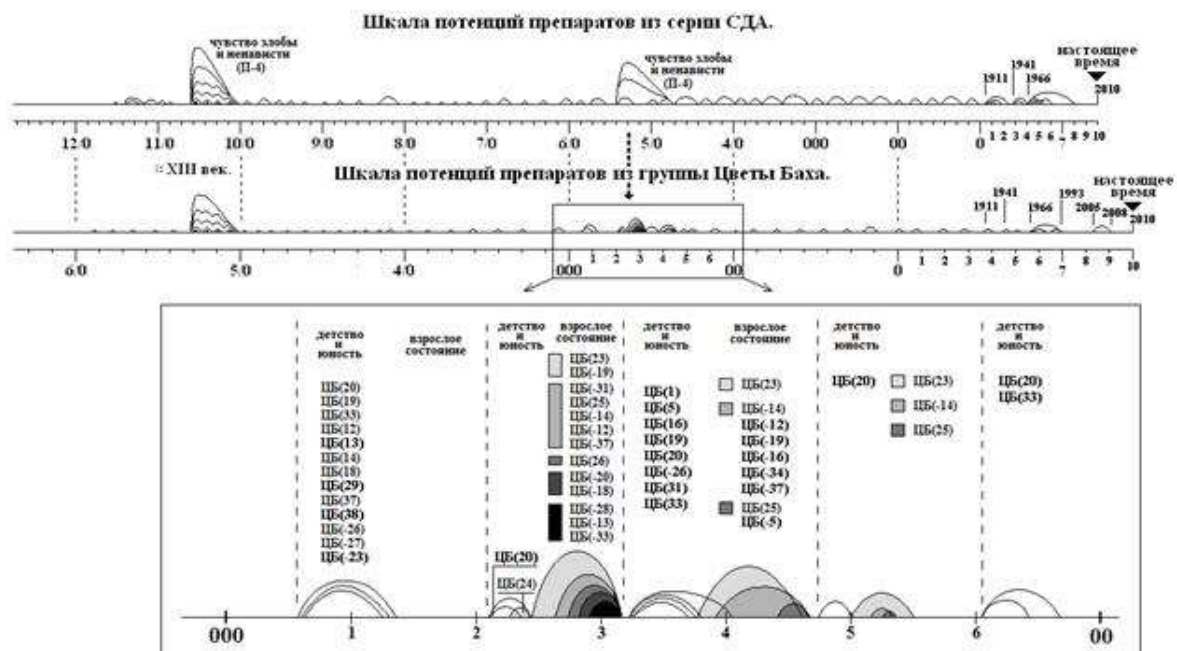
If, for example, we take the drug 5/0 and gradually increase the potency, we measure its resonance from the mark 7 to 0, then in this way we will check the entire range from 5/0 to 6/0. Then you can take 6/0 and also check from 7 to 0 the entire range of 6 / 0-7 / 0. Thus, it is possible to create a continuous potency-time scale to any depth (Fig. 4). The figure shows that there are situations when the same period of time can be measured through different intermediate preparations. For example, if the drug 6/0 is tested with a decrease in potency from mark 7 to mark 10, then it turns out that we are testing the very end of the 5 / 0-6 / 0 range near 6/0. The same range can be tested through the 5/0 preparation at the 0-0.5-1 labels, only this range will be more "compressed" and "shorter". This is due to the fact that the scale of potency of time in the region of 7-10 is more "stretched". Gradually, with increasing potency up to marks 4 and 3, the scale becomes more and more "denser", and when approaching 0, the scale of potency of time is the most "compressed". The most "stretched" scale is about 10. When testing the parent drug from 10 to 9.9-9.8, you can measure the state at different hours of the past day.

This kind of "overlay" of the scale for different groups of drugs occurs slightly differently. For Bach Blossom preparations, the 710 range is repeated in the 0-0.5 range, and for the SDA group preparations the 7-10 range is repeated in the 0-1 range (Fig. 4).



Measuring the chain of negative impressions and sensations of childhood deepening in time for about 50 generations, I managed to "get" to the period of the initial emergence of most negative impressions and sensations, which looks like a powerful initial surge at the depth of several centuries, after which the negative chain continues. This surge, like a powerful explosion, continuously stretches over three generations and combines two overlapping chains of generations. The intensity of the impressions in it is much higher than in any other place so far. I had to take several cups of preparations (250 grains) before the compensation of these generations was achieved. Gradually, as compensation, this single conglomerate was divided into several constituent stable ranges,

Before this initial burst, several more weakly resonating generations were identified, and even deeper, drugs are not tested at all over a long period of time. This initial "outburst of violence" with a subsequent chain is determined both by the Bach Flowers group of drugs and by SDA at different scales, but it is not difficult to find the same generations and study their coloration through a complex of different drugs (Fig. 6). Moreover, the scale of the scale of these drugs differs by exactly 2 times. The "first zero" for the Central Bank corresponds to 2/0 for the SDA, 5/0 for the Central Bank corresponds to 10/0 for the SDA.



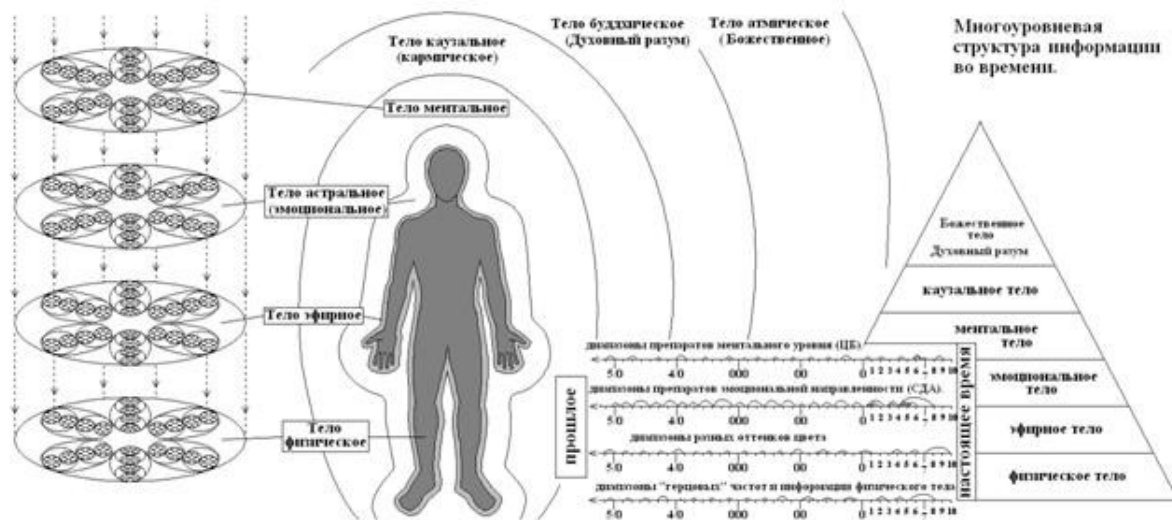

When analyzing the entire complex of impressions and sensations during the initial outburst, it becomes clear that this is a complex of feelings associated with violence against women and the subsequent birth of children hated by these mothers. Immediately after the birth of such a child, the feeling of dislike and uselessness in this world is measured (SDA preparation No. 1 Life-giving Cross). Also, immediately after birth, the feeling of anger and hatred begins to be tested (drug SDA No. 4 Source from someone else's anger and hatred). Fears are also tested early (SDA preparation No. 2 Life-giving source-1 - yin-fear, SDA preparation No. 3 Life-giving source-2 - yangstrakh). A little later, the feeling of insecurity and self-doubt begins to be tested (SDA drug №11 Star of Bethlehem). Drugs from the CB series during the period of the initial outburst of violence also reflect the state of fear, sadness, uncertainty,

I got the impression that this initial surge corresponds to the period of the invasion of the Tatar-Mongol troops into Russia in the 13th century. It is this significant event in history that can correspond to approximately the same depth on the potency-time scale. The negative chain of practically the same sensations and impressions in the periods of early childhood, which has been following the initial surge for centuries to the present, is most likely a consequence of the preservation in the subconscious of people of a complex of negative feelings that have arisen as a result of the primary surge of violence, as well as the addition of many shades of negative feelings for many generations to come.

After many years of testing on myself a huge number of SDA and CB drugs, I can say that these drugs are able to compensate for negative impressions and sensations in the experienced past of the person himself and the deep past of his distant ancestors. This information from the deep past is the human subconscious. The present state of a person is influenced not only by the preparations of the recent past of this person, but also by the preparations of the deep and very deep past of his ancestors. And any shade of the state of mind of today can be influenced both by the drug of the last few years, and by the same drug of centuries ago. We can say that in the mental plane, a person is a complex of impressions and sensations of all their ancestors who have ever lived,

in other words, it just consists of them. On the whole, a person is a multilevel complex of information accumulating over time (Fig. 7).

Despite the fact that it is possible to compensate at different depths of one's past very many shades of negative feelings, impressions and sensations, it is completely unacceptable to carry out such compensation one-sidedly and unbalanced. In other words, if you massively take some certain drugs, and do not pay attention to other drugs, then the general condition in the present tense will be skewed, unbalanced and the person will feel bad. The drug balance is checked in real time by testing the original drugs at the label 10. After such testing in real time, it is possible to determine which drugs the patient needs at the moment to achieve balance and harmony. It is these drugs that need to be found in the explicit and significant ranges of a person's past and take them.

Thus, we can measure and check the state of balance and the need for drugs in the present tense (at mark 10), and at the same time take the necessary drugs that have been identified in the resonating ranges of different depths of the past. Despite taking drugs from the deep past, the balance in the present tense will change. And those drugs that were tested as necessary will become irrelevant after a while. Such observation and testing on ourselves will once again help to make sure that our present state is the sum total of our entire deep past.

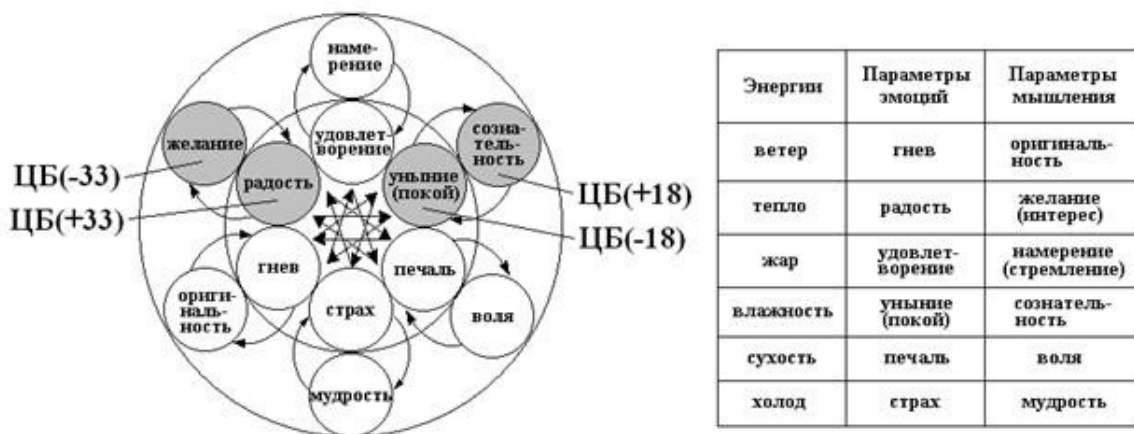
The principle of balance in the present tense applies to all groups of drugs and all levels. As a result of taking any necessary drug, a gradual balancing of the state and harmonization first occurs. AND, in spite of the fact that any range is in uncompensated, and in this range there will be a need for any drug, at saturation time, the reception must be paused. Not everything that has been tested in the past needs to be accepted. The need for admission is determined only by the balance of the present tense.

If you do not test the moment of saturation in time and continue taking the drug further, then gradually this useful and necessary drug will begin to be taken excessively, will create an imbalance and cause the need to take other drugs. At the same time, one should not be mistaken that the excess of any drug can be easily compensated by its inversion in the same potency. Inversion of any

information does not "extinguish" this information to zero, inversion can only temporarily compensate for direct information at some stage. Inversion is antiphase information, which, together with direct information, can represent a new quality, and in case of excessive total accumulation of direct and inverse drug, it will be necessary to compensate for them with a completely different drug, which may also be necessary both in direct and inverse form at the same time.

For example, we can take a drug from the Bach Flowers series No. 33 ceratostigma CB (33). With an excessive total accumulation of direct and inverse CB preparations (33), it becomes necessary to compensate them with CB preparation (18) European chestnut, possibly both in direct and inverse forms. It can be seen in (Fig. 8) that the direct drug and its inversion are pairs of mental and emotional energies, therefore they can only temporarily compensate each other.

Considering the fact that direct and inverse drugs do not "quench" each other to zero, but only complement and partially compensate, it must be clearly understood that any information that we introduce into the past cannot be canceled. All information that we bring into the past remains there forever, it can only be supplemented and compensated with other information to create a harmonious state in the present. Of course, it is best to enter information in the right range. You also need to know that the drug introduced into the unnecessary zone "will not fly by." It will affect the overall balance in the same way as any other drug, because it is exactly the same as the introduction of information into the past. But such an introduction of information into an irrelevant zone should be avoided, because it will create a narrow local imbalance at this depth of time.
