Control and enhancement of DNA repair processes in the patient's body as a concept of therapy for diseases of any etiology N. Kempe (Liboch, Austria)

Introduction

The analysis of previous years shows that there can be different approaches in energy-informational medicine, which ultimately lead to the optimization of the processes of maintaining homeostasis and recovery. All these techniques are necessarily systemic. This is perhaps the most important difference between these methods and symptomatic therapy. In my work, I have tried many options and a variety of approaches. It was also a purely energetic approach in the spirit of oriental medicine, homeopathic vision in the classical sense and in a more modern view (for example, according to Shankaran), potentiated herbal medicine, deep accounting of psychosomatic processes in the body, Jan Scholten's method of elements, biosystem approach in the manner of Biogroups, Lindas, all kinds of complex methods, very interesting method of H. Schimmel, homotoxicological ideas of Reckeweg and much more, what our wonderful system "IMEDIS" gives us. Despite the great success in both treatment and prevention of diseases, I was constantly tormented by the question that all these methods do not sufficiently take into account modern concepts and findings of medical science, modern biology and modern concepts of physics and chemistry. Especially serious

it seemed to me an introduction to therapeutic approaches, modern concepts of cell biology, on the one hand, and the system of interaction of cells in the body, on the other. It seemed to me that we need to take deeper into account the modern concepts of epigenetics, DNA functions, complex processes of cellular metabolism and their systemic nature, and on the basis of this knowledge create methods of influencing complex dynamic processes in the body by our bioenergetic methods.

As one of the most interesting Austrian inventors V. Schauberger said: "You have to learn from nature, observe it, comprehend and then try to create something similar yourself".

The impetus for my reflections was given by the study of the action of venoms of snakes and spiders on complex biological organisms, their development and use. At the end of his life prof. H. Schimmel told me a number of his ideas about the action of snake venoms, especially in high potencies. And recently I have received very interesting information from one of our most experienced and oldest therapists A.P. Musayev about his successful use in the treatment of the potentiated venom of the spider latrodectus mactans ("black widow"). Then I got acquainted with the surprisingly informative work of a group of scientists from the Institute of Bioorganic Chemistry, Russian Academy of Sciences, Moscow (A.A. Vasilevsky, S.A. Kozlov, E.V. Grishin) "Molecular diversity of spider venom" effects at the chemical level. I saw,

electromagnetic) character. The next step was to study the effect of certain organic poisons on the cells of a living organism and, first of all, on the processes of metabolism and replication. As a result, a method was developed to optimize the vital functions of living organisms by acting on the cellular level.

At the seminar, I will dwell on these premises in more detail.

The basis for optimal cell functioning is the state of their DNA. But DNA is susceptible to all sorts of damage. These are radiation, exposure to UV radiation, exposure to chemicals, DNA replication errors, and apurinization and deamination. DNA damage by all these factors occurs with a frequency of several hundred to 1000 cases in each cell every hour! Therefore, living organisms have natural mechanisms for the repair of DNA molecules.

It is clear that this circumstance must be taken into account in all types of therapy. For example, in 80–90% of cases, the cause of all cancers is the absence or too slow DNA repair [1].

At present, the ecological situation is such that the repair processes, even in young and healthy organisms, do not have time to prevent or significantly slow down mutation processes in cells.

Therefore, in any situation, these circumstances should be taken into account, and any therapy should be carried out simultaneously with the optimization of the functions of individual cells. Moreover, this applies not only to chronic and other serious diseases, but also to acute infectious diseases, injuries and contusions.

To implement the idea of treating body dysfunctions of any etiology due to the reparation of the state and function of cells in the equipment produced by the IMEDIS Center, the Selector contains test pointers and preparations:

- the level of DNA indices (drugs for testing ART);
- a set of various drugs according to the state of DNA from "Medpharm";
- EPT frequencies based on the state and DNA correction;
- biooscillators that accurately indicate the type and quality of cellular dysfunctions, such as A-Plex 1-7 and Cell-Plex 1-6;
- various biologically active substances (enzymes, neurotransmitters, various cytokines, oligopeptides, etc.);
- amino acids, chromosomes, various tissues;
- chronorgans;
- poisons of poisonous plants and animals, especially snakes and spiders, so necessary for DNA repair;
- resoplexes and meridian preparations of H. Schimmel and much more.

Therefore, already at the first admission of the patient, the state of the DNA how should be assessed, by DNA indices, and through testing the appropriate biooscillators and drugs from Medpharma.

Next, you should collect all the DNA dysfunctions identified in this case and through them try to find 1-3 drugs that are able to carry out the appropriate repair. These can be Chronorgan preparations, individual enzymes, these can be light signals (or their electronic copies).

But organic toxins and, first of all, spider venoms help most deeply and integrally.

Bioresonance therapy in time modulation mode with programs, for example, E356, E424, E463, works surprisingly well, and if post-replicative repair is required, E802.

Preliminary therapy in the form of bioresonance therapy in the time modulation mode with the above frequencies and with the connection of universal frequencies 7.83 Hz, 8.2 Hz, 9.56 Hz, 10 Hz and 12.5 Hz, with a quick search, is also very effective.

With all DNA repair therapies, drainage must be taken very seriously. Due to the sharp increase in many metabolic processes on the electrodes, after a few minutes of therapy, dark spots that are difficult to wash off appear.

When performing control segmental diagnostics at the end of therapy, you may be surprised that your patient will be in a state of pronounced sympathicotonia and have increased oxygen consumption by the cells! But subjectively, patients feel relief and sometimes very strong. This is especially noticeable in patients with permanent fatigue and pain.

When using this approach to therapy, it is very important to understand when to start writing BR drugs and to accurately determine their dosage and time of administration.

With all the simplicity of the approach, such therapy has many nuances and knowledge of natural repair processes:

- direct repair processes;
- excisional repair;
- post-replicative repair.

The methods of initiation and enhancement of reparative processes using the BRT method will be discussed in more detail at the seminar.

Reparative processes of DNA in the body were discovered relatively recently (at the end of the forties of the last century), and there is still a lot of unexplored in this topic. But even my small experience of using these possibilities through the use of appropriate methods of bioresonance therapy for a variety of, and especially in severe diseases, is so encouraging that I would very much like to pass this experience on to all colleagues using the equipment of the IMEDIS Center and invite everyone to start in earnest deal with this topic, without waiting for cardinal discoveries in conventional medicine.
