## Bioresonance therapy method in experimental oncology and biophysics cancer (review of the literature based on the materials of the conferences "IMEDIS") V.P. Zaderin (Rostov Research Oncological Institute of the Ministry of Health of the Russian Federation, Rostov-on-Don, Russia)

(1) conducted an experimental study on 79 mice (37 - main and 24 - control group), who were vaccinated with Ehrlich's carcinoma. In the control group, imitation of BRT was carried out, and in the main group, various BRT strategies were carried out. The use of an inverse preparation of Ehrlich's carcinoma made it possible to increase the life span of animals by one third in comparison with the control group and "pure" BRT.

cells appear hexonidase, which breaks down glucose and creates a dead zone around the tumor with blocking receptors. The tumor gets out of the regulatory influence of the body and becomes tolerant to the immune system. The authors report that a synthesized MR-antiprotein-blocker prepared from the histogenetic substance of the patient himself can destroy the tumor in 30% of incurable patients.

## Summary

These publications show:

1. Resonant wave techniques should be actively implemented in experimental oncology, which will expand the information about the features of the resonant-wave characteristics of the tumor cell and the ability to influence it with weak control frequency signals.

2. Treatment of cancer patients should be comprehensive and include: resonance-wave, biochemical, psychological and physical methods of influencing the tumor.
