The method of complex application of energy-informational preparations and GUNA homeopathic preparationsIN AND.

Introduction

The constant search for new effective forms of patient care has led to this study. Experimentally, in the process of diagnostics, treatment and observation of patients, a new proposed methodology for the complex use of informational preparations and homeopathic preparations of the "GUNA" company has developed.

It is known that drugs that are prepared on the "IMEDIS" equipment are informational. The very mechanism of their action is not fully understood, but, nevertheless, the fact remains: they "work". In our opinion, their action, in some way, resembles one of the principles of Gestalt psychology: a certain action is represented by a well-known symbol. However, it should be noted that with repeated use of information drugs, the response of the body's cells decreases, and, accordingly, the effectiveness of therapy decreases. How can this problem be solved? In our opinion, and based on the experience of work, there are several possible rational options for solving this problem. In this article, we present five of them. The first two options include the use of informational drugs only in therapy.

Purpose of the study:

- 1. Show the effectiveness of therapy when used together energy-informational and multicomponent homeopathic preparations.
- 2. Choose schemes of universal recipes for combined use energy-informational and multicomponent homeopathic preparations.

Material and research technique

The work was carried out on the APK "IMEDIS-EXPERT" (program version 6.10). Medicines were recorded on homeopathic globules (sugar crumbs).

The study used classic homeopathic preparations of the "GUNA" company.

The study was carried out in an outpatient setting in patients aged 30 to 70 years with various forms of pathology.

More than 200 patients were treated and followed up using this technique. The period of observation of patients is from 3 months to 2 years.

For the first 2–4 weeks (depending on the nature of the disease and the patient's condition), only energy-informational preparations made on the IMEDIS equipment were prescribed. Subsequently, the preparations of the "GUNA" company were added to the energy-informational complexones. In some cases, in the treatment regimen

induction programs of the brain were also included. These programs were carried out directly during the session of endogenous bioresonance therapy.

Results

Variants of the methodology for the use of energy-informational preparations and homeopathic preparations of the "GUNA" company.

- I. Option: every 6-8 weeks to change the drug potency.
- II. Option: for the treatment of the disease or symptom-based therapy, create2 information drugs and weekly alternate their use, then the period of their effective action increases to 12 weeks.

III. Option: the combined use of dietary supplements and information drugs. We have many years of experience working with dietary supplements from various companies. For several years we have been working in the direction of practical application and the search for rational combinations of biological additives and information drugs. The results of practical application have shown that this path is fraught with a number of dangers. Firstly, the very principle of work of drugs is incompatible: a homeopathic informational preparation and a high concentration of substances that make up dietary supplements.

Secondly, with such a methodological approach, dietary supplements "force" the cell to work in a forced mode, "for wear and tear." In certain cases and for a short period of time (1-3 months) this is acceptable. However, we come into conflict in two main directions:

- 1. Physiological contradiction with the principle of the cell it works at homeopathic concentrations;
 - 2. Contradiction with the dietary supplements business principle:
 - the more drugs, the longer they are taken, etc., the higher the profit;
- marketers in the distribution of dietary supplements are, very often, not doctors. Dietary supplements are prescribed without taking into account the specifics of the disease and individual selection of drugs.

In our work with these drugs, we are always guided by the principles of individual selection of the drug, its dose, timing of application, taking into account the specific pathology of patients.

We have repeatedly proposed this principle of individual selection of the drug to various companies dealing with dietary supplements. In fairness, it should be noted that there are successful prescriptions of dietary supplements. But, demonstrating the principle of individual selection of a drug in the offices or at conferences of these companies, we encountered not only the ineffectiveness of the drugs, but also often with cases of their unjustified prescription, overdose, side, negative actions, with the risk of developing serious complications.

IV. Option: a combination of energy-information drugs with classic

homeopathic medicines.

Here a logical principle arises - "like is combined with like". Why did we choose GUNA products? Because most of them are a synthesis of homeopathy, immunology, molecular biology, and organopreparations. Long-term practical use of these drugs confirms their high efficiency.

The practical use of these drugs has shown that reducing the dosage of classic homeopathic drugs to 30% does not significantly affect the effectiveness of their therapeutic action.

V. Option: the use of a combination of allopathic drugs with option IV.

Here are examples of some of the most commonly used recipes that we have developed.

Legend in recipe recipes:

0 - natural homeopathic preparations from GUNA. 1 - Dr.

Schimmel's preparations.

- 2 preparations of the company "OHOM".
- 3 programs of treatment with brain rhythms. 4
- organopreparations.

Recipe 1

0.GUNA CAGE

- 1.Liver-gallbladder.
- 1. Kidneys.
- 1.Lymph.
- 1.Inflammation.

Indications for use:

- almost all patients are older 40 years old, if they do not have any pronounced pathology;
- various diseases in the stage of long-term remission;
- in patients of the older age group at the finish linegenetic code based on the results of family history. The peculiarity of the preparation GUNA-CELL is a multicomponent (34 constituent parts) and normalizing the activity of the drug are organopreparations of DNA and RNA, and one of the components (Conium) has an anti-cancer effect.

An important positive point when using this prescription is that, against the background of improving general well-being and condition, there is no

there is an increase in blood pressure.

Recipe 2 0.GUNA-ARTHRO. 1.Joints.

- 2.Drainage of the osteoarticular system.
- 3. "Universal program". ("Universal program" electromagnetic therapy was published by us in 2010 in the Abstracts and Reports of the XVI International Conference.)

Indications for use: can be prescribed to all patients of the ageover 30 years old.

GUNA-ARTRO contains 27 components, of which 7 are organopreparations, and 2 are immunopreparations (fibroblast growth factor and nerve growth factor).

During the year, 2 courses of treatment are carried out: October-November and February-March (optimal terms).

Recipe 3

0.K2MDIA or K2FDIA.

0.GUNA-CELL.

- 1.Pancreas.
- 2. Drainage of the liver-gallbladder-pancreas.
- 3.Induction program P5.

Indications for use:

- diabetes;
- diseases of the cardiovascular system;
- brain diseases;
- diseases of the gastrointestinal tract;
- diseases of the respiratory system.

K2MDIA and K2FDIA drugs created and apply how antidiabetic. They contain 15 components, 11 of which are organopreparations. A wide range of organopreparations made it possible to successfully use them in diseases of the cardiovascular system, brain and gastrointestinal tract.

The method of application of the P5 induction program is as follows: we turn on the program 10 minutes before the start of the session of endogenous bioresonance therapy. Then within 15 minutes. we carry them out together.

In diabetes, all medications are recorded on the water.

Recipe 4

0.GUNA-HYPERTONIA.

0.YPER-G.

- 1. Kidneys.
- 2.Drainage of arteries and heart.
- 3.Induction program P5.

Indications for use: hypertension.

The GUNA-HYPERTONIA preparation contains 15 components, 3 of which are organic preparations (diencephalon, adrenal glands and kidneys). IPER-G is responsible for normalizing the structure of the vascular wall (mainly arteries) in metabolic disorders in the body and in the damaging effect of endotoxins, when

the elastic fibers of the arterial wall are damaged.

Recipe 5

- 0.1 NFGM.
- 1. Nerves.
- 1. Vessels.
- 2. Drainage of the nervous system.
- 2. Drainage in the pituitary-adrenal cortex system.
- 3.Induction programs P7 or P15.

Indications for use:

- brain diseases;
- lesions of peripheral nerves.

NFGM (brain neurotrophic factor) is an immunological drug that normalizes brain function in various conditions.

Recipe 6

- 0 ANTI-AGE-FACE.
- 0 ANTI-AGE-SKIN.
- 0 ANTI-AGE-STRESS.
- 0 ANTI-AGE-VIENNA.
- 1.Liver.
- 1. Kidney.
- 1.Lymph.

2.Drainage of the skin.

3. Brain programs P5 or P10.

4.Leather.

Indications for use:

- this drug is used for general rejuvenation of the body;
- cosmetology (both independently and in combination with other cosmetic techniques).

There are 2 courses of therapy per year: in spring and autumn.

On the example of all the above recipes, it can be seen that we most often use only those preparations of the "GUNA" company, which include organic preparations. This methodical approach allows not only to correct this or that problem of a mental or physical nature, but also to "tune" the cell for a longer life.

Prescribing scheme

As a rule, we prescribe GUNA preparations 2 times a day, 10 drops each. One standard package (30 ml bottle) at this dosage is enough for 1.5–2 months of treatment.

Informational preparations are prescribed 2 times a day, 10 globules (with intensive workload of the patient) or 3 times a day, 6 globules (if the patient has the opportunity to take them in this mode).

The average course of treatment is 1.5–2 months. This is followed by a break in treatment for 2 weeks, after which we conduct a control examination for further correction of therapy.

The combined use of informational and classical homeopathic medicines allows not only to significantly improve the results of treatment, but also to reduce the dose of homeopathic medicines, which, in turn, reduces the overall cost of therapy.

The above recipes represent a very simple and versatile option for carrying out therapy in cases of simple pathology. But these same recipes turn out to be much more complicated when it comes to the presence of a combined pathology in a patient. As an example, the following clinical case (V. Option) can be cited (the given clinical data are only general in nature):

Clinical example

The patient, a man, 60 years old, hypertension, heart rhythm disturbances, has not been examined for many years. On the recommendation, a general clinical examination was carried out. Revealed high sugar content - 22.4 mmol / l, ketoacidosis, glucosuria, ketonuria. Diabetes (decompensated) type II. Refuses insulin therapy. Treatment was started: diet, Mertskformin, Biochrom-DIA with glucose tolerant factor, the following homeopathic recipe was selected.

Recipe:

0.K2MDIA.

0.GUNA-CELL.

0.YPER-G.

- Bioenergy protection.
- P85 drug for hypertension.
- Guna-cage.
- P14 soothing and hypnotic drops.
- K2MDIA.
- Syn46 headache.
- Magnesium aceticum-yin.forte.
- Trienost drops.
- Pyruvic acid.
- Alkaline.
- Removal of poisons from connective tissue.
- General peroxidation of the body.
- P74 drug for nocturnal enuresis.
- Dre 6 lymph drainage.
- Dre 1 drainage of arteries and heart.
- Dre 12 drainage of the nervous system.
- IPER-G.
- P40 drug for diabetes mellitus.

- Chromium ZhTP capsule.
- Syzygium OTI comp.
- American five-leaf ginseng.
- Alfaldik D3.
- Scylla 3.
- Podophyllum 3.
- Metallic silver D30.

From the frequencies of electropuncture therapy, two programs have been created for the treatment of this patient:

1st Program E: 16, 31, 46, 533, 3, 68, 62, 4, 205, 147, 28. This program is designed for a gradual hypoglycemic effect.

2nd Program E: 16, 31.

This program has a pronounced and rapid hypoglycemic effect and has a pronounced hypotensive effect.

The use of this therapy regimen (in combination with allopathic drugs) for 4 weeks reduced the fasting blood sugar level to 10.8 mmol / L. Starting from the 5th week, treatment was carried out only with allopathic drugs. Fasting blood sugar increased to 12.4 mmol / L.

The patient is in the process of selecting adequate therapy and this case is presented to confirm the complexity in the case of individual selection of drugs in patients with severe concomitant pathology.

Conclusions:

- 1. The proposed technique for the combined use of classical and energy-informational homeopathic preparations potentiates the action of each of them, increasing the effectiveness of therapy by an average of 30%.
- 2. Combined use of informational and classical homeopathic drugs allows to reduce the dose of traditional homeopathic medicines by 30%.
- 3. A new method of complex application of information and homeopathic medicines, allowing to increase the effectiveness of therapy along with its versatility.
