

The causes of blockages and their effect on the results of the autonomic resonance test

In Chinese medicine, the term "Yang", from the point of view of classical European medicine, corresponds to all functional processes in the body: these are the body's energy resources, the functioning of the receptor apparatus, psychoemotional response, etc.

Yin processes correspond to such concepts as: morphological state of the structure, biological substance, the presence of necessary trace elements, vitamins, amino acids, etc. These two concepts are inextricably linked and complement each other. The mutual influence of the Yang and Yin systems defines the concept of health, which implies a balance of these two systems.

The ART method is able to reflect and track such interactions. For this, the following test indicators are used: adaptation reserves, the optimal therapy step for adaptation reserves, health levels, biological and photon index, etc.

There are several options for the body's response to a change in the internal environment or the invasion of a pathogenic factor. The first option is the launch of regulatory (sanogenetic) mechanisms. The response occurs in the form of inflammation, changes in microcirculation, venous stasis and lymphatic edema. This is reflected in the positive testing of the respective pointers. The body tries to limit the inflammation process, and immunological reactions are triggered. Sanogenetic blockages appear.

However, with insufficient adaptive reserves, when the body itself is not able to normalize the existing metabolic changes, new, additional compensatory pathways are formed to restore balance. The causes of the disorders that have arisen can be both in the failure of the altered morphological structures, and in the presence of many old, pathological, blocking normal regulatory mechanisms, conditions. Such blockages correspond, as a rule, to chronic processes and are of a pathological nature.

This can be expressed in positive testing of pointers: blocked adaptation reserves, mesenchymal blockages, an extremely small step in the resolution of therapy or its absence in terms of adaptation reserves, photon index, presence of cicatricial interference fields.

Chinese medicine describes the occurrence of such conditions and necessarily takes them into account when making diagnoses and treating them. The mechanism described above is defined as a violation of the normal course of the meridians with the formation of interchannel and intracanal collateral connections.

Subsequently, the system of wonderful meridians is switched on. Most often, these conditions are found in elderly people and in people with many chronic diseases.

Experience shows that in some situations such conditions can change the current ART indicators. This is characterized by the fact that there is no correspondence between the clinical picture of the disease and the results of ART. The test results more indicate compensatory, secondary changes in systems and organs. The clinical assessment of the physician in such situations is of leading importance in drawing up a treatment plan for the patient. Such errors can often give such conditions as severe anemia, oncological processes, severe hormonal deficiency, including hormone replacement therapy, etc. Clinical understanding and correct assessment of such conditions allows the doctor to avoid testing errors associated with the distortion of the current test.

Chinese medicine, in addition to regulatory treatments such as acupuncture, massage and moxibustion, uses herbal medicines. Phytopreparations have an effect at the structural level, i.e. act through the replenishment or toning of yin. This makes it possible to achieve long-term stabilization of the results obtained with further therapy. Other herbal medicines affect the toning and replenishment of Yang, this activates a quick response of functional systems.

There is a change in the processes of microcirculation, drainage of the lymphatic system and, most importantly, the harmonization of the neuroendocrine system. This is reflected in the change in ART indicators in the form of removing mesenchymal blocks and blocked adaptation reserves, cicatricial interference fields. The resolving step of therapy increases on the scale of adaptation reserves, biological and photon index.

Such a start of processes is also possible in the presence of biologically active substances with high bioavailability for damaged organ systems, i.e. influence on the body by regulating Yang through Yin.

Homeopathic medicines, bioresonance (endogenous and exogenous) therapy, influencing primarily the functional systems of the body, affect metabolic (Yin) processes through Yang activation. They have the most striking effect on patients with a high level of structures (Yin systems). Informational preparations are capable of activating metabolic processes, subject to a full supply of nutrients. But this also requires sufficiently high energy resources of the body. At a low level of the structure (Yin systems), exacerbations, breakdowns of adaptation reserves, the occurrence of frequent relapses are possible, blockages are formed, the current test changes.

The use of regulatory information methods is possible in combination with phytopreparations. At the same time, an integrated approach must be taken into account in the selection of drugs and energy-informational methods of therapy.

The combined action of phytopreparations and information drugs under the control of ART allows not only preserving, but also replenishing both structural and functional systems of the body. Clinically, this is reflected in a mild, gradual improvement in health, with long-term stabilization of the achieved state. The longer the pathological condition exists, the more pronounced the changes in the neuroimmune and neuroendocrine systems will be.

It is important to control the dynamics of organopreparations of the hypothalamus, pineal gland, hippocampus.

Harmoniously composed complex how phytopreparations So and information drugs, should lead to the fact that organopreparations of the hypothalamus and pineal gland against the background of the composed complex, will either be tested in the D6 potency, will cease to reduce the measuring level during testing.

It is important to evaluate the permitted release step through the Argentum nitricum C52 index. He indicates the extent to which a step of therapy is possible, taking into account blockades, which will correspond to the general state of the body, taking into account the reserves of adaptation, and the general biological index (Gotovsky Yu.V.).

It is important to note that the resolving step of BRT increases significantly when phytocomplexes are introduced into complex treatment. At the same time, additional reserves of neurohumoral, immune and other systems of the body increase.
