## Energy-informational approaches to the treatment of malignant tumors V.S. Mosienko1, OK. Kurtseitov2

At the beginning of the twenty-first century, mankind has come to a feeling of the need to revise scientific paradigms and dogmas with regard to health and illness, the relationship of a person with the outside world. In our time, man as an integral part of the Universe has ceased to be considered only a biological object. It is a cosmic entity, a bioenergy information system that carries the entire complexity of interaction with the Cosmos. The prophecy of K. Tsiolkovsky about the spiritualized Universe and about the global brain, which V. Vernadsky (1989) called "noosphere", which carries intelligent forces, is becoming a reality. Human thought, fed by the Universe, forms and substantiates new knowledge of mankind. And it is no coincidence that for the study of the Universe, the subtle worlds, the most perfect apparatus is a man with his mind,

Today, science from fragmented thinking is trying to penetrate beyond the boundaries of the visible world, it is getting closer and closer to religion, considering Cosmic Intelligence as the basis of life on Earth, according to D. Bohm and K. Pribram. Academician Y. Yatskiv expressed the idea of the possible presence in the Cosmos of energy inaccessible to devices, which controls the course of the development of the Universe.

On the basis of quantum physics, A. Martynov (1990), L. Puchko (2002) and others formulated new ideas about a living organism as a carrier of an energy-informational biofield, which controls all processes in our body. Life, according to V. Engelhardt's definition, is the unity of "three streams: matter, energy and information, completely inseparable from one another."

At the present time (information age), humanity has stepped from the world of things into the world of energy and information, as a result of which the substantive approach in the search for cytotoxic anticancer chemotherapy drugs, solved within the framework of one materialistic conceptual system - which chemical, biological substance or physical factor to kill a cancer cell has not led to positive treatment results. Until now, there are no highly specific drugs that would infect only malignant cells and not poison the patient's body. The "Achilles' heel" of almost all anticancer drugs is the low primary sensitivity of malignant cells, their genomic instability, as well as the high toxicity of anticancer chemotherapy drugs, affecting important parenchymal organs and systems of the body. This leads to an accelerated progression of the tumor process, especially when malignant cells are insensitive to the drugs used, exacerbation of concomitant diseases and accelerated death of the patient. Without specific anticancer drugs, we cannot deliver them to a malignant tumor due to the defectiveness of the nutritive capillary blood flow and slagging of the main substance of the connective

## tumor tissue.

The principle used in the twentieth century, a new marker - a new substance - a new treatment (targeted) also did not lead to positive success. This suggests that the cytotoxic (killed) path of rational pharmacotherapy has led cancer treatment to a standstill. Perhaps the real solution to such a complex problem as prevention, treatment, rehabilitation and palliative care for cancer patients is located in a different energy-informational plane.

Now we consider the world as a resonant set of physical, energetic and informational levels of reality, which carries the entire complexity of the influence of the Universe. The information of the Cosmos, interacting with the energy-information system of individual people, programs the activities of all mankind, generates the vital forces of every living organism.

According to A. Akimov and G. Shipov (1996) and other scientists, "primary Consciousness" is the highest form of creation, development and transformation of information. The most powerful source of information programs is the person himself, his thoughts. After all, what are the thoughts of a person, such is his information space, the functional state of the organism and heredity. So consciousness - this is not an abstraction, but the most important physical reality. It can serve as a defining tool for healing even in the advanced stages of incurable diseases, including cancer. It is futile to treat a sick person in isolation from the Universe. Therefore, for the successful treatment, prevention and rehabilitation of cancer patients, fundamentally new approaches are needed in a complex triad: the body - a malignant tumor - the surrounding environment, i.e. treatment should be carried out on the basis of an integrative, holistic approach, taking into account the biological law of the unity of the body and the external environment. This approach makes it possible to use in a new way the achievements of quantum physics, physical vacuum, nano- and biotechnology, bioresonance therapy and other vibrational and non-traditional methods in the integrative treatment of tumor disease.

Physicians should abandon the absolutization of the physical body "to go beyond it" and begin to study the anatomy and physiology of subtle bodies - etheric, astral, mental, causal and others. We still know little about these bodies and do not take into account their influence during treatment (V.S.Mosienko, L.K. Kurtseitov, 2010). In the physiology of subtle bodies, vital force plays an important role - energy, the purpose of which is to support the life of the cells of the physical body of a person not only due to nutrients (A.A. Nalyan, 2011). Energy metabolism is the driving force behind the metabolism of living nature. Modern science considers metabolism and energy exchange in living matter as a single process, i.e., only food is, according to many scientists, the only source of energy. But many researchers also take a different point of view. I.L. Gorlovin believes

Chinese medicine claims that life force arises from the interaction of the body's etheric body with the external environment. Homeopaths and conventional medicine physicians believe that life force sustains, organizes and

forms life in all living things, it orders and renews the life of protein bodies. Perhaps vital energy distinguishes living from non-living.

According to P.D. Uspensky, "... the life force is capable of releasing an infinitely greater amount of energy than chemical and physical processes produce." S. Hahnemann wrote: "Healing can be conditioned only by the reaction of the vital force ... and the speed and reliability of the healing is proportional to the extent to which the patient retains the vital force." Hardware determination of its level in a sick organism would give significant progress in understanding the role of the biofield in a healthy and sick organism, the possibility of predicting the stages and outcome of the disease.

The physiology of subtle bodies also includes the energy generated by the mental plane of being and manifested in the dominant of the brain in thoughts, ideas, will and words. This is the so-called psychic or spiritual energy - its potential power is practically limitless. Jesus Christ, as well as great saints, used the potential of spiritual energy in the treatment of the suffering.

Archbishop Luke says that spiritual healing is infinitely great and has not yet been appreciated by modern man and is often carried out not only through the willful efforts of the patient and the doctor, but also through the grace of the Holy Spirit, i.e. Divine grace.

Obviously, the real world is the psychic world - the world of consciousness. The universe is as we see it.

Until we learn what energy, consciousness and information are, it is unlikely that we will be able to successfully treat chronic diseases, effectively rehabilitate and provide quality palliative care to patients.

There is evidence that under the influence of thought, emotion and will, which are a manifestation of consciousness, it is possible to change the function and even the structure of DNA, the chemical composition and structure of water, the function of brain cells, devices, etc. the change in matter most effectively occurs due to the influence of information. It is the human biofield that carries information about the state of physical, mental and spiritual health and controls all the processes of our body.

P. Gariaev (1994) formulated a scientific hypothesis, where he received, under the influence of a laser, a kind of recording of DNA information - a phantom, which was recorded by the device for another 40 days. Under the guidance of the author, an apparatus was created that simulated vibration commands to restore radiation-damaged wheat and barley seeds. This explained the so-called phantom pains, which have baffled biologists and doctors for a long time, which enter the human brain from a missing part of the body that has the same part of DNA as the person himself. Thus, from the point of view of P. Gariaev's wave genetics, DNA works not as a substance, but as energy in the form of electromagnetic and acoustic fields, in which the entire organism, its physical and subtle bodies are encoded.

Jiang Kanzhen showed in the 70s that DNA is a cumulative genetic material, consisting of passive DNA and an active electromagnetic field that can be changed. It is enough for this

to act with a bioelectromagnetic signal (these are moving photons, which, according to quantum physics, have corpuscular-wave properties).

The influence of the information on the green mass of wheat, through the author's installation on the germinated corn seeds, led to the germination of peculiar ears with signs of corn and wheat grains. The acquired new qualities were steadily passed on to subsequent generations. The author received the chicken eggs processed by the bioelectromagnetic field of the ducks. This provides a basis or possible approaches to treat many diseases, including malignant tumors, as well as to rejuvenate a person. Finding mechanisms of reversibility of age-related changes and DNA breakdowns at the molecular-genetic level, under the influence of bioelectromagnetic fields of young organisms on elderly or sick people, is the most important approach that can be developed by the team of the IMEDIS Center. Moreover, the author even had a certificate for the invention. The method of transmitting genetic information by the field should be attributed to the great discoveries of our time, says Yu. Simakov. Already at present, Novosibirsk scientists have succeeded in experimentally proving the effect of materialization of information flows that can change the genetic code, protein-nucleic acid metabolism, the growth of cellular structures, etc.

Obviously, with a malignant disease, a reorientation of energy flows in a sick organism occurs, its mental state changes, as well as the entire chemistry and physics of metabolic processes in tissues.

Ayurveda believes that the influence on consciousness can serve as a decisive influence for the treatment of even serious diseases that are not treated by official medicine with its evidence base and rational pharmacotherapy. And here, in addition to the doctor, the participation of a healer, psychologist, energy therapist and a priest in the treatment, and especially in the rehabilitation of an oncological patient will be invaluable. Moreover, according to I. Pavlov, the human body is a highly self-regulating, self-supporting, restoring and even improving system. And the healing of the body is an innate ability of human beings, and this gift is unique for each patient.

A cancer patient after stress, shock, disbelief, pain, feelings of helplessness, doom and hopelessness should take responsibility for his life with the help of a doctor or healer. To resist the circumstances that caused this fatal illness, to make life more meaningful, conscious and worthy, so that one can fight for it. With this integrative method of treatment and rehabilitation, there is a balanced exchange of energy, information with cosmic or bioresonant energy. It is these streams that play a decisive and constructive, restorative role in future adaptive or holistic treatment. Such treatment and rehabilitation of cancer patients should be carried out permanently throughout the patient's life.

The scheme for the treatment of oncological diseases, used in the NNML clinic of the Main Hospital of the Ministry of Health of UkraineI. At the level of the physical body.

- 1. Diet therapy cleansing the body on a special diet, in three servings which has the entire set of nutrients in the daily diet.
  - 2. Treatment provided by international standards for nosology.
  - 3. The use of drugs from anticancer fungi.
- 4. For malnourished patients, the use of magnetoactive cluster organic iron compound.
  - II. At the level of the etheric and astral body.

Methods of energy-informational therapy (BRT, MRI, homeopathic preparations).

III. At the level of the mental body.

Work with consciousness (psychotherapist, priest).

The results of the treatment of cancer patients.

During 1998-2001, the clinic treated 92 patients with various nosological forms of III-IV degree cancer. In 76% of cases, there was an improvement in the quality of life and its prolongation, in 14% - no effect was observed. 5-year survival rate was 17.4% (16 people). 10-year survival rate - 7.6% (7 people).
