

Presentation of therapy concepts taking into account the influence of ecology

The very dynamic changes in ecology on Earth that have been observed in the past few years make us think about how to build a therapy concept with this fact in mind. The main observed phenomena:

- The increased level of cosmic radiation and, in connection with this, the increase and change in the spectral radiation of the sun.
- Unusual behavior of the earth's magnetic field.
- A sharp increase and variety of technogenic and chemogenic effects on living matter on Earth.

The result of this is a change in the nature of the course of diseases and their symptoms and the emergence of new diseases.

For more than two years now, we have been looking for new approaches to therapy by methods of energy-informational medicine, first of all, of course, with the help of the equipment of the IMEDIS Center, taking into account these environmental changes. In our opinion, the approach through the restoration of natural reparative processes in the epigenome of human cells is very effective. In the devices of the Center "IMEDIS" there are very great opportunities for this, embedded both in the selector and in the EPT section in the form of resonant frequencies. At the last conference, we presented the first very encouraging results. Now a number of our therapists are using this technique. Further, it turned out that cosmic radiation, which is a wide spectrum in the high-frequency region (α -, β - and γ -radiation), contains not only destructive information and energy, but also contains important useful information for living matter, which is accepted by complex DNA molecules. We began to record this information by means of radionics and use it for therapy using the methods of BRT of the IMEDIS system. At the same time, we did research (information diagnostics) using all the methods available to us (R. Voll, ART and, of course, segmental diagnostics - DM) before and after therapy. Where possible, appropriate clinical studies have been used. The results turned out to be very promising, but for their widespread use it was necessary to find methods of recording space information, possible for all. Since in this method of restoring and maintaining the state of DNA of cells we use, among other things, the corresponding electronic copies of Medpharma preparations, naturally, first of all, we turned to them,

The main idea here is to optimize the functions of the cellular mechanism as much as possible, and, therefore, to put on a high level the body's natural ability to recover and then, if it is still necessary, to carry out targeted partial therapy.

The scheme of such treatment justifies itself both in seemingly completely hopeless cases and in less dangerous dysfunctions of the body, especially in cases where the etiology of the disease is unknown and incomprehensible.

As always, we start with quadrant measurements and segmental diagnostics. Their interpretation and analysis provide us with very important information about the current state of homeostasis and allow us to assess the capabilities of the body during the "load" of therapy. Next, we proceed to the study of the DNA of the body's cells using the ART method. We check the state of four nucleotides: adenine, guanine, thymine and cytosine, the DNA molecule as a whole and enzymes (all drugs from the Medpharma selector) separately and then together. It should be noted that the majority of patients have violations here! Next, we check whether the situation is corrected when the preparations "cosmic energy" and / or "orgone energy" are turned on. We remember the result - it is very important.

Now we check the state of the cells: from the preparations of the "GUNA" company, the section "Biooscillators" we check all A-Plex 1-7 and Cell-Plex 1-6.

Next, we test whether there are already embedded viruses in the DNA that are in an active state (DNA virus D60, Dr. Schimmel's preparations or the section "Preparations for ART"). If yes, then we further determine which viruses dominate using drugs from the selector (drugs by Dr. Schimmel or by Medpharma). Viruses can be tested in groups. But since this is a rather laborious work, you can test only their type (short-chain, long-chain, fragments) and then enter the found into the therapy circuit.

The next step is the definition of "Chronorgans" ("OTI"). There may be several of them. For therapy, it is enough to take the one that is tested through Cu met. D400. Now we are checking the need to connect the M18 meridian to the therapy circuit, which is responsible for the functioning of fundamental resonances within cells.

To assess the effect of the environment, in addition to the "classical" test for the presence of geopathogenic, electromagnetic and radioactive loads, the "GUNA" preparation D-Plex radiation should be tested (section "Biooscillators"). To assess the state of the genome and epigenome, it is imperative to check for the presence of genetic abnormalities in general and the structure of disorders through Medpharma drugs, including drugs indicating mutational processes

A very important step is to check how self-correcting genetic abnormalities are. To do this, we add together the tested preparations for the composition of DNA (nucleotides, the DNA molecule as a whole, Enzymes and all found genetic abnormalities) to the measurement circuit. Naturally, the result will be - a decrease in the measuring level (the test is positive). Then we add the indicators "cosmic radiation" and "orgone energy". If a high measuring level is restored during testing, then we will be able to cope with the disease at the moment by constructing bioresonance therapy accordingly. If the measurement level is not restored, it is necessary to connect ROSTOCK products (SOM 1, SOM 18 and C8-12).

Testing the drug Platina 1000. According to the body's reaction to it

a decision is made on the need for deep drainage and monitoring of the state and therapy of the chakras.

One of the most effective ways in this case is to conduct bioresonance therapy, carried out in three stages (during one patient visit):

1. Conducting a BRT cycle (440 sec.) Along all meridians sequentially or simultaneously (then somewhat shorter), with recording immediately or after 100–150 seconds. for grains or water in the first container of the IMEDIS apparatus.

2. Conducting the second cycle of BRT along all meridians. Information from the first the container is transferred to the third (inverted). Drainage preparations and almost all preparations obtained from the tests described at the beginning are connected from the selector. The choice of these drugs and some others, depending on the disease, will be discussed in detail at the seminar).

3. Then bioresonance therapy is performed in time modulation mode with fast enumeration (enumeration time 1–3 sec.), as discussed at seminars in 2012 and 2013 [1, 2] (modulation frequencies E356, E424, E463, and if postreplicative repair and E802 are required, drainage tested drainage E33, E36, E140, E171 and E349, the frequency of alignment of the sympathetic and parasympathetic systems, etc.). The time for the third stage, unfortunately, is very different for different patients and ranges from 200 to 1000 seconds. It also needs to be tested, for example, with a biotensor.

In 1-2 minutes after the end of therapy, segmental diagnostics should be performed without fail. There will be no limit to your surprise! Usually all phantoms will look surprisingly good, but the integral parameters, on the contrary, are alarming. There may be signals such as increased oxygen consumption or a transition to a strong sympathetic state. That's right, the healing processes were involved. The patient should be warned that the next hours before bedtime, he should not overload himself, either physically or mentally.

Very important! At the second and third stages, drugs "Medpharma" "cosmic radiation" and "orgone energy" are necessarily connected to the therapy circuit. Otherwise, in all likelihood, nothing will work out, or it will work out only partially!

About recording a drug for a patient. You can, of course, write down the drug from the very beginning of the third stage of therapy, it will be very effective. But it is much better to do this through the patient himself, namely to tell him that after a while (this is usually 2–3 minutes after the start of the third stage) he will suddenly feel a weak, but completely clear sensation of lightness. He must at this moment tell you about it. This will be the moment the drug starts recording. Then the drug will act much softer, more physiological. Interestingly, all patients experience this moment, albeit in very different ways. In children, it is necessary to record the drug in the last 200 seconds. therapy.

I have been working on this principle for the third year already, while the therapy turned out to be very effective, both in "mild" cases, and in the treatment of such serious diseases as: cancer, diabetes, multiple sclerosis and, especially, with difficult

complex difficult to diagnose cases. At the seminar, I will try to highlight important details of such therapy, give examples and talk about other types of building therapy on this basis, for example, the use of DNA therapy in conjunction with induction therapy. I will try to explain why this therapy copes so well with the negative effects of the environment on humans.
