

A New Approach to Allergy Treatment

Compared to more recent times, we have to increasingly deal with the treatment of allergic reactions of the body, while it is often not even always clear what caused the allergic disease. This disease has become increasingly manifested in a wide variety of age groups of people and proceeds somewhat differently from the usual. AIC "IMEDIS" provides a variety of possibilities for the treatment and prevention of allergic diseases, but nevertheless it is noticeable that not long ago the methods that had proved themselves so well began to fail. So, for example, the classical desensitization of the body with its simultaneous "cleansing" by the BRT methods and the introduction of the appropriate nosodes or homeopathic remedies, which works so well for seasonal allergies to pollen, requires additional funds for success; or for example the treatment of allergic reactions to insect bites is often costly and the treatment lasts inadequately long. Situations often arise when allergic reactions lead to the resumption of already treated arthritis. It is becoming more and more difficult to cope with intolerance to lactose, fructose, a number of allopathic drugs, and just foods that have not caused any problems before.

From the point of view of epigenetics, both the onset and treatment of allergies look somewhat different. We will distinguish between two different qualities of allergy:

1. An allergic reaction is a consequence of a violation in the genome, or hereditary, or caused by a very strong external influence (for example, high doses of radioactive radiation or prolonged stay in a geopathogenic zone). According to the ART method "IMEDIS-TEST", this is checked as follows: through the test-index "genetic flaws" (for example, from the section "Biological indices") by filtration we test either the index for the presence of an allergic reaction, or the allergen, if known.

2. An allergic reaction is a consequence of the "recording" in the epigenome (for example, for due to strong stressful conditions of any kind, which also lead to a strong decrease in the reserves of adaptation, and this can be both purely psychological stresses, and an inadequate lifestyle that continues for a long time, and much more). By the ART method "IMEDIS-TEST" it is checked in the following way. In this case, we can very accurately conduct a study of the epigenome with the help of Medpharma drugs and very accurately determine the type of disorder and the place where rehabilitation therapy should be carried out. The sequence of measurements will be detailed at the workshop.

Depending on what etiology the allergic reaction belongs to, appropriate therapy should be built. Common to both types of reactions will be the mandatory inclusion of the correction of natural gene repair in general. But if in the first case it is possible to effectively use nosodes, special homeopathic remedies, the principles of Reckeweg homotoxicology, deep drainage of the body, etc., then in the second case, first of all, one should engage in therapy

at the cellular level, using, for example, preparations from the firms "GUNA", "Medpharm", "OTI", etc. Special attention should be paid to the state of mitochondria.

In reality, you will have to do both, but it is important to know how and in what sequence. Although scientific studies of the processes of controlling the work of the cell through the correction of the epigenome are still at the initial stage, thanks to the capabilities of the AIC "IMEDIS" we can determine both the degree of functional deviation in the epigenome (four stages) and optimize the work at the cellular level. In this process of optimizing cell function, a variety of viruses can be inactivated and cellular drainage initiated to maintain cellular metabolism. This method gives us new opportunities to explain the deep processes in the body when carrying out "old" methods, which have long been well used in energy-informational medicine, such as, for example, meridian therapy (especially the use of transverse meridians).

At the seminar, we will analyze in detail several specific examples: Conclusion: complex bioresonance therapy on the equipment of the Center "IMEDIS", carried out taking into account the correction of the natural reparative processes of DNA and support of cell functions, is a powerful tool for the treatment and prevention of allergic diseases, both congenital and acquired.
