

Frequencies of the gallbladder meridian in the practice of exogenous bioresonance therapy

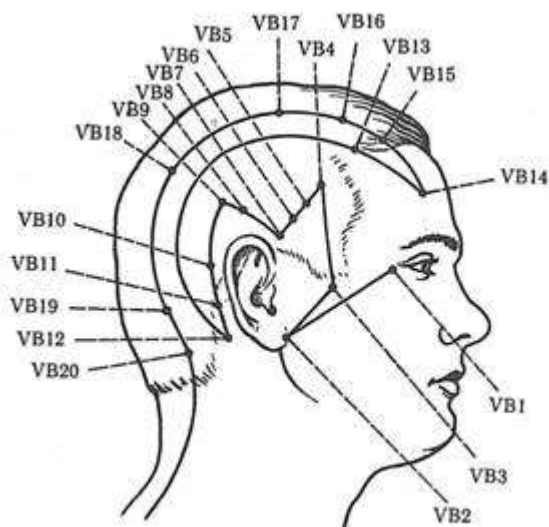

The meridian of the gallbladder (GB) is paired, centrifugal, belongs to the yang system. There are 44 biologically active points (BAP) on each side [1]. It has informational and functional relationships with various parts of the hepatobiliary system, as well as with the internal structures of the eye (retina, vitreous humor, optic nerve), various parts of the brain, neuroendocrine system, third teeth of the upper and lower jaw, joints and muscles of the lower extremities, bone marrow [2].

In reflexology, the meridian gallbladder (or VB, according to the French classification) is most widely used for a variety of diseases: decreased visual acuity, optic nerve atrophy, conjunctivitis, glaucoma, parotitis, epistaxis, pharyngitis, tinnitus, deafness, hypertension, pneumonia, bronchial asthma, pulmonary emphysema, mastitis, lymphadenitis, gastralgia, hepato-cholecystitis, nephritis, cystitis, hemorrhoids, endometritis, inflammation of the appendages, dysmenorrhea, orchitis, dermatoses, headache, dizziness, fainting, pathology of the trigeminal and facial nerves, and intercostal neuralgia, lumbago, paresis and paralysis of the lower extremities, muscle and joint pain of the lower extremities, epilepsy, neuroses, autonomic disorders [3].

As can be seen from the list of diseases, the gallbladder meridian (VB) is used very widely in reflexology (practically for any pathology of any organ or system of the human body). At the same time, oriental experts [4] believe that this meridian is especially important and is the main one in the treatment of all kinds of psycho-emotional and neurological disorders. A special role is assigned to the BAP located on the head (Fig. 1.)

Target given research: define efficiency frequencies,
corresponding points of the head of the meridian of the gallbladder (VB1-20), in the treatment of various diseases.

The frequencies corresponding to the BAT data are in the "Meridians" section of the "IMEDIS-EXPERT" program. Their selection was carried out through the index "Effective medication" (high potencies) Ferrum met. D800. Each patient was matched with a frequency in accordance with this index. Signal intensity was also measured through the Ferrum met. D800 and amounted to 30 units in all cases. The selected frequency was recorded on the sugar crumbs through a device for magnetic therapy "inductor". The dose of the drug (the amount of crumbs per dose) was determined using the same index. The frequency and duration of admission depended on the nature of the problem (acute or chronic) and was 1–2 times a day, with a gradual (as improvement) decrease in the dosage and frequency of taking the drug. All patients received only this drug, other procedures (BRT, induction therapy, etc.)

These frequencies were used in the treatment of 100 people aged 6 to 84 years, both men and women, with a wide variety of pathologies. Chronic inflammatory diseases of the upper respiratory tract (rhinitis, sinusitis, bronchitis) - 5 people; allergic rhinitis, conjunctivitis - 7 people; severe depressive syndrome - 2 people, and in one of the patients the depressive state lasted more than 10 years and practically ceased to respond to therapy with allopathic drugs and various methods of psychotherapy; phobias with panic attacks - 3 people; primary female infertility - 2 persons; skin diseases (eczema, neurodermatitis) - 4 people; chronic inflammatory diseases of the genitourinary system (cystitis, adnexitis, prostatitis, urethritis, pyelonephritis) - 11 people; various infectious diseases: helminthic invasions, toxoplasmosis, giardiasis, viral and mycotic lesions, bacterial infections (Staphylococcus aureus, Green Streptococcus) - 25 people; 41 people - patients with a variety of "bouquets" (hypertension, type II diabetes mellitus, periodontitis, severe vegetative-vascular disorders, psycho-emotional problems, diseases of the spine, cephalalgia, hepato-cholecystitis, gastro-duodenitis; and all of the above taken together and in all possible combinations).

With the appointment of this drug, treatment began after the initial diagnosis and identification of existing disorders and leading pathophysiological links. In some cases: infertility, depression - a course of treatment with an appropriate selected drug for 2-3 months completely solved the problem. At the moment, 2 healthy children have been born, 2 patients have come out of depression. The rest of the patients showed a significant improvement: complaints disappeared or significantly decreased, control indicators, such as biological and photon indices (almost to the age norm), increased, the reserves of adaptation from exhausted

(to one degree or another) to low, the psychological load decreased, the indicators of hormonal levels, the state of immunity improved (according to the parameters of ART "IMEDIS-TEST"). Some of the patients with a fairly good state of health (26%), at this stage, arbitrarily completed treatment and stopped visiting a doctor. The rest continued the treatment according to the scheme developed by us.

It is characteristic that a pronounced positive effect was obtained in almost all cases. If there were any difficulties and problems in the treatment process, then they were all associated with inaccurate selection of the drug. After correction and drug change, further treatment was successful.

The most interesting thing in this study is that observing how these frequency drugs work, the following was revealed: the frequencies of the gallbladder meridian corresponding to the points of the head (VB1-20) show versatility in comparison with any other frequency drugs available in the IMEDIS program. EXPERT "and used for exogenous bioresonance therapy. These frequencies make it possible to treat not a disease, but a person, regardless of the nature and number of pathological processes. It is only necessary to accurately select the appropriate frequency for each patient, and then they provide, at this stage of treatment, the greatest depth of therapy in each specific case. This is very similar to the principles of the constitutional homeopathic remedy (CHP). And judging by all the results,

Research in this area is still ongoing, and, according to preliminary data, this or that point of the gallbladder meridian (and, accordingly, the frequency) has a certain relationship with a person's age. But this assumption is still in the research phase.
