

Application of essences "Rostok" in bioresonance therapy in patients in a state of energy depletion

Introduction

In the last decade, it has become noticeable that various scientific areas related to human cognition have entered a certain crisis state. Despite all the advances in medicine, the improvement of existing methods of diagnosing and treating the physical body of a person, people continue to get sick and die from diseases and do not receive adequate treatment.

One of the main reasons is that a person is not considered as a multidimensional model - only the physical body is examined and treated.

Man is in himself a Microcosm and a particle of the Macrocosm, which reflects the multidimensional structure of the Universe. It is a complex, highly organized, self-regulating and self-healing system. A complex biocomputer network controls bioenergetic and biochemical processes at all levels through forward and backward channels. The result should be adaptation and balance in the physical and psycho-emotional state of the body.

But we are witnessing how rapidly our world is changing in all respects, and the human body is increasingly losing the ability to adapt and self-heal. There is a blockage of inter-level connections, systems and subsystems, and we observe this in the diagnosis and treatment of our patients.

The use of equipment and therapeutic techniques "IMEDIS" gives the doctor unlimited opportunities to stimulate the adaptation and self-healing of the human body. Since November 2012, we have started using Rostock Essences in their original form for the treatment of our patients. We noticed some correlations between the use of Rostock Essences and other preparations and began to use them in our daily work.

Thanks to the kind support and responsiveness of Mrs. Nikola Volgemut, it became possible to successfully use the Rostock Essences in combination with the IMEDIS equipment.

Materials and methods

Over the past three years, more than 2500 patients aged from 1 to 85 years have been examined by the methods of ART and segmental diagnostics. In general, there is an increase in the body's pollution from the environment, harmful food, an increase in viral and allergic diseases and daily stress. This trend, unfortunately, is observed all over the world. The number of patients with blockages, low energy and chakra dysfunctions has increased. In these patients, conventional BRT strategies do not work as expected.

Very emaciated patients cannot tolerate bioresonance therapy at the beginning of therapy.

The patients were divided into five groups according to their condition:

1. Children with low energy, with a very depleted immune system due to a combination of allergic, viral and bacterial diseases.
2. Elderly, chronically ill patients with many diseases, who take a lot of medication.
3. Young patients with serious medical conditions, such as chronic renal failure without dialysis.
4. Patients suffering from chronic fatigue syndrome.
5. Patients with depressive episodes taking many medications. All patients were examined and cured using the IMEDIS equipment. Since the beginning of our work, we have been using the APK "IMEDIS-EXPERT" - a unique diagnostic and treatment complex.

Accordingly, individual patients were selected through testing appropriate test indicators, for example, the depletion of the immune system, focal load, adhesions and scars, the main affected organ. Pointers to chakra disturbances have also been tested.

The therapy strategy was also strictly individual:

1. For very malnourished patients, only Essences were used. "Rostok" - M1, M7, M41, SOM3, SOM8, SOM18, SOM22, SOM23, LM7, C5, C6, C7 in the form of drops. At the second visit, it was noted that the patients already tolerate endogenous BRT well.
2. The potentiation of the influence between the Essences "Sprout" and Biooscillators from Guna (Dr. Roy Martina). Essences Rostock and Cell Plex preparations are especially successfully combined.
3. Endogenous BRT with the connection of Cell Plex drugs, drugs and Sprout essences have a pronounced tonic effect.
4. Orgone Energy preparations were also suitable for some patients. "Medpharma" and chakra drugs and therapy.
5. Thanks to Mrs. N. Kempe, head of the Institute of Biosensorics, we have there is a large selection of information products. First of all, Enzyme and DNA preparations were suitable for the patients. They were added to the 4th container of the apparatus during therapy.

Only after energizing the patients did the applied BRT strategies have a successful impact.

During BRT, patients were often given a few drops of Rostock Essence to take. Essences were also added during BRT to the 2nd or 4th container of the BRP apparatus and recorded after the end of BRT without the patient. All patients were also prescribed 2 liters of water activated with essences for further therapy.

Conclusions:
