Fundamentals of drafting the concept of therapy in energy-information medicine

The development of energy-informational medicine goes hand in hand with a change in the paradigm of the concept of the function of living systems. Beginning in the late 19th - early 20th centuries and the increasing use of energy-informational medicine methods for both diagnosis and therapy has now led to the emergence of a very noticeable independent direction for the treatment of diseases in humans and animals in many countries. And although over the past 50-100 years in evidence-based science and empirical medicine, a holistic view of the development and functioning of all living things as an integral system is increasingly beginning to appear, the principles of symptomatic treatment still dominate. This, naturally, left its mark on the development of treatment methods in energy-informational medicine, especially in its early stages. At the moment, we are witnessing an interesting convergence of ideas about the functions of living systems. The IMEDIS system, which is still the most scientifically-volumetric and has the greatest capabilities of all the options for diagnostics and therapy with non-invasive energy-informational methods, gives us invaluable opportunities for correcting dysfunctions of living organisms against the background of the possibility of constant monitoring of the therapy. The quality of the treatment carried out and, especially, its final result depends on the choice of the most optimal sequence of informational influence on the living system, i.e. from the correct choice of the concept of therapy for a particular individual. It seems to us that in order to obtain convincing results of treatment, doctors must develop systems thinking in themselves.

Only systemic therapy can cure or bring to a possible life-acceptable result such diseases as multiple sclerosis, cancer, HIV, cope with dangerous infectious diseases, prolong the comfort of a person's life until the last day of its natural biological border, cope with the diseases of civilization (arthritis-arthrosis , gout, asthma, allergies, etc.) and with a range of problems such as infertility, obesity and much

other.

In this case, systemic therapy is understood as therapy that takes into account the causes and development of dysfunctions in the body, maintaining the natural processes of repair and maintaining homeostasis, teaching the body the ability to “cope” with a similar situation in the future and, finally, helping in overcoming symptoms if they are eliminated by the body itself takes too much time, thereby complicating the patient's life (sometimes to the point of impossibility). Therefore, the optimal therapy must be very thoughtful. It must take into account the hierarchy of natural processes in the body, must go clearly with an understanding of the action and interaction of individual subsystems (immune, endocrine, reactions of parasitic inclusions and much more), take into account the laws of evolutionary and space biology and, especially, the laws of control of open developing systems (biocybernetics) ...

These principles of designing therapy should be taken into account in evidence-based medicine, to the best of the possibilities available there. Life shows that energy-informational therapy has much more opportunities for this.

The IMEDIS system has immense possibilities, offering us practically everything that is available in science and empirical knowledge. On the one hand, this is great, but on the other hand, it is not easy to choose the best option in each specific case. Dysfunctions of the body are very individual, and the laws of control of living systems are just beginning to become clear (the results of cognitive processes in cell biology, the interaction of the genome and the epigenome, multilevel interactions and autonomy of individual body systems, the dynamics of the morphogenetic control field, new possibilities of the biochemistry of the organism, and much more).

The IMEDIS system offers us ready-made examples of a systematic approach and contains a number of control information packages to test the suitability of certain methods and to agree and optimize individual elements. Moreover, the IMEDIS selector contains electronic copies of both allopathic drugs of evidence-based medicine and some other drugs related to its concomitant methods, for example, herbal medicine, lithotherapy, etc.

The first step in such a systematic approach was the therapy proposed by Yuri Valentinovich Gotovsky with a general and a particular bioresonance drug (OBR, CHR). Therapy simultaneously from above and below in a complex interconnection of the general system and its individual subgroups.

5 strategies of bioresonance therapy by Yu.V. Gotovsky. Without going into the super-complicated details of functional relationships, we carry out deep systemic therapy here. It is clear that this idea can be further developed by creating new and interesting strategies. These methods work great for both acute conditions and chronic diseases. Absolutely unique results are obtained with rehabilitation therapy after a stroke and with the therapy of one of the paired organs. Here we use the fifth strategy, where the patient himself is the donor. We shoot for this

information from a healthy organ or a properly functioning part of the body. True, with this very effective therapy, the constant external influences of the environment on the body and deep mental stress are almost not taken into account.

Moreover, in the "IMEDIS" system, complex drugs are well represented, linking the development of individual dysfunctions and their elimination with the help of a set of complex therapeutic information packages linking mental and material processes. These are drugs "LINDA'S", "GUNA" (especially "Biooscillators"), the generalized system of integrated phototherapy and homosynergic drugs "BIOGROUP", homeopathic complexones "HOMEOPHARMA", which help to use homeopathy and organopreparations in a completely new way, the system of dynamics of detoxification of Reckeweg, functional Schimmel chains and many others. All these are ideas and developments of a whole galaxy of scientists and physicians, who are striving for systemic solutions in therapy, transferred to a purely informational level.

The IMEDIS system has included in its powerful arsenal a completely new type of informational influence - resonance-frequency therapy, created for a purely field effect on the informational structure of the body's control: these are frequency complexes of P. Schmidt, R. Rife, V. Ludwig, R. Voll and etc. Frequency bioresonance system includes many necessary electronic copies of control systems for alien cohabitants of living organisms - parasites. Frequency resonance therapy allows for pure energy therapy. In addition to new developments, this includes the whole range of energy concepts of Indian and Chinese medicine

And, finally, a large group of informational preparations in the field of cell biology and genetics ("MEDPHARMA") has been introduced into the "IMEDIS" system.

Unfortunately, not only for novices, but also for long-working doctors, it is not easy to understand this huge number of offered possibilities.

What should be the optimal therapy regimen?

First step. Assessment of the state of the cellular set of the organism and optimization of intracellular processes, since without this a real correction of the body's functions, which brought the body into a state of illness, is simply impossible.

Conducting evaluative diagnostics, the best is segmental diagnostics, but it is also possible using the method of R. Voll. In both cases, quadrant measurements are carried out as the first measurement - energy assessment.

We propose to proceed from the fact that in any organism, first of all, all processes at the cellular level should function optimally, both in the cells of the organs themselves, and in completely differently structured cells of the immune system. This includes the control of individual elements of cells and, first of all, DNA (the correct composition of enzymes, the state of its four constituent elements). In this case, it is necessary to check and, if necessary, immediately include in the therapy the dynamics of reparative functions (programs E354, E424, E463 and E802) and the state of the channel for receiving information by the cell,

necessary for its functioning. These may be chakras, especially Ch9-Ch12, but it is especially important to track whether the main channel connecting the body with cosmic information is open (for example, the drug Rostok M11, Bridge to knowledge). Further, the therapy circuit should at least include the pre-tested frequencies of equalization of the state of the sympathetic and parasympathetic nervous systems (E186, E13, E131, E44 and E60), Schumann frequency 7.83 Hz, frequency of removing negative environmental effects 6.2 Hz ; tested frequencies of input, output and flow of energy (E18, E11, E96, E106, E114, E61, E82, E60, E64, E176, E90, E220) and frequencies of vital energy, the so-called. universal frequencies E96, E212, E539.

It is best to conduct this therapy as a bioresonance therapy in a time modulation mode with a fast search of frequencies. The busting period is selected in the range of 1-3 Hz, the therapy time is determined by testing through the Chronos drug, at low potencies - 6-8 minutes (the older the patient - the longer), at high potencies - 10-20 minutes. Further, in any case, another 5-8 minutes of therapy is carried out with the frequencies of elimination of toxins (E33, E36, E140, E171, E349), since this program immediately triggers many chemical reactions of different quality, and not yet optimal metabolic processes begin.

During bioresonance therapy, a wide variety of drugs can be connected from the selector. During the last 120-150 sec. the drug is recorded either simply with the continuation of the patient's therapy, or without it. The prescribed drug is tested and the regimen is determined. Numerous aspects of this stage will be discussed in detail at the workshop.

After that, a control measurement is made: segmental diagnostics or measurements by the method of R. Voll. Typically, after therapy, the patient begins to noticeably improve, it can be scheduled for a second appointment in 2-4 weeks. Moreover, this is usually even in acute conditions. It is important that the analysis of the results of segmental diagnostics, both the current state and integral parameters, will predict a further change in the state of the organism - where normalization will clearly begin, and where there may be problems.

The second stage is devoted to the correction of the functions of the immune system.

At this stage, we also start with segmental diagnostics. Further, the individual functions of the immune system are monitored, both with the help of the drugs available in the selector, including using the capabilities of the vegetative resonance test (ART) "IMEDIS-TEST", and through the resonance frequencies. Here it is important to find out not only the state of the immune system as a whole (tension, exhaustion, etc.), but also the state of its individual elements and processes (the state of the thymus, the state of T and B lymphocytes, the processes of phagocytosis, the state of the spleen, leukopoiesis, the state of the bone It is very important to check the infection of lymphocytes with viruses! It is this fact that is decisive in the treatment of a number of diseases, especially such serious ones as multiple sclerosis, arthrosis of various types and cancer.

chemistry cannot fix the situation! To determine the state of lymphocytes, we have a whole set of frequencies, for example, six groups of lymphocyte viruses (about 35 frequencies of the E- and H-groups) and several drugs in the selector, for example, the LSM virus or "T-lymphocyte defect". It is necessary to carefully check the infection of lymphocytes and macrophages with the Epstein-Barr virus. After testing, therapy should be carried out to correct the immune system.

There are many possibilities for this therapy, but the structure remains the same. Again, this should be a complex therapy. Against the background of bioresonance therapy with time modulation, where the frequencies of infection with lymphocyte viruses tested, as indicated above, and also tested frequencies of strengthening the functions of the immune system (for example, E9, E57, E186, E42, E29, E570, etc.) are selected, to enhance phagocytosis, frequencies of elimination of toxins and reparative processes in DNA must be introduced again. The search time is very short here too - 1-4 sec. A wide variety of drugs can be connected from the selector. Their number and quality depends on the level of experience of the therapist. One of the interesting possibilities is the introduction of drugs that have a strong effect on the morphogenetic field, for example, drugs from the Aura Soma group, ayahuasca, Mexican chest, creosote, drugs "Rostok" and many others. It is good to connect Metatox drugs. At the end, the drug is recorded, preferably with water. In this case, it is especially important to use also a tested preparation of special water - Renorm. Several examples will be sorted out at the workshop.

After these two stages, the true cause and type of the disease is clarified for the doctor. In very many cases, the diagnosis is not at all the same or very little coincides with what was said at the first visit. In some cases, some patients already after the second stage normalize their homeostasis so that they can be assigned to control only after 3-5 months.

In the third stage, we begin to deal with specific dysfunctions, having previously analyzed the control measurements of the previous stage. Experience shows that in a significant proportion of patients, the symptoms with which they came to the first appointment disappeared or significantly weakened. This is quite understandable, since the state of the cells is optimized, the immune system is working at full strength, and natural reparative processes have solved many problems. In most cases, the body knows best what to do to optimize the maintenance of homeostasis. But since the external effect on the body can be very dynamic and multifaceted, on the contrary, new symptoms may appear. Therefore, the attending physician must take into account these circumstances (they can be of both a field, mental, and a purely material plan).

It is simply impossible to describe all of these therapy concepts in a short talk. This will be done at the seminar using specific examples, but some generalizations that we can make based on five years of experience with this system, we suggest below:

1. At all stages of therapy, patients feel a noticeable improvement, which is very increases confidence in the attending physician; as a rule, they already have some experience

treatment by other methods, often crammed with the simultaneous administration of several allopathic drugs at once with all the ensuing consequences, or underwent not very sparing treatment procedures, for example, chemotherapy, radiation and many others, the consequences of which are often quite frightening. Therefore, they are pleasantly surprised that they feel better, pain and minor disorders go away, more energy appears and hope for recovery begins to appear. This is very important for long-term chronic diseases.

2. The diagnosis is being clarified. We have repeatedly observed that terrible diagnoses, despite highly sensitive diagnostic methods with modern high-tech devices, they are not confirmed. However, we work closely with evidence-based medicine doctors, and where circumstances permit, we analyze the situation together. Especially often we observed that not always a high PSA factor is necessarily associated with oncology, that the diagnosis of liver cirrhosis is simply a strong infection with the fasciola hepatica parasite or a consequence of the action of some very aggressive toxins, that the diagnosis of scleroderma is a severe metabolic disorder that causes collagenosis, and the simultaneous invasion by specific subcutaneous parasites (it is perfectly treated with the equipment of the IMEDIS Center) that conjunctivitis of newborns and pneumonia following 3-4 days after it is an infection with chlamydia, which immediately after childbirth begin their march from serovar to serovar. The disease is very easy to treat with the equipment of the IMEDIS Center, and the use of antibiotics sharply worsen the situation. Especially dramatic situations arise in the diagnosis of cancer and multiple sclerosis. 3. A little about mental disorders (children's hyperactivity, depression, consequences of severe mental shocks, the onset of schizophrenia, general stabilization of the psyche, etc.). In these cases, the systems approach described above also helps a lot. In addition to the above, we actively use induction programs in conjunction with modern concepts of psycho-neuro-immuno-endocrinology. At the seminar we will dwell on this especially. Here, in addition, we control the state of the genome and, as far as possible, influence the epigenome, eliminating errors in the genome that have arisen for many reasons. Medpharma drugs provide us with a wide range of diagnostic and therapeutic options. Especially great satisfaction is given by working with children, since we always have success there. The basics of this work were laid by a geneticist from Latvia, Inara Keisha, helping children with Down syndrome with the help of the IMEDIS Center equipment. Almost 20 years ago, together with Inara, we carried out a pilot project to improve the condition of the so-called mentally retarded children in the Hartheim boarding house in upper Austria. The project was very successful. We have adopted many of these methods in our work with children with disabilities. An example will be discussed at the workshop.

A few words about parasites in our body. Currently, we have greatly changed our understanding of this circumstance and we see not only the destructive action of parasites, but also the existing symbiosis created over thousands of years of evolution. For example, we are now using the treatment of Crohn's disease with rhinitis viruses with great success, removing patients from the constant use of cortisone (examples at the seminar). By the way, the science for evidence-based medicine is now seriously engaged in this method. The fact that the Nobel Prize in 2015 was awarded to three doctors for their many years of research in the field of parasitology (especially helminths) of the human body and, in particular, for new ideas for eliminating malaria, confirms the correctness of our thinking!

The equipment of the IMEDIS Center provides many opportunities, but in order to use it effectively, one must learn to think systematically. And, finally, systems thinking in our highly dynamic age of development of all living things and society as a whole will help each of us better navigate this rapidly and unexpectedly changing world. The old proverb "Live and learn" is very relevant now.
