

Getting rid of addiction IN. Rybko (Kursk, Russia)

Introduction

This work draws your attention to the problem of mind control using the example of the influence of a sect. Everyone knows the fact that such a tool as mind control can be used both for the benefit of a person and to his detriment. For example, positive mind control can be used to help people quit smoking without affecting other behaviors. The destructive side is manifested when, with the help of such a tool, a person is seized, leading to a violation of a person's ability to think and act independently, which makes it possible to use this person as efficiently as possible for their own purposes. There are usually several goals - these are power, material enrichment, the massive implementation of their ideas, obedience - the creation of a group with completely controlled consciousness.

Control of one individual over another is possible by introducing his own program into him, acting only for his own benefit. For this, there are means and ways to achieve your goal. Conceptually, for success, it is necessary to penetrate into the consciousness of a person, creating, along with the I-personality of a person, a False-I in the form of a part of the personality of a "guru" would be the formation and development of a person).

It is quite understandable that a "gura" must have mystical, spiritual, intellectual or successful super qualities, which are not yet in the adept, but he would like to have them. The businessman - the leader of the sect must accurately understand his audience. Namely, those to whom his activities will be directed. These are people who strive for power, for the "salvation of mankind," "unique in their uniqueness," thirsting for the acquisition of mystical and "spiritual" abilities. Psychologists also argue that people with traumatic events in childhood, adolescence, lack or complete absence of a basic feeling of love, brought up in an incomplete family, with a violation of the system of internal images of "MOTHER AND FATHER" are at risk. Such aspects in the future can lead to problems of choosing a pair and keeping it. It is easy to carry out the work of the "guru" in case of loss, associated with the death of loved ones: husband, wife, parents; with the formation of a family void. Divorce, loneliness, unhappy marriage with an unloved person - all this leads to the need for a surrogate family. But even having found such fertile ground, it is not so easy for "gure" to overcome the resistance of common sense. In order to integrate your idea as a part of the personality, "gure", it is necessary to wrap it in a harmless, "useful" shell (by analogy with the story of the "Trojan Horse".) push through hidden information. The effect of the impact is enhanced with a large crowd of people participating in the event. Indeed, in a crowd, the level of self-criticism and detached attitude to what is happening is usually sharply reduced.

The process of gaining control over consciousness can be divided into three phases. The first is "unfreezing", which includes disorientation, confusion, sensory and physiological deprivation, hypnosis, NLP (neuro-linguistic programming) in relation to the person being "implanted". At the same time, its own identity is partially called into question, especially in relation to the assessment of past memories (for example, the suggestion of false positive memories, or, on the contrary, the re-comprehension of positive memories as negative events in reality).

The second stage is "change". It includes the step-by-step imposition of a new "identity", the use of techniques of encouragement, punishment, blocking of thinking, and control of the surrounding information environment. Application of individual and group techniques of hypnosis and mystical manipulations (singing, rhythmic repetition, prayer). In a similar way, the individual reality is gradually replaced by the reality of the group (sect).

And the third phase is "freezing". Full implementation of the "guru" identity in the personality of the individual with separation from the past (this includes the loss of contact with relatives and friends), the transition to activities within the framework of the accepted cult. Active recruitment of other adherents, transfer of property and funds to the sect. Outwardly, this sometimes manifests itself in the purchase of new clothes, in updating the hairstyle, in the manner of speaking, in the appearance of a new "family". A person feels himself surrounded by human and "universal" love, although he does not yet know that the adept has a separate one-room apartment. Perhaps the formation of new couples with new role models, active participation in seminars, practices, secluded from society, recruiting new adepts. A set of such manifestations is considered by psychologists, especially Western ones, as clear signs of a virus information program (VIP). Having penetrated into the consciousness of a person in the form of a part of the personality of the "guru", this program leads to the splitting of his consciousness. That is, dissociative personality disorder occurs. Dissociation (translated from Lat. - division) is an unconscious process that separates mental functions and the inner personality of a person into separate components isolated from each other, in fact, into several conflicting subpersonalities. Each of the subpersonalities, endowed with its own individual energy and needs, begins to defend its own interests, deploying its own program of self-fulfillment, which leads to a conflict between them, and as a result - to the inability of the person in whom this conflict occurs to carry out his own program of self-fulfillment.

- the inability of a feminist (for example, a woman psychologist dealing with family problems) to create and maintain her own family and raise children;
- the inability of a professional athlete - a person who has gone into sports to prove his physical superiority - to maintain a healthy

- lifestyle and, as a result, to health and longevity;
- the inability of the player - a person striving for easy earnings - for this very easy earnings (since the resources necessary for this have not been accumulated)
- etc.

With a malignant course of the process, a kind of "military coup" is possible - a complete capture of the human psyche by the subpersonality embedded in him and the transition to the implementation of someone else's, not originally characteristic of him, the program of self-realization. This, of course, a more rare outcome, is typical, for example, for the deformation of the human psyche in a country undergoing fascistization, in real destructive sects and extremist organizations.

The danger of both complete and partial dissociation is great, primarily because the vast majority of people unconsciously strive for it. This is due to the fact that in the mind of an unprepared person, such a dissociation is identified with a resource set in the form of certain roles and masks, external stereotypes of behavior and altered states of consciousness, which, as it seems to him, give more opportunities to fulfill their desires. The fact that roles and masks have an unpleasant tendency to come to life, capturing the psychic space of the owner, is usually simply not realized by the person.

Moreover, various subpersonalities often have different manifestations at the physical level, as evidenced by the presence of various diseases, individual for each of them separately. This is illustrated in F. Putnam's Diagnosis and Treatment of Multiple Personality Disorders. Undoubtedly, complicating the effectiveness of not only diagnostic testing, but also therapy in general.

An analogy can be drawn between the action of alien information in the form of mind control with the appearance of the stealth aircraft in the United States "STEALTH". At the first stage of creation, the American radar did not see the plane. But when several of our radars were pointed at the same plane from different directions, the plane was detected. For example, in modern MANPADS (portable anti-aircraft missile system), a combined method of targeting is used: optical, infrared (by heat trail), laser, and STELS technologies will not be able to help here. So in our case, the information-viral program (IVP) in the form of the "subpersonality of the guru" is invisible to the body, since it is hidden in the shell of a common human idea (Trojan horse). But if you highlight this problem with several "radars", then the object will be detected and adapted to the healthy part of the person's personality.

From my point of view, the system-nosological approach of K.N. Mkhitarian, where the system of "radars" for detecting the "invisible subpersonality" is various degrees of amplification of the KMX (KMX1, KMX2, KMX3, etc.).

If we proceed from the holographic system of the world, then the main approaches in treatment are associated with: correcting a physiological problem, restoring the integrity of the family system (adaptation and acceptance of parents and spouses), presenting the body with a viral information program with further

adaptation to the "portrait of a guru", the use of SDA in the therapy of the viral information program.

Practical part

The idea of using the ART and BRT methods to correct the consequences of consciousness control arose after the treatment of a similar problem by patient K. in 2013. Based on the methodology of bioresonance therapy and psychology, a treatment plan was drawn up, including three approaches:

- work related to solving problems at the level of physiology;
- adaptation of the family system;
- "unfreezing" of the subpersonality in the form of the image of the "guru".

In September 2013, the husband of patient K., 48 years old, who had previously been observed by me, turned to me. He asked for help as he began to worry about the very close merging of his wife with a group of people conducting and distributing women's seminars and trainings. It was unusual that, on the one hand, people do not drink, take care of their health, develop the feminine principle. But, on the other hand, something new appeared in the personality of his wife, some alien part, which lost self-criticism and objective assessment of the actions of the head of seminars and trainings. According to the spouse, his wife developed an obsessive desire to actively disseminate the ideas of her group, and at the same time there was a feeling that the people around her were blind and did not understand the obvious (for her) things. A week later, patient K. (with the participation of her husband) complained of pain and discomfort in the right knee, aggravated by exertion. She associated the appearance of these pains with the beginning of training at the Women's Training. My joking statements about the role of the personality of the training leader caused an inadequate negative reaction in my direction. In the conversation, it was clarified: a problematic relationship with his father, an unhappy first marriage that ended in divorce. In the woman's voice, there was a great resentment hidden on them. It was suggested that she was influenced by mind control from the group, the ground was set for a return visit, and the appointment was postponed for a week. After that, I had a conversation with my husband about the tactics of behavior and prevention. The advice was to increase attention to the wife, patience and non-resistance in an active manner, since any information-viral program requires attention to ensure vital activity, and a sharp negative reaction is its replenishment, causing even greater resistance from those who have come under its control. The patient was invited for re-treatment, and I asked in advance to take with me photographs of my father, mother and first husband, as well as a photo of the "guru".

The information program introduced inside has its material manifestation at the level of physiology, biochemistry, psychology and fate. The therapeutic approaches in this work can be divided into two parts: the first is preparatory and the second is the main one. The preparatory part includes two levels of treatment: physiological and psychological. In the second part, therapy is aimed at correcting the influence of the information-viral program in the form of consciousness control, direct methods of correcting the influence of control

consciousness from the outside.

Materials and methods of diagnostics and therapy

For diagnostics and therapy, an apparatus was used for electropunctural diagnostics, drug testing, adaptive bioresonance therapy and electro-, magnetic and light therapy according to BAP and BAZ "IMEDIS-EXPERT" the original measuring level).

The sequence of the preparation of therapy drugs
The sequence of stages in the manufacture of bioresonance preparations:

1. KMH was recorded. Recall that an individual marker (KMX) 1 is the sum of signals written off from the end and nodal points of the main chiroglyphic lines of the patient.
2. Based on the patient's complaints, a group of organopreparations was tested knee joint (lowering the measuring level during testing), hereinafter referred to as Σ Organotherapy.
3. An electronic autonosode of the patient's urine (ANMoch.) Was made, which then it was potentiated electronically until the VRT condition was met:

By compensation drug NANMoch. marker targeting
 $(KMX1 + \Sigma \text{Organopreparations})$ the therapeutic dose contour was defined
of the Drug No. 1 - 4 grains.

4. The purpose of the manufacture of the second drug is aimed at intrafamilial adaptation. Before the preparation of Drug No. 2, the patient took a therapeutic dose of Drug No. 1, after which a marker (KMH) 2 was made. A recording of the cerebral response was made after the patient viewed photographs of her father and ex-husband, in the form of a preparation Off_3 (photo of father + ex-husband). Then the preparation No. 2 was made, which fulfills the condition $(KMH) 2 \downarrow + \text{Pot-Off}_3 \text{ } \text{zs}(\text{photo of father and ex-husband}) -.$

Preparation # 2 was received: $\text{Pot-Off}_3 \text{ } \text{zs}(\text{photo of father and ex-husband}) / (KMH) 2.$

By compensation (CMH) 2, the therapeutic dose of the drug was determined: 5 globules.

5. After the patient has taken a therapeutic dose of Drug No. 2 the production of the following drug was made, which is the main part of the therapy.

The main part of the treatment comes from the understanding that, firstly, the patient has a certain predisposition to influence in the form of a certain emptiness, and part of the "guru" personality just complements what is lacking, what is lacking to complete self-identification. In this sense, the information program works like a drug that brings euphoria and relief, which subsequently becomes addictive and strong attachment.

Emerged idea homeopathic use of information-viral programs of consciousness as medicine. For this, the preparation No. 3 was made. For this purpose, the marker (KMX) 2 was first amplified to (KMX) 3. Next, a recording of the cerebral response was carried out (the patient viewed the photograph of the "guru" for 5 minutes). 2(portrait of "gura"). Off2(the portrait of the "gura") is divided into two parts, 5 grains each. The second part of this preparation will be used at the very end in the manufacture of the fourth preparation.

6. A therapy drug has been received that fulfills the following condition:

(KMX) 3 - on Pot-Off2(portrait of "gura") -, with the receipt of the third drug Pot-Off2 zs(portrait of "gura") \ (KMH) 3. By compensation (KMH) 3, was the therapeutic dose of the drug was determined - 6 globules.

7. The next stage of therapy is associated with the idea that information-viral the program has a narcotic effect on human consciousness. Causing euphoria, pain relief, giving new strength to life. Just as a drug is embedded in synapses and changes the conduction of a nerve impulse, so a program in the form of a "portrait of a guru" is introduced into a person, splitting it, changing the essence, distorting reality. The mechanism of action of drugs for the treatment of drug addiction consists in "knocking out" and replacing the narcotic substance from the nerve synapses, replacing them with the means of therapy. The idea of using SDA information drugs (Runes, symbols of Goetia) for therapy with their possibility of replacing the viral program with a healing program was put forward.

After the patient took a therapeutic dose of the Drug No. 3, a marker with amplification (KMX) 3 to (KMX) 4 was made. Received the fourth therapy drug that meets the condition (CMH) 4 + Off2(Portrait of a "guru") on the SDA - (or possibly Σ SDA).

C obtaining the fourth drug SDA / ((KMX) 4 + Off2(Portrait of a "guru")). By compensation (CMH) 4, the therapeutic dose of the drug was determined - 3 grains.

Preparations received:

1. Preparation number 1. Targeted urine nosode, targeted regeneration drug, physiological level of therapy, 4 grains were taken 3 times a day for a month. The patient took the therapeutic dose.

NANMoch. = ANMoch ./ (KMX1 + Σ Organopreparations).

2. Preparation number 2. Adaptation of intrafamilial relationships, adopted by 5 grains 2 times a day for three weeks, a week off and two more weeks.

Pot-Off3 zs(photo of father and ex-husband) / (KMH) 2.

3. Preparation number 3. Homeopathic level of therapy, the drug was taken according to 6 grains 2 times a month.

(Portrait of the "guru") / (KMH) 3.

4. Preparation number 4. Informational and antiviral therapy level, 3 grains were taken for two weeks, a week off and then for three weeks.

SDA / (KMX) 4 + Off2(Portrait of the "guru").

Therapy results

For a second appointment, in January 2014, the couple came together. The wife laughs as she tells the story of her interaction with the network marketing sect. Family relations have returned to normal, there are no complaints from the right knee. Organopreparations are not tested. At the request of the spouses, an additional psychoemotional correction was performed with Bach Flowers.

conclusions

Destructive control of consciousness, the result of which is a split personality, leads to a violation of a person's ability to think and act independently. We often encounter this phenomenon both in everyday life and in practice, and it is diverse in its manifestation. It is important to understand that separate subpersonalities can have different goals, programs of action, up to various physical diseases in the body. This undoubtedly complicates the results of both diagnostics and therapy in general. The effectiveness of the correction of various conditions depends on the preventive focus of our work. The above example shows that a timely understanding of the ongoing processes allows avoiding serious consequences. And often formal things - the lack of warmth, love in a person's life, rejection of parents and loved ones - take such forms, distortion of which can lead to irreparable consequences. Using the methods and approaches of bioresonance therapy allows you to determine the range of problems, give a person a chance to look at himself with new eyes and understand who I am and where I am.
