Szondi's test - Wonderful meridians. VRT version. A new way of recording information for homeopathic remedies I.A. Bobrov, P.D. Bizyaev, K.N. Mkhitaryan (Moscow, Russia)

L. Szondi's test was created at the beginning of the twentieth century on the basis of the "portrait elections" method, which became the basis of the test and, accordingly, the theory of eight drives, which grew into the doctrine of fate analysis [1, 2, 3, 4]. The essence of the method is to provide the subject with a series of portraits depicting people with various mental illnesses. L. Szondi considered the persons represented in the portraits as representatives of one of the eight "drives" conditioned by a certain (basic) need. There are eight groups in total, united in pairs: patients with paranoid and catatonic forms of schizophrenia; mania and depression; epilepsy and hysteria; sadists and persons with sexual behavior disorder. The subject should choose the most pleasant or unpleasant portraits.

In turn, the eight drive factors are combined into pairs, consisting of opposite drive factors, determined on the basis of portraits of clinically polar manifestations. Thus, four vectors of drives are formed.

According to the development of L. Szondi and his followers, these eight paired drives determine not only simple behavioral reactions, but also the entire fate of a person, that is, the choice of friends, spouse, profession, illness and even death. The developed approach reflects the objective laws of the functioning of human psychophysics, which has a genetic basis.

Comparison of the descriptions of the properties of four pairs of Wonderful meridians with four pairs of eight drives by L. Szondi reveals a significant number of coincidences. And the experience of use by the authors confirms that we are talking about the same functional systems that determine the state of chronosemantic, that is, biosocial homeostasis, which determines the indicators of homeostasis depending on temporal parameters and social tasks [5, 6].

The experience of one of the authors has shown that the use of the Szondi test to determine the balance of the Miraculous meridians in the human body and the choice of the Miraculous meridian for therapeutic effects greatly simplifies this procedure and increases its reliability.

Clinical example 1

Patient P., 38 years old. The diagnosis is chronic prostatitis, lumbosacral sciatica. Initially, allopathic treatment had practically no effect, as a result of which the patient turned for homeopathic and acupuncture treatment. Basic homeopathic treatment was carried out using constitutionally close (mainly Staphysagria and Pulsatilla) and symptomatic homeopathic remedies, as well as courses of acupuncture with

taking into account the constitution within the framework of the FS concepts of the five elements and the eight World Championships (as the author believed at that time). The selection of homeopathic remedies was carried out on the basis of repertorization according to the Kent repertory, followed by testing by the ART method. As markers of constitutionality, we used the KMX marker, pineal gland D28, and preparations of embryonic leaves. The choice of a reflexotherapy recipe was made on the basis of EPD, as well as descriptions of the constitutions of the five elements. The main features for describing the patient, in addition to the modalities of pain and urinary disorders, were certain facts of his life, namely that, despite his age and higher education (printing), the patient did not have a permanent job or occupation. He also never had a family, but in general a permanent partner and a regular sex life. Serious urogenital infections are denied, which is confirmed by ART. Attention was drawn to the patient's frequent conflicts with the parents and the strongest resentment towards them with obvious anger and constant failures on the personal front.

Against the background of the treatment described above, the results were much better than from the allopathic one. Pains, both radiculitis and prostatic pains, were quickly stopped, urination was normalized. However, against the background of remissions, there were regular exacerbations associated either with irregular sexual activity, or with parting with a partner, or with conflict situations in the house. Thus, it became clear that the disease is clearly biosocial in nature, and it must be treated at the level of FS FM. By that time, the Szondi test appeared, and work was carried out to correlate it with the World Cup system. The patient was tested according to the Szondi test, Much to the author's surprise, as a result, a significant dominance of the hy - factor (4+) was revealed, correlated with the FM Chun Mai (dot is the RP4 key), which, in turn, corresponds to the Tsan trigram. Correlate with it, in particular, concepts such as a father (the patient has frequent conflicts with his father, and a strong resentment towards him); travel (the patient, not having a permanent job, travels a lot - "rolling stone"); strength, tension, strength (despite the sores, the patient is clearly "pumped", massive, and this muscle mass is in constant tension - cannot relax). In pathology - weakness of the tendons and ligaments - the patient has a weakness of the connective tissue. During a targeted in-depth psychological conversation, it was possible to find out that the patient is very ambitious, but cannot achieve recognition, since there is no worthy occupation, he does not know what he wants to do. He tries to compensate for his requests by organizing trips to which he goes.

Based on the analysis of the above, acupuncture according to the Chun Mai FM was started through the point - key RP4, with the addition of the point - gap R9 connecting the points MC6 and adding points of this FM: E30, R11, 12, 13. Sedation method (se), normalization.

There were only two sessions, after which the patient disappeared for almost a year. Appeared in connection with a slight relapse of pain in the lumbosacral

area and prostate after hypothermia on a hike. It turned out that during this time he got a permanent job, albeit as a courier, but with the prospect of seniority in the group, leads a group of exercise therapy with disabled people (he used to go in for sports, woo shu), resumed woo shu classes, is going to lead a group of beginners in within the school. Until the moment of treatment, the pain was not disturbed. One session was carried out according to the above method, after which there were no complaints for six months.

Clinical example 2

Patient O., 47 years old. Complaints of recurrent pain in the lumbar region, periodic attacks of a suffocating cough. According to the results of the Szondi test, the predominance of the m-factor (3+), corresponding to the FM Du-mai, was revealed, which unites the posterior median meridian and the meridian of the bladder, which corresponds to the Dui trigram with such qualities as joy, fun (the patient is really optimistic, cheerful), which is responsible for the assimilation of Qi by the lungs, "which becomes wet and clean", and in pathology manifests itself as coughing and suffocation.

Acupuncture was carried out according to the FM Du-May using the point - key IG3, Point - slit V59, connecting point V62 and additional points of the urinary and posterior median meridians. The method of inhibition (se) and normalization (neither boo nor se). After four sessions, back pain does not bother, coughing and choking too. Follow-up for one year.

In total, there were 11 clinical cases of effective use of the Szondi test for the selection of FM, as a result of which it was decided to create an ART version of the Szondi test. To do this, create electronic copies of the portraits of the Szondi test and enter them into the IMEDIS selector.

The question arose about the adequate recording of portraits as images for the preparation of information preparations suitable for entering into the selector. The recording must transfer to the medium all the properties of the portrait, like images with all the features of the signs of a genetically determined biosocial FS FM - attraction factor. At the same time, one must be sure that the recording reflects precisely the features of the image, and not the features of the quality of cardboard, printing ink, etc. Direct electromagnetic recording, according to the authors, does not fully satisfy this requirement. Therefore, one of the authors (Bizyaev P.D.) developed a method for direct recording of an image on a carrier. He created a stand on which an image from a card is projected through a pinhole lens onto a carrier in the form of an aqueous-alcoholic solution of lactose at the moment of its drying - crystallization. Thus, a "body of the image" is created, which is potentiated like an ordinary homeopathic remedy by hand. The method is described in more detail in a separate article in this collection. To create the test, preparations were made in the minimum potency C1,

Testing within the framework of ART is carried out in a standard way by direct testing of the drug included in the selector. This is how the degree of preference of the drive factors (Miraculous meridians) is determined. The conclusion is made on the basis of the number of tested drugs (portraits) related to this or that attraction. Then the same drugs are tested, but in inversion, on the basis of which it is possible to make an assumption about the drives (Miraculous meridians), the decrease (leveling) of the activity of which is relevant for the tested organism. This can probably be seen as a portrait "denial" effect in native testing.

According to the authors, the Szondi test should facilitate the choice of FM for treatment. In addition, the test preparations can be used as test pointers, and, probably, the drugs can be used as therapeutic ones (both directly and in inversion). The authors admit their use both as monopreparations and as part of complexes, including for BRT. Moreover, the APK "IMEDIS-EXPERT" already has the ability to conduct the BRT FM with note modulation, as well as recording the frequencies of musical notes corresponding to the FM, and the frequency for the EPT of the elements and the FM [7, 8, 9, 10]. But this question has not been worked out and requires its own study.
